## A BILL

To adjust the boundaries of Santa Monica Mountains National Recreation Area, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Santa Monica Moun-  
5 tains National Recreation Area Boundary Adjustment  
6 Act”.

7 **SEC. 2. BOUNDARY ADJUSTMENT.**

8 Section 507(c) of the National Parks and Recreation  
9 Act of 1978 (92 Stat. 3501; 16 U.S.C. 460kk) estab-

1 lishing Santa Monica Mountains National Recreation Area  
2 is amended—

3           (1) in paragraph (1), by striking “‘Boundary  
4           Map, Santa Monica Mountains National Recreation  
5           Area, California, and Santa Monica Mountains  
6           Zone’, numbered SMM–NRA 80,000, and dated  
7           May 1978” and inserting “‘Santa Monica Moun-  
8           tains National Recreation Area and Santa Monica  
9           Mountains Zone, California, Boundary Map’, num-  
10          bered \_\_\_\_\_ and dated February, 2001”;  
11          and

12           (2) by adding the following sentence after the  
13          third sentence of paragraph (2)(A): “Lands within  
14          the ‘Wildlife Corridor Expansion Zone’ identified on  
15          the boundary map referred to in paragraph (1) may  
16          be acquired only by donation or with donated  
17          funds”.

18 **SEC. 3. TECHNICAL CORRECTIONS.**

19          Section 507 of the National Parks and Recreation  
20          Act of 1978 (92 Stat. 3501; 16 U.S.C. 460kk) estab-  
21          lishing Santa Monica Mountains National Recreation Area  
22          is amended—

23           (1) in subsection (c)(1) by striking “Committee  
24           on Natural Resources” and inserting “Committee on  
25           Resources”;

1           “(2) in subsection (c)(2)(B) by striking “of cer-  
2           tain” in the first sentence and inserting “certain”;  
3           and

4           “(3) in subsection (n)(5) by striking “laws” in  
5           the second sentence and inserting “laws,”.
