A BILL

To adjust the boundaries of Santa Monica Mountains
National Recreation Area, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 *This Act may be cited as the “Santa Monica Moun-*
3 *tains National Recreation Area Boundary Adjustment*
4 *Act”.*

5 **SEC. 2. BOUNDARY ADJUSTMENT.**

6 *Section 507(c) of the National Parks and Recreation*
7 *Act of 1978 (92 Stat. 3501; 16 U.S.C. 460kk) establishing*
8 *Santa Monica Mountains National Recreation Area is*
9 *amended—*

10 (1) *in paragraph (1), by striking “Boundary*
11 *Map, Santa Monica Mountains National Recreation*
12 *Area, California, and Santa Monica Mountains*
13 *Zone’, numbered SMM–NRA 80,000, and dated May*
14 *1978” and inserting “‘Santa Monica Mountains Na-*
15 *tional Recreation Area and Santa Monica Mountains*
16 *Zone, California, Boundary Map’, numbered 80,047,*
17 *and dated February 2001”;* and

18 (2) *by adding the following sentence after the*
19 *third sentence of paragraph (2)(A): “Lands within*
20 *the ‘Wildlife Corridor Expansion Zone’ identified on*
21 *the boundary map referred to in paragraph (1) may*
22 *be acquired only by donation or with donated funds.”.*

23 **SEC. 3. TECHNICAL CORRECTIONS.**

24 *Section 507 of the National Parks and Recreation Act*
25 *of 1978 (92 Stat. 3501; 16 U.S.C. 460kk) establishing Santa*
26 *Monica Mountains National Recreation Area is amended—*

1 (1) *in subsection (c)(1), by striking “Committee*
2 *on Natural Resources” and inserting “Committee on*
3 *Resources”;*

4 (2) *in subsection (c)(2)(B), by striking “of cer-*
5 *tain” in the first sentence and inserting “certain”;*
6 *and*

7 (3) *in subsection (n)(5), by striking “laws” in*
8 *the second sentence and inserting “laws,”.*
