## RESOLUTION

Providing for consideration of the bill (H.R. 4735) to reauthorize and improve the program of block grants to States for temporary assistance for needy families, improve access to quality child care, and for other purposes.

1       *Resolved*, That upon the adoption of this resolution  
2 it shall be in order without intervention of any point of  
3 order to consider in the House the bill (H.R. 4735) to  
4 reauthorize and improve the program of block grants to  
5 States for temporary assistance for needy families, im-

1 prove access to quality child care, and for other purposes.  
2 The bill shall be considered as read for amendment. The  
3 previous question shall be considered as ordered on the  
4 bill and on any amendment thereto to final passage with-  
5 out intervening motion except: (1) two hours of debate on  
6 the bill, with 50 minutes equally divided and controlled  
7 by the chairman and ranking minority member of the  
8 Committee on Ways and Means, 40 minutes equally di-  
9 vided and controlled by the chairman and ranking minor-  
10 ity member of the Committee on Education and the Work-  
11 force, and 30 minutes equally divided and controlled by  
12 the chairman and ranking minority member of the Com-  
13 mittee on Energy and Commerce; (2) an amendment in  
14 the nature of a substitute printed in the report of the  
15 Committee on Rules accompanying this resolution, if of-  
16 fered by Representative Cardin of Maryland or his des-  
17 ignee, which shall be in order without intervention of any  
18 point of order, shall be considered as read, and shall be  
19 separately debatable for one hour equally divided and con-  
20 trolled by the proponent and an opponent; and (3) one  
21 motion to recommit with or without instructions.
