## RESOLUTION

Providing for consideration of the bill (H.R. 3129) to authorize appropriations for fiscal years 2002 and 2003 for the United States Customs Service for antiterrorism, drug interdiction, and other operations, for the Office of the United States Trade Representative, for the United States International Trade Commission, and for other purposes.

- 1 Resolved, That at any time after the adoption of this
- 2 resolution the Speaker may, pursuant to clause 2(b) of
- 3 rule XVIII, declare the House resolved into the Committee

- 1 of the Whole House on the state of the Union for consider-
- 2 ation of the bill (H.R. 3129) to authorize appropriations
- 3 for fiscal years 2002 and 2003 for the United States Cus-
- 4 toms Service for antiterrorism, drug interdiction, and
- 5 other operations, for the Office of the United States Trade
- 6 Representative, for the United States International Trade
- 7 Commission, and for other purposes. The first reading of
- 8 the bill shall be dispensed with. All points of order against
- 9 consideration of the bill are waived. General debate shall
- 10 be confined to the bill and shall not exceed one hour equal-
- 11 ly divided and controlled by the chairman and ranking mi-
- 12 nority member of the Committee on Ways and Means.
- 13 After general debate the bill shall be considered for
- 14 amendment under the five-minute rule. It shall be in order
- 15 to consider as an original bill for the purpose of amend-
- 16 ment under the five-minute rule the amendment in the na-
- 17 ture of a substitute recommended by the Committee on
- 18 Ways and Means now printed in the bill. The committee
- 19 amendment in the nature of a substitute shall be consid-
- 20 ered as read. All points of order against the committee
- 21 amendment in the nature of a substitute are waived. No
- 22 amendment to the committee amendment in the nature
- 23 of a substitute shall be in order except those printed in
- 24 the report of the Committee on Rules accompanying this
- 25 resolution. Each such amendment may be offered only in

- 1 the order printed in the report, may be offered only by
- 2 a Member designated in the report, shall be considered
- 3 as read, shall be debatable for the time specified in the
- 4 report equally divided and controlled by the proponent and
- 5 an opponent, shall not be subject to amendment, and shall
- 6 not be subject to a demand for division of the question
- 7 in the House or in the Committee of the Whole. All points
- 8 of order against such amendments are waived. At the con-
- 9 clusion of consideration of the bill for amendment the
- 10 Committee shall rise and report the bill to the House with
- 11 such amendments as may have been adopted. Any Member
- 12 may demand a separate vote in the House on any amend-
- 13 ment adopted in the Committee of the Whole to the bill
- 14 or to the committee amendment in the nature of a sub-
- 15 stitute. The previous question shall be considered as or-
- 16 dered on the bill and amendments thereto to final passage
- 17 without intervening motion except one motion to recommit
- 18 with or without instructions.
