Mr. SESSIONS, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 4775) making supplemental appropriations for further recovery from and response to terrorist attacks on the United States for the fiscal year ending September 30, 2002, and for other purposes.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 2(b) of
3 rule XVIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 4775) making supplemental appro-

1 priations for further recovery from and response to ter-
2 rorist attacks on the United States for the fiscal year end-
3 ing September 30, 2002, and for other purposes. The first
4 reading of the bill shall be dispensed with. All points of
5 order against consideration of the bill are waived. General
6 debate shall be confined to the bill and shall not exceed
7 one hour equally divided and controlled by the chairman
8 and ranking minority member of the Committee on Appro-
9 priations. After general debate the bill shall be considered
10 for amendment under the five-minute rule. The amend-
11 ments printed in the report of the Committee on Rules
12 accompanying this resolution shall be considered as adopt-
13 ed in the House and in the Committee of the Whole. All
14 points of order against provisions in the bill, as amended,
15 are waived except as follows: page 4, lines 18 through 23;
16 page 57, line 6, through page 58, line 22; page 92, lines
17 3 through 5. During consideration of the bill for further
18 amendment, the Chairman of the Committee of the Whole
19 may accord priority in recognition on the basis of whether
20 the Member offering an amendment has caused it to be
21 printed in the portion of the Congressional Record des-
22 ignated for that purpose in clause 8 of rule XVIII. Amend-
23 ments so printed shall be considered as read. During con-
24 sideration of the bill, points of order against amendments
25 for failure to comply with clause 2(e) of rule XXI are

1 waived. At the conclusion of consideration of the bill for
2 amendment the Committee shall rise and report the bill,
3 as amended, to the House with such further amendments
4 as may have been adopted. The previous question shall
5 be considered as ordered on the bill and amendments
6 thereto to final passage without intervening motion except
7 one motion to recommit with or without instructions.

8 SEC. 2. (a) Pending the adoption of a concurrent res-
9 olution on the budget for fiscal year 2003, the provisions
10 of House Concurrent Resolution 353, as adopted by the
11 House, shall have force and effect in the House as though
12 Congress has adopted such concurrent resolution.

13 (b) The chairman of the Committee on the Budget
14 shall submit for printing in the Congressional Record—

15 (1) the allocations contemplated by section
16 302(a) of the Congressional Budget Act of 1974,
17 which shall be considered to be such allocations
18 under a concurrent resolution on the budget;

19 (2) “Accounts Identified for Advance Appro-
20 priations,” which shall be considered to be the pro-
21 grams, projects, activities, or accounts referred to
22 section 301(b) of House Concurrent Resolution 353;
23 and

24 (3) an estimated unified surplus, which shall be
25 considered to be the estimated unified surplus set

1 forth in the report of the Committee on the Budget
2 accompanying House Concurrent Resolution 353 re-
3 ferred to in section 211 of such concurrent resolu-
4 tion.

5 (c) The allocation referred to in section 231(d) of
6 House Concurrent Resolution 353 shall be considered to
7 be the corresponding allocation among those submitted by
8 the chairman of the Committee on the Budget under sub-
9 section (b)(1).
