Mrs. MYRICK, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

## RESOLUTION

Providing for consideration of the bill (H.R. 5010) making appropriations for the Department of Defense for the fiscal year ending September 30, 2003, and for other purposes.

1       *Resolved*, That at any time after the adoption of this  
2 resolution the Speaker may, pursuant to clause 2(b) of  
3 rule XVIII, declare the House resolved into the Committee  
4 of the Whole House on the state of the Union for consider-  
5 ation of the bill (H.R. 5010) making appropriations for  
6 the Department of Defense for the fiscal year ending Sep-

1 tember 30, 2003, and for other purposes. The first reading  
2 of the bill shall be dispensed with. All points of order  
3 against consideration of the bill are waived. General de-  
4 bate shall be confined to the bill and shall not exceed one  
5 hour equally divided and controlled by the chairman and  
6 ranking minority member of the Committee on Appropria-  
7 tions. After general debate the bill shall be considered for  
8 amendment under the five-minute rule. Points of order  
9 against provisions in the bill for failure to comply with  
10 clause 2 of rule XXI are waived. During consideration of  
11 the bill for amendment, the Chairman of the Committee  
12 of the Whole may accord priority in recognition on the  
13 basis of whether the Member offering an amendment has  
14 caused it to be printed in the portion of the Congressional  
15 Record designated for that purpose in clause 8 of rule  
16 XVIII. Amendments so printed shall be considered as  
17 read. At the conclusion of consideration of the bill for  
18 amendment the Committee shall rise and report the bill  
19 to the House with such amendments as may have been  
20 adopted. The previous question shall be considered as or-  
21 dered on the bill and amendments thereto to final passage  
22 without intervening motion except one motion to recommit  
23 with or without instructions.

24 SEC. 2. That upon the adoption of this resolution it  
25 shall be in order, any rule of the House to the contrary

1 notwithstanding, to consider concurrent resolutions pro-  
2 viding for adjournment of the House and Senate during  
3 the month of July.
