Providing for consideration of the bill (H.R. 5011) making appropriations for military construction, family housing, and base realignment and closure for the Department of Defense for the fiscal year ending September 30, 2003, and for other purposes.

- 1 Resolved, That at any time after the adoption of this
- 2 resolution the Speaker may, pursuant to clause 2(b) of
- 3 rule XVIII, declare the House resolved into the Committee
- 4 of the Whole House on the state of the Union for consider-
- 5 ation of the bill (H.R. 5011) making appropriations for

- 1 military construction, family housing, and base realign-
- 2 ment and closure for the Department of Defense for the
- 3 fiscal year ending September 30, 2003, and for other pur-
- 4 poses. The first reading of the bill shall be dispensed with.
- 5 All points of order against consideration of the bill are
- 6 waived. General debate shall be confined to the bill and
- 7 shall not exceed one hour equally divided and controlled
- 8 by the chairman and ranking minority member of the
- 9 Committee on Appropriations. After general debate the
- 10 bill shall be considered for amendment under the five-
- 11 minute rule. Points of order against provisions of the bill
- 12 for failure to comply with clause 2 of rule XXI are waived.
- 13 During consideration of the bill for amendment, the Chair-
- 14 man of the Committee of the Whole may accord priority
- 15 in recognition on the basis of whether the Member offering
- 16 an amendment has caused it to be printed in the portion
- 17 of the Congressional Record designated for that purpose
- 18 in clause 8 of rule XVIII. Amendments so printed shall
- 19 be considered as read. At the conclusion of consideration
- 20 of the bill for amendment the Committee shall rise and
- 21 report the bill to the House with such amendments as may
- 22 have been adopted. The previous question shall be consid-
- 23 ered as ordered on the bill and amendments thereto to

- 1 final passage without intervening motion except one mo-
- 2 tion to recommit with or without instructions.
