Mr. REYNOLDS, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 4635) to amend title 49, United States Code, to establish a program for Federal flight deck officers, and for other purposes.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 2(b) of
3 rule XVIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 4635) to amend title 49, United
6 States Code, to establish a program for Federal flight deck
7 officers, and for other purposes. The first reading of the

1 bill shall be dispensed with. All points of order against
2 consideration of the bill are waived. General debate shall
3 be confined to the bill and shall not exceed one hour equal-
4 ly divided and controlled by the chairman and ranking mi-
5 nority member of the Committee on Transportation and
6 Infrastructure. After general debate the bill shall be con-
7 sidered for amendment under the five-minute rule. It shall
8 be in order to consider as an original bill for the purpose
9 of amendment under the five-minute rule the amendment
10 in the nature of a substitute recommended by the Com-
11 mittee on Transportation and Infrastructure now printed
12 in the bill. The committee amendment in the nature of
13 a substitute shall be considered as read. All points of order
14 against the committee amendment in the nature of a sub-
15 stitute are waived. No amendment to the committee
16 amendment in the nature of a substitute shall be in order
17 except those printed in the portion of the Congressional
18 Record designated for that purpose in clause 8 of rule
19 XVIII and except pro forma amendments for the purpose
20 of debate. Each amendment so printed may be offered only
21 by the Member who caused it to be printed or his designee
22 and shall be considered as read. At the conclusion of con-
23 sideration of the bill for amendment the Committee shall
24 rise and report the bill to the House with such amend-
25 ments as may have been adopted. Any Member may de-

1 mand a separate vote in the House on any amendment
2 adopted in the Committee of the Whole to the bill or to
3 the committee amendment in the nature of a substitute.
4 The previous question shall be considered as ordered on
5 the bill and amendments thereto to final passage without
6 intervening motion except one motion to recommit with
7 or without instructions.
