RESOLUTION

Providing for consideration of the bill (H.R. 4628) to authorize appropriations for fiscal year 2003 for intelligence and intelligence-related activities of the United States Government, the Community Management Account, and the Central Intelligence Agency Retirement and Disability System, and for other purposes.

- 1 Resolved, That at any time after the adoption of this
- 2 resolution the Speaker may, pursuant to clause 2(b) of
- 3 rule XVIII, declare the House resolved into the Committee

of the Whole House on the state of the Union for consideration of the bill (H.R. 4628) to authorize appropriations 3 for fiscal year 2003 for intelligence and intelligence-related activities of the United States Government, the Community Management Account, and the Central Intelligence Agency Retirement and Disability System, and for other purposes. The first reading of the bill shall be dispensed 8 with. All points of order against consideration of the bill are waived. General debate shall be confined to the bill 10 and shall not exceed one hour equally divided and controlled by the chairman and ranking minority member of 11 12 the Permanent Select Committee on Intelligence. After general debate the bill shall be considered for amendment under the five-minute rule. It shall be in order to consider 14 15 as an original bill for the purpose of amendment under the five-minute rule the amendment in the nature of a sub-16 stitute recommended by the Permanent Select Committee 17 18 on Intelligence now printed in the bill. The committee 19 amendment in the nature of a substitute shall be consid-20 ered as read. All points of order against the committee 21 amendment in the nature of a substitute are waived. No 22 amendment to the committee amendment in the nature 23 of a substitute shall be in order except those printed in the portion of the Congressional Record designated for that purpose in clause 8 of rule XVIII and except pro

- 1 forma amendments for the purpose of debate. Each
- 2 amendment so printed may be offered only by the Member
- 3 who caused it to be printed or his designee and shall be
- 4 considered as read. At the conclusion of consideration of
- 5 the bill for amendment the Committee shall rise and re-
- 6 port the bill to the House with such amendments as may
- 7 have been adopted. Any Member may demand a separate
- 8 vote in the House on any amendment adopted in the Com-
- 9 mittee of the Whole to the bill or to the committee amend-
- 10 ment in the nature of a substitute. The previous question
- 11 shall be considered as ordered on the bill and amendments
- 12 thereto to final passage without intervening motion except
- 13 one motion to recommit with or without instructions.
