## A BILL

- To increase, effective as of December 1, 2001, the rates of compensation for veterans with service-connected disabilities and the rates of dependency and indemnity compensation for the survivors of certain disabled veterans.
  - 1 Be it enacted by the Senate and House of Representa-
  - 2 tives of the United States of America in Congress assembled,

#### 1 SECTION 1. SHORT TITLE.

2 This Act may be cited as the "Veterans' Compensa-3 tion Cost-of-Living Adjustment Act of 2001".

4 SEC. 2. INCREASE IN RATES OF DISABILITY COMPENSA5 TION AND DEPENDENCY AND INDEMNITY
6 COMPENSATION.

7 (a) RATE ADJUSTMENT.—The Secretary of Veterans
8 Affairs shall, effective on December 1, 2001, increase the
9 dollar amounts in effect for the payment of disability com10 pensation and dependency and indemnity compensation by
11 the Secretary, as specified in subsection (b).

12 (b) AMOUNTS TO BE INCREASED.—The dollar13 amounts to be increased pursuant to subsection (a) are14 the following:

15 (1) COMPENSATION.—Each of the dollar
16 amounts in effect under section 1114 of title 38,
17 United States Code.

18 (2) ADDITIONAL COMPENSATION FOR DEPEND19 ENTS.—Each of the dollar amounts in effect under
20 sections 1115(1) of such title.

21 (3) CLOTHING ALLOWANCE.—The dollar
22 amount in effect under section 1162 of such title.

(4) NEW DIC RATES.—The dollar amounts in
effect under paragraphs (1) and (2) of section
1311(a) of such title.

1	(5) OLD DIC RATES.—Each of the dollar
2	amounts in effect under section $1311(a)(3)$ of such
3	title.
4	(6) Additional dic for surviving spouses
5	WITH MINOR CHILDREN.—The dollar amount in ef-
6	fect under section 1311(b) of such title.
7	(7) Additional dic for disability.—The
8	dollar amounts in effect under sections 1311(c) and
9	1311(d) of such title.
10	(8) DIC FOR DEPENDENT CHILDREN.—The
11	dollar amounts in effect under sections 1313(a) and
12	1314 of such title.
13	(c) Determination of Increase.—(1) The in-
14	crease under subsection (a) shall be made in the dollar
15	amounts specified in subsection (b) as in effect on Novem-
16	ber 30, 2001.

17 (2) Except as provided in paragraph (3), each such
18 amount shall be increased by the same percentage as the
19 percentage by which benefit amounts payable under title
20 II of the Social Security Act (42 U.S.C. 401 et seq.) are
21 increased effective December 1, 2001, as a result of a de22 termination under section 215(i) of such Act (42 U.S.C.
23 415(i)).

(3) Each dollar amount increased pursuant to para graph (2) shall, if not a whole dollar amount, be rounded
 down to the next lower whole dollar amount.

4 (d) SPECIAL RULE.—The Secretary may adjust ad5 ministratively, consistent with the increases made under
6 subsection (a), the rates of disability compensation pay7 able to persons within the purview of section 10 of Public
8 Law 85–857 (72 Stat. 1263) who are not in receipt of
9 compensation payable pursuant to chapter 11 of title 38,
10 United States Code.

#### 11 SEC. 3. PUBLICATION OF ADJUSTED RATES.

12 At the same time as the matters specified in section 13 215(i)(2)(D) of the Social Security Act (42 U.S.C. 14 415(i)(2)(D)) are required to be published by reason of 15 a determination made under section 215(i) of such Act during fiscal year 2002, the Secretary of Veterans Affairs 16 17 shall publish in the Federal Register the amounts specified in subsection (b) of section 2, as increased pursuant to 18 19 that section.
