#### 11 SEC. 3. REGULATIONS.

- 12 The Secretary of Housing and Urban Development
- 13 shall issue regulations necessary to carry out the amend-
- 14 ments made by this Act, which regulations shall take ef-
- 15 fect not later than the expiration of the 1-year period be-
- 16 ginning on the date of enactment of this Act.

### 17 SEC. 4. COST ADJUSTMENTS.

- 18 The dollar amounts established by the amendments
- 19 made by this Act shall be increased annually by the Sec-
- 20 retary by the amount of increase, if any, in the Annual
- 21 Construction Cost Index prepared by the Bureau of the
- 22 Census within the Department of Commerce, in accord-
- 23 ance with regulations prescribed by the Secretary.
