AN ACT

To amend title XIX of the Social Security Act to clarify that Indian women with breast or cervical cancer who are eligible for health services provided under a medical care program of the Indian Health Service or of a tribal organization are included in the optional medicaid eligibility category of breast or cervical cancer patients added by the Breast and Cervical Cancer Prevention and Treatment Act of 2000.

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Native American
5 Breast and Cervical Cancer Treatment Technical Amend-
6 ment Act of 2001”.

1 **SEC. 2. CLARIFICATION OF INCLUSION OF INDIAN WOMEN**
2 **WITH BREAST OR CERVICAL CANCER IN OP-**
3 **TIONAL MEDICAID ELIGIBILITY CATEGORY.**

4 (a) TECHNICAL AMENDMENT.—The subsection (aa)
5 of section 1902 of the Social Security Act (42 U.S.C.
6 1396a) added by section 2(a)(2) of the Breast and Cer-
7 vical Cancer Prevention and Treatment Act of 2000 (Pub-
8 lic Law 106–354; 114 Stat. 1381) is amended in para-
9 graph (4) by inserting “, but applied without regard to
10 paragraph (1)(F) of such section” before the period at the
11 end.

12 (b) BIPA TECHNICAL AMENDMENTS.—

13 (1) Section 1902 of the Social Security Act (42
14 U.S.C. 1396a), as amended by section 702(b) of the
15 Medicare, Medicaid, and SCHIP Benefits Improve-
16 ment and Protection Act of 2000 (114 Stat. 2763A–
17 572) (as enacted into law by section 1(a)(6) of Pub-
18 lic Law 106–554), is amended by redesignating the
19 subsection (aa) added by such section as subsection
20 (bb).

21 (2) Section 1902(a)(15) of the Social Security
22 Act (42 U.S.C. 1396a(a)(15)), as added by section
23 702(a)(2) of the Medicare, Medicaid, and SCHIP
24 Benefits Improvement and Protection Act of 2000
25 (114 Stat. 2763A–572) (as so enacted into law), is

1 amended by striking “subsection (aa)” and inserting
 2 “subsection (bb)”.

3 (3) Section 1915(b) of the Social Security Act
 4 (42 U.S.C. 1396n(b)), as amended by section
 5 702(c)(2) of the Medicare, Medicaid, and SCHIP
 6 Benefits Improvement and Protection Act of 2000
 7 (114 Stat. 2763A–574) (as so enacted into law), is
 8 amended by striking “1902(aa)” and inserting
 9 “1902(bb)”.

10 (c) EFFECTIVE DATES.—

11 (1) BCCPTA TECHNICAL AMENDMENT.—The
 12 amendment made by subsection (a) shall take effect
 13 as if included in the enactment of the Breast and
 14 Cervical Cancer Prevention and Treatment Act of
 15 2000 (Public Law 106–354; 114 Stat. 1381).

16 (2) BIPA TECHNICAL AMENDMENTS.—The
 17 amendments made by subsection (b) shall take effect
 18 as if included in the enactment of section 702 of the
 19 Medicare, Medicaid, and SCHIP Benefits Improve-
 20 ment and Protection Act of 2000 (114 Stat. 2763A–

1 572) (as enacted into law by section 1(a)(6) of Pub-
2 lic Law 106–554).
