A BILL

To amend title 38, United States Code, to clarify the applicability of the prohibition on assignment of veterans benefits to agreements regarding future receipt of compensation, pension, or dependency and indemnity compensation, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Veterans Benefits and
- 5 Pensions Protection Act of 2002".

1	SEC. 2. APPLICABILITY OF PROHIBITION ON ASSIGNMENT
2	OF VETERANS BENEFITS TO AGREEMENTS
3	ON FUTURE RECEIPT OF CERTAIN BENEFITS.
4	(a) In General.—Section 5301(a) of title 38,
5	United States Code, is amended—
6	(1) by inserting "(1)" after "(a)";
7	(2) by designating the last sentence as para-
8	graph (2) and indenting such paragraph, as so des-
9	ignated, two ems from the left margin; and
10	(3) by adding at the end the following new
11	paragraph:
12	"(3)(A) For purposes of this subsection, in any case
13	where a beneficiary entitled to compensation, pension, or
14	dependency and indemnity compensation enters into an
15	agreement with another person under which agreement
16	such other person acquires for consideration the right to
17	receive payment of such compensation, pension, or de-
18	pendency and indemnity compensation, as the case may
19	be, whether by payment from the beneficiary to such other
20	person, deposit into an account from which such other per-
21	son may make withdrawals, or otherwise, such agreement
22	shall be deemed to be an assignment and is prohibited.
23	"(B) Any agreement or arrangement for collateral for
24	security for an agreement that is prohibited under sub-
25	paragraph (A) is also prohibited.

- 1 "(C)(i) Any person who enters into an agreement
- 2 that is prohibited under subparagraph (A), or an agree-
- 3 ment or arrangement that is prohibited under subpara-
- 4 graph (B), shall be fined under title 18, imprisoned for
- 5 not more than one year, or both.
- 6 "(ii) This subparagraph does not apply to a bene-
- 7 ficiary with respect to compensation, pension, or disability
- 8 and indemnity compensation to which the beneficiary is
- 9 entitled under a law administered by the Secretary.".
- 10 (b) Effective Dates.—(1) Subparagraphs (A) and
- 11 (B) of paragraph (3) of section 5301(a) of title 38, United
- 12 States Code (as added by subsection (a) of this section),
- 13 shall apply with respect to any agreement or arrangement
- 14 described in such subparagraphs, whether entered into be-
- 15 fore, on, or after the date of the enactment of this Act,
- 16 and any such agreement or arrangement entered into be-
- 17 fore the date of the enactment of this Act is void and un-
- 18 enforceable as of such date.
- 19 (2) Subparagraph (C) of such paragraph shall apply
- 20 with respect to any agreement or arrangement covered by
- 21 such subparagraph that is entered into on or after the
- 22 date of the enactment of this Act.
- 23 (c) Outreach.—The Secretary of Veterans Affairs
- 24 shall, during the five-year period beginning on the date
- 25 of the enactment of this Act, carry out a program of out-

- 1 reach to inform veterans and other recipients or potential
- 2 recipients of compensation, pension, or disability and in-
- 3 demnity compensation benefits under the laws adminis-
- 4 tered by the Secretary of the prohibition on the assign-
- 5 ability of such benefits under law. The program shall in-
- 6 clude information on various schemes to evade the prohibi-
- 7 tion, and means of avoiding such schemes.
- 8 (d) AUTHORIZATION OF APPROPRIATIONS.—There is
- 9 hereby authorized to be appropriated for the Department
- 10 of Veterans Affairs for each of fiscal years 2003 through
- 11 2007, \$3,000,000 for purposes of carrying out the pro-
- 12 gram of outreach required by subsection (c).
