A BILL

To make grants to States to improve public safety in order to prepare for and respond to terrorist threats.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Securing Our States
- 5 Act of 2002" or the "SOS Act".
- 6 SEC. 2. GRANTS AUTHORIZED.
- 7 (a) In General.—The Director of the Federal
- 8 Emergency Management Agency (referred to in this Act
- 9 as the "Director") shall make grants to States to improve

- 1 public safety in order to prepare for and respond to ter-
- 2 rorist threats.
- 3 (b) Consultation.—The Director shall consult with
- 4 the Office of Homeland Security and any other Federal
- 5 agency, as appropriate, when making a grant under this
- 6 Act.

7 SEC. 3. AMOUNT OF GRANT.

- 8 (a) In General.—Each State shall receive a per-
- 9 centage of the total amount awarded under this Act equal
- 10 to the proportion of the population of that State to the
- 11 total population of the United States, as determined by
- 12 the most recent census.
- 13 (b) DISTRIBUTION.—Not less than 75 percent of the
- 14 funds distributed to each State under subsection (a)
- 15 shall—
- 16 (1) be distributed on a per capita basis to units
- of local government, or a combination of units of
- local government; and

- est need as determined by the Governor of each

- 22 SEC. 4. USE OF FUNDS.
- Grants made under this Act shall be used to—

3	ing supplies, equipment, and training;
4	(2) purchase and refurbish personal protective
5	equipment for fire, police, and emergency personnel,
6	and to acquire technology to improve communication
7	systems;
8	(3) improve protection of critical infrastructure,
9	including—
10	(A) water treatment plants, distribution
11	systems, and other water infrastructure;
12	(B) nuclear power plants and other power
13	infrastructure;
14	(C) tunnels and bridges;
15	(D) oil and gas pipelines and storage facili-
16	ties;
17	(E) sea and other waterway port security
18	(including fire and other preventive and re-
19	sponse resources); and
20	(F) transportation of hazardous sub-
21	stances;
22	(4) assist State and local emergency planning
23	organizations so that public agencies can design, re-
24	view, and improve disaster response systems;

1	(5) assist States and localities in coordinating
2	their efforts and sharing information with all rel-
3	evant agencies involved in preventing or responding
4	to terrorist attacks;
5	(6) establish timely notification systems that
6	enable States and localities to communicate with
7	each other and the Federal government in order to
8	prepare for and respond to a terrorist threat; and
9	(7) improve communication systems to provide
10	information to the public in a timely manner about
11	the facts of any threat and the precautions the pub-
12	lic should take.

14	tor regarding any improvements made in public security
15	as a result of the grants received under this Act.
