## A BILL

To prohibit the use of fiscal year 2003 Federal funds for support of the Palestinian Authority pending the cessation of terrorist activities by the Palestinian Authority.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. PROHIBITION ON USE OF FISCAL YEAR 2003**

4                       **FEDERAL FUNDS FOR SUPPORT OF PALES-**

5                       **TINIAN AUTHORITY PENDING CESSATION OF**

6                       **TERRORIST ACTIVITIES BY PALESTINIAN AU-**

7                       **THORITY.**

8               (a) CONTINGENT PROHIBITION ON AVAILABILITY OF

9 FISCAL YEAR 2003 FUNDS.—Notwithstanding any other

1 provision of law, no funds available to any department,  
2 agency, or other element of the Federal Government for  
3 fiscal year 2003 may be obligated or expended for the pur-  
4 pose, or in a manner which would have the effect, of  
5 supporting—

6 (1) the Palestinian Authority;

7 (2) any entity supported by the Palestinian Au-  
8 thority;

9 (3) any successor entity to the Palestinian Au-  
10 thority or an entity referred to in paragraph (2); or

11 (4) any private, voluntary organization for—

12 (A) projects related to the Palestinian Au-  
13 thority; or

14 (B) projects located in Palestine that  
15 would otherwise be undertaken by the Pales-  
16 tinian Authority or an entity referred to in  
17 paragraph (2) or (3).

18 (b) TERMINATION OF PROHIBITION.—The prohibi-  
19 tion in subsection (a) shall cease to be effective upon the  
20 submittal by the President to Congress of a certification  
21 that neither the Palestinian Authority, nor any entity sup-  
22 ported by the Palestinian Authority, has engaged in plan-  
23 ning or carrying out any terrorist act during the six-month  
24 period ending on the date of the certification.

1       (c) SUPPORT.—For purposes of this section, support  
2 shall include direct and indirect support, whether such  
3 support is financial or otherwise, including support for the  
4 Holst Fund of the World Bank and the United Nations  
5 Relief and Works Agency.
