## A BILL

To amend section 16131 of title 10, United States Code, to increase rates of educational assistance under the program of educational assistance for members of the Selected Reserve to make such rates commensurate with scheduled increases in rates for basic educational assistance under section 3015 of title 38, United States Code, the Montgomery GI Bill.

1	SECTION 1. INCREASE IN RATES OF EDUCATIONAL ASSIST-
2	ANCE UNDER PROGRAM OF EDUCATIONAL
3	ASSISTANCE FOR MEMBERS OF THE SE-
4	LECTED RESERVE.
5	(a) Increase in Rates.—Section 16131(b)(1) of
6	title 10, United States Code, is amended by striking sub-
7	paragraphs (A) through (C) and inserting the following
8	new subparagraphs (A) through (C):
9	"(A) For a program of education pursued on a
10	full-time basis, at the monthly rate of—
11	"(i) for months occurring during fiscal
12	year 2003, \$428;
13	"(ii) for months occurring during fiscal
14	year 2004, \$473; and
15	"(iii) for months occurring during a subse-
16	quent fiscal year, the amount for months occur-
17	ring during the previous fiscal year, increased
18	under paragraph (2).
19	"(B) For a program of education pursued on a
20	three-quarter-time basis, at the monthly rate of—
21	"(i) for months occurring during fiscal
22	year 2003, \$321;
23	"(ii) for months occurring during fiscal
24	year 2004, \$355; and
25	"(iii) for months occurring during a subse-
26	quent fiscal year, the amount for months occur-

1	ring during the previous fiscal year, increased
2	under paragraph (2).
3	"(C) For a program of education pursued on a
4	half-time basis, at the monthly rate of—
5	"(i) for months occurring during fiscal
6	year 2003, \$214;
7	"(ii) for months occurring during fiscal
8	year 2004, \$237; and
9	"(iii) for months occurring during a subse-
10	quent fiscal year, the amount for months occur-
11	ring during the previous fiscal year, increased
12	under paragraph (2).".
13	(b) Effective Date.—The amendment made by
14	subsection (a) shall take effect on October 1, 2002, and
15	shall apply with respect to months that begin on or after
16	the date.
17	(c) CPI Adjustment.—No adjustment shall be
18	made under paragraph (2) of section 16131(b) of title 10,
19	United States Code, for fiscal years 2003 and 2004.
