2 **ASSESSMENTS FOR UNITED NATIONS PEACE-**
3 **KEEPING OPERATIONS.**

4 (a) **IN GENERAL.**—Section 931(b)(2) of the Admiral
5 James W. Nance and Meg Donovan Foreign Relations Au-
6 thorization Act, Fiscal Years 2000 and 2001 (as enacted
7 by section 1000(a)(7) of Public Law 106–113 and con-
8 tained in appendix G of that Act; 113 Stat. 1501A–480)
9 is amended by striking “25 percent” and inserting “28.15
10 percent”.
