A BILL

To provide tax and regulatory relief for farmers and to improve the competitiveness of American agricultural commodities and products in global markets.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE; TABLE OF CONTENTS.**

4 (a) SHORT TITLE.—This Act may be cited as the
5 “Rural America Prosperity Act of 2001”.

1 **TITLE I—TAX RELIEF FOR**
2 **FARMERS**
3 **Subtitle A—General Tax Provisions**

4 **SEC. 101. DEDUCTION FOR 100 PERCENT OF HEALTH IN-**
5 **SURANCE COSTS OF SELF-EMPLOYED INDI-**
6 **VIDUALS.**

7 (a) IN GENERAL.—Paragraph (1) of section 162(l)
8 of the Internal Revenue Code of 1986 (relating to special
9 rules for health insurance costs of self-employed individ-
10 uals) is amended to read as follows:

11 “(1) ALLOWANCE OF DEDUCTION.—In the case
12 of an individual who is an employee within the
13 meaning of section 401(c)(1), there shall be allowed
14 as a deduction under this section an amount equal
15 to 100 percent of the amount paid during the tax-
16 able year for insurance which constitutes medical
17 care for the taxpayer, his spouse, and dependents.”.

18 (b) EFFECTIVE DATE.—The amendment made by
19 this section shall apply to taxable years beginning after
20 December 31, 2001.

21 **SEC. 102. EXCLUSION OF GAIN FROM SALE OF FARMLAND.**

22 (a) IN GENERAL.—Part III of subchapter B of chap-
23 ter 1 of the Internal Revenue Code of 1986 (relating to
24 items specifically excluded from gross income) is amended
25 by inserting after section 121 the following:

1 **“SEC. 121A. EXCLUSION OF GAIN FROM SALE OF QUALIFIED**
2 **FARM PROPERTY.**

3 “(a) EXCLUSION.—In the case of a natural person,
4 gross income shall not include gain from the sale or ex-
5 change of qualified farm property.

6 “(b) LIMITATION.—

7 “(1) IN GENERAL.—The amount of gain ex-
8 cluded from gross income under subsection (a) with
9 respect to any taxable year shall not exceed
10 \$500,000 (\$250,000 in the case of a married indi-
11 vidual filing a separate return), reduced by the ag-
12 gregate amount of gain excluded under subsection
13 (a) for all preceding taxable years.

14 “(2) SPECIAL RULE FOR JOINT RETURNS.—The
15 amount of the exclusion under subsection (a) on a
16 joint return for any taxable year shall be allocated
17 equally between the spouses for purposes of applying
18 the limitation under paragraph (1) for any suc-
19 ceeding taxable year.

20 “(c) QUALIFIED FARM PROPERTY.—For purposes of
21 this section—

22 “(1) IN GENERAL.—The term ‘qualified farm
23 property’ means real property located in the United
24 States if, during periods aggregating 3 years or
25 more of the 5-year period ending on the date of the
26 sale or exchange of such real property—

1 “(A) such real property was used by the
2 taxpayer or a member of the family of the tax-
3 payer as a farm for farming purposes, and

4 “(B) there was material participation by
5 the taxpayer (or such a member) in the oper-
6 ation of the farm.

7 “(2) OTHER DEFINITIONS.—The terms ‘mem-
8 ber of the family’, ‘farm’, and ‘farming purposes’
9 have the respective meanings given such terms by
10 paragraphs (2), (4), and (5) of section 2032A(e).

11 “(3) SPECIAL RULES.—Rules similar to the
12 rules of paragraphs (4) and (5) of section 2032A(b)
13 and paragraphs (3) and (6) of section 2032A(e)
14 shall apply.

15 “(d) OTHER RULES.—For purposes of this section,
16 rules similar to the rules of subsection (e) and subsection
17 (f) of section 121 shall apply.”.

18 (b) CONFORMING AMENDMENT.—The table of sec-
19 tions for part III of subchapter B of chapter 1 of the In-
20 ternal Revenue Code of 1986 is amended by inserting
21 after the item relating to section 121 the following:

“Sec. 121A. Exclusion of gain from sale of qualified farm prop-
erty.”.

22 (c) EFFECTIVE DATE.—The amendments made by
23 this section shall apply to any sale or exchange after the

1 date of enactment of this Act in taxable years ending after
2 such date.

3 **SEC. 103. INCOME AVERAGING FOR FARMERS NOT TO IN-**
4 **CREASE ALTERNATIVE MINIMUM TAX LIABIL-**
5 **ITY.**

6 (a) IN GENERAL.—Section 55(c) of the Internal Rev-
7 enue Code of 1986 (defining regular tax) is amended by
8 redesignating paragraph (2) as paragraph (3) and by in-
9 serting after paragraph (1) the following:

10 “(2) COORDINATION WITH INCOME AVERAGING
11 FOR FARMERS.—Solely for purposes of this section,
12 section 1301 (relating to averaging of farm income)
13 shall not apply in computing the regular tax.”.

14 (b) EFFECTIVE DATE.—The amendment made by
15 this section shall apply to taxable years beginning after
16 December 31, 1997.

17 **SEC. 104. FARM AND RANCH RISK MANAGEMENT AC-**
18 **COUNTS.**

19 (a) IN GENERAL.—Subpart C of part II of sub-
20 chapter E of chapter 1 of the Internal Revenue Code of
21 1986 (relating to taxable year for which deductions taken)
22 is amended by inserting after section 468B the following:

1 **“SEC. 468C. FARM AND RANCH RISK MANAGEMENT AC-**
2 **COUNTS.**

3 “(a) DEDUCTION ALLOWED.—In the case of an indi-
4 vidual engaged in an eligible farming business, there shall
5 be allowed as a deduction for any taxable year the amount
6 paid in cash by the taxpayer during the taxable year to
7 a Farm and Ranch Risk Management Account (herein-
8 after referred to as the ‘FARRM Account’).

9 “(b) LIMITATION.—The amount which a taxpayer
10 may pay into the FARRM Account for any taxable year
11 shall not exceed 20 percent of so much of the taxable in-
12 come of the taxpayer (determined without regard to this
13 section) which is attributable (determined in the manner
14 applicable under section 1301) to any eligible farming
15 business.

16 “(c) ELIGIBLE FARMING BUSINESS.—For purposes
17 of this section, the term ‘eligible farming business’ means
18 any farming business (as defined in section 263A(e)(4))
19 which is not a passive activity (within the meaning of sec-
20 tion 469(c)) of the taxpayer.

21 “(d) FARRM ACCOUNT.—For purposes of this
22 section—

23 “(1) IN GENERAL.—The term ‘FARRM Ac-
24 count’ means a trust created or organized in the
25 United States for the exclusive benefit of the tax-

1 payer, but only if the written governing instrument
2 creating the trust meets the following requirements:

3 “(A) No contribution will be accepted for
4 any taxable year in excess of the amount al-
5 lowed as a deduction under subsection (a) for
6 such year.

7 “(B) The trustee is a bank (as defined in
8 section 408(n)) or another person who dem-
9 onstrates to the satisfaction of the Secretary
10 that the manner in which such person will ad-
11 minister the trust will be consistent with the re-
12 quirements of this section.

13 “(C) The assets of the trust consist en-
14 tirely of cash or of obligations which have ade-
15 quate stated interest (as defined in section
16 1274(c)(2)) and which pay such interest not
17 less often than annually.

18 “(D) All income of the trust is distributed
19 currently to the grantor.

20 “(E) The assets of the trust will not be
21 commingled with other property except in a
22 common trust fund or common investment
23 fund.

24 “(2) ACCOUNT TAXED AS GRANTOR TRUST.—

25 The grantor of a FARRM Account shall be treated

1 for purposes of this title as the owner of such Ac-
 2 count and shall be subject to tax thereon in accord-
 3 ance with subpart E of part I of subchapter J of
 4 this chapter (relating to grantors and others treated
 5 as substantial owners).

6 “(e) INCLUSION OF AMOUNTS DISTRIBUTED.—

7 “(1) IN GENERAL.—Except as provided in para-
 8 graph (2), there shall be includible in the gross in-
 9 come of the taxpayer for any taxable year—

10 “(A) any amount distributed from a
 11 FARRM Account of the taxpayer during such
 12 taxable year, and

13 “(B) any deemed distribution under—

14 “(i) subsection (f)(1) (relating to de-
 15 posits not distributed within 5 years),

16 “(ii) subsection (f)(2) (relating to ces-
 17 sation in eligible farming business), and

18 “(iii) subparagraph (A) or (B) of sub-
 19 section (f)(3) (relating to prohibited trans-
 20 actions and pledging account as security).

21 “(2) EXCEPTIONS.—Paragraph (1)(A) shall not
 22 apply to—

23 “(A) any distribution to the extent attrib-
 24 utable to income of the Account, and

1 “(B) the distribution of any contribution
 2 paid during a taxable year to a FARRM Ac-
 3 count to the extent that such contribution ex-
 4 ceeds the limitation applicable under subsection
 5 (b) if requirements similar to the requirements
 6 of section 408(d)(4) are met.

7 For purposes of subparagraph (A), distributions
 8 shall be treated as first attributable to income and
 9 then to other amounts.

10 “(f) SPECIAL RULES.—

11 “(1) TAX ON DEPOSITS IN ACCOUNT WHICH
 12 ARE NOT DISTRIBUTED WITHIN 5 YEARS.—

13 “(A) IN GENERAL.—If, at the close of any
 14 taxable year, there is a nonqualified balance in
 15 any FARRM Account—

16 “(i) there shall be deemed distributed
 17 from such Account during such taxable
 18 year an amount equal to such balance, and

19 “(ii) the taxpayer’s tax imposed by
 20 this chapter for such taxable year shall be
 21 increased by 10 percent of such deemed
 22 distribution.

23 The preceding sentence shall not apply if an
 24 amount equal to such nonqualified balance is
 25 distributed from such Account to the taxpayer

1 before the due date (including extensions) for
2 filing the return of tax imposed by this chapter
3 for such year (or, if earlier, the date the tax-
4 payer files such return for such year).

5 “(B) NONQUALIFIED BALANCE.—For pur-
6 poses of subparagraph (A), the term ‘non-
7 qualified balance’ means any balance in the Ac-
8 count on the last day of the taxable year which
9 is attributable to amounts deposited in such Ac-
10 count before the 4th preceding taxable year.

11 “(C) ORDERING RULE.—For purposes of
12 this paragraph, distributions from a FARRM
13 Account (other than distributions of current in-
14 come) shall be treated as made from deposits in
15 the order in which such deposits were made, be-
16 ginning with the earliest deposits.

17 “(2) CESSATION IN ELIGIBLE BUSINESS.—At
18 the close of the first disqualification period after a
19 period for which the taxpayer was engaged in an eli-
20 gible farming business, there shall be deemed dis-
21 tributed from the FARRM Account of the taxpayer
22 an amount equal to the balance in such Account (if
23 any) at the close of such disqualification period. For
24 purposes of the preceding sentence, the term ‘dis-
25 qualification period’ means any period of 2 consecu-

1 tive taxable years for which the taxpayer is not en-
2 gaged in an eligible farming business.

3 “(3) CERTAIN RULES TO APPLY.—Rules similar
4 to the following rules shall apply for purposes of this
5 section:

6 “(A) Section 220(f)(8) (relating to treat-
7 ment on death).

8 “(B) Section 408(e)(2) (relating to loss of
9 exemption of account where individual engages
10 in prohibited transaction).

11 “(C) Section 408(e)(4) (relating to effect
12 of pledging account as security).

13 “(D) Section 408(g) (relating to commu-
14 nity property laws).

15 “(E) Section 408(h) (relating to custodial
16 accounts).

17 “(4) TIME WHEN PAYMENTS DEEMED MADE.—
18 For purposes of this section, a taxpayer shall be
19 deemed to have made a payment to a FARRM Ac-
20 count on the last day of a taxable year if such pay-
21 ment is made on account of such taxable year and
22 is made on or before the due date (without regard
23 to extensions) for filing the return of tax for such
24 taxable year.

1 “(5) INDIVIDUAL.—For purposes of this sec-
2 tion, the term ‘individual’ shall not include an estate
3 or trust.

4 “(6) DEDUCTION NOT ALLOWED FOR SELF-EM-
5 PLOYMENT TAX.—The deduction allowable by reason
6 of subsection (a) shall not be taken into account in
7 determining an individual’s net earnings from self-
8 employment (within the meaning of section 1402(a))
9 for purposes of chapter 2.

10 “(g) REPORTS.—The trustee of a FARRM Account
11 shall make such reports regarding such Account to the
12 Secretary and to the person for whose benefit the Account
13 is maintained with respect to contributions, distributions,
14 and such other matters as the Secretary may require
15 under regulations. The reports required by this subsection
16 shall be filed at such time and in such manner and fur-
17 nished to such persons at such time and in such manner
18 as may be required by such regulations.”.

19 (b) TAX ON EXCESS CONTRIBUTIONS.—

20 (1) Subsection (a) of section 4973 of the Inter-
21 nal Revenue Code of 1986 (relating to tax on excess
22 contributions to certain tax-favored accounts and an-
23 nuities) is amended by striking “or” at the end of
24 paragraph (3), by redesignating paragraph (4) as

1 paragraph (5), and by inserting after paragraph (3)
2 the following:

3 “(4) a FARRM Account (within the meaning of
4 section 468C(d)), or”.

5 (2) Section 4973 of such Code, is amended by
6 adding at the end the following:

7 “(g) EXCESS CONTRIBUTIONS TO FARRM AC-
8 COUNTS.—For purposes of this section, in the case of a
9 FARRM Account (within the meaning of section
10 468C(d)), the term ‘excess contributions’ means the
11 amount by which the amount contributed for the taxable
12 year to the Account exceeds the amount which may be con-
13 tributed to the Account under section 468C(b) for such
14 taxable year. For purposes of this subsection, any con-
15 tribution which is distributed out of the FARRM Account
16 in a distribution to which section 468C(e)(2)(B) applies
17 shall be treated as an amount not contributed.”.

18 (3) The section heading for section 4973 of
19 such Code is amended to read as follows:

20 **“SEC. 4973. EXCESS CONTRIBUTIONS TO CERTAIN AC-
21 COUNTS, ANNUITIES, ETC.”.**

22 (4) The table of sections for chapter 43 of such
23 Code is amended by striking the item relating to sec-
24 tion 4973 and inserting the following:

“Sec. 4973. Excess contributions to certain accounts, annuities,
etc.”.

1 (c) TAX ON PROHIBITED TRANSACTIONS.—

2 (1) Subsection (c) of section 4975 of the Inter-
3 nal Revenue Code of 1986 (relating to tax on pro-
4 hibited transactions) is amended by adding at the
5 end the following:

6 “(6) SPECIAL RULE FOR FARRM ACCOUNTS.—

7 A person for whose benefit a FARRM Account
8 (within the meaning of section 468C(d)) is estab-
9 lished shall be exempt from the tax imposed by this
10 section with respect to any transaction concerning
11 such account (which would otherwise be taxable
12 under this section) if, with respect to such trans-
13 action, the account ceases to be a FARRM Account
14 by reason of the application of section 468C(f)(3)(A)
15 to such account.”.

16 (2) Paragraph (1) of section 4975(e) of such
17 Code is amended by redesignating subparagraphs
18 (E) and (F) as subparagraphs (F) and (G), respec-
19 tively, and by inserting after subparagraph (D) the
20 following:

21 “(E) a FARRM Account described in sec-
22 tion 468C(d),”.

23 (d) FAILURE TO PROVIDE REPORTS ON FARRM AC-
24 COUNTS.—Paragraph (2) of section 6693(a) of the Inter-
25 nal Revenue Code of 1986 (relating to failure to provide

1 **SEC. 112. TERMINATION OF STEP UP IN BASIS AT DEATH.**

2 (a) **TERMINATION OF APPLICATION OF SECTION**
3 1014.—Section 1014 of the Internal Revenue Code of
4 1986 (relating to basis of property acquired from a dece-
5 dent) is amended by adding at the end the following:

6 “(f) **TERMINATION.**—In the case of a decedent dying
7 after December 31, 2010, this section shall not apply to
8 property for which basis is provided by section 1022.”.

9 (b) **CONFORMING AMENDMENT.**—Subsection (a) of
10 section 1016 of the Internal Revenue Code of 1986 (relat-
11 ing to adjustments to basis) is amended by striking “and”
12 at the end of paragraph (26), by striking the period at
13 the end of paragraph (27) and inserting “, and”, and by
14 adding at the end the following:

15 “(28) to the extent provided in section 1022
16 (relating to basis for certain property acquired from
17 a decedent dying after December 31, 2010).”.

18 **SEC. 113. CARRYOVER BASIS AT DEATH.**

19 (a) **GENERAL RULE.**—Part II of subchapter O of
20 chapter 1 of the Internal Revenue Code of 1986 (relating
21 to basis rules of general application) is amended by insert-
22 ing after section 1021 the following new section:

1 **“SEC. 1022. CARRYOVER BASIS FOR CERTAIN PROPERTY**
2 **ACQUIRED FROM A DECEDENT DYING AFTER**
3 **DECEMBER 31, 2010.**

4 “(a) CARRYOVER BASIS.—Except as otherwise pro-
5 vided in this section, the basis of carryover basis property
6 in the hands of a person acquiring such property from a
7 decedent shall be determined under section 1015.

8 “(b) CARRYOVER BASIS PROPERTY DEFINED.—

9 “(1) IN GENERAL.—For purposes of this sec-
10 tion, the term ‘carryover basis property’ means any
11 property—

12 “(A) which is acquired from or passed
13 from a decedent who died after December 31,
14 2010, and

15 “(B) which is not excluded pursuant to
16 paragraph (2).

17 The property taken into account under subpara-
18 graph (A) shall be determined under section 1014(b)
19 without regard to subparagraph (A) of the last sen-
20 tence of paragraph (9) thereof.

21 “(2) CERTAIN PROPERTY NOT CARRYOVER
22 BASIS PROPERTY.—The term ‘carryover basis prop-
23 erty’ does not include—

24 “(A) any item of gross income in respect
25 of a decedent described in section 691,

1 “(B) property of the decedent to the extent
2 that the aggregate adjusted fair market value
3 of such property does not exceed \$1,300,000,
4 and

5 “(C) property which was acquired from the
6 decedent by the surviving spouse of the dece-
7 dent (and which would be carryover basis prop-
8 erty without regard to this subparagraph) but
9 only if the value of such property would have
10 been deductible from the value of the taxable
11 estate of the decedent under section 2056, as in
12 effect on the day before the date of enactment
13 of the Rural America Prosperity Act of 2001.

14 For purposes of this subsection, the term ‘adjusted
15 fair market value’ means, with respect to any prop-
16 erty, fair market value reduced by any indebtedness
17 secured by such property.

18 “(3) LIMITATION ON EXCEPTION FOR PROP-
19 ERTY ACQUIRED BY SURVIVING SPOUSE.—The ad-
20 justed fair market value of property which is not
21 carryover basis property by reason of paragraph
22 (2)(C) shall not exceed \$3,000,000.

23 “(4) ALLOCATION OF EXCEPTED AMOUNTS.—
24 The executor shall allocate the limitations under
25 paragraphs (2)(B) and (3).

1 “(5) INFLATION ADJUSTMENT OF EXCEPTED
2 AMOUNTS.—In the case of decedents dying in a cal-
3 endar year after 2011, the dollar amounts in para-
4 graphs (2)(B) and (3) shall each be increased by an
5 amount equal to the product of—

6 “(A) such dollar amount, and

7 “(B) the cost-of-living adjustment deter-
8 mined under section 1(f)(3) for such calendar
9 year, determined by substituting ‘2010’ for
10 ‘1992’ in subparagraph (B) thereof.

11 If any increase determined under the preceding sen-
12 tence is not a multiple of \$10,000, such increase
13 shall be rounded to the nearest multiple of \$10,000.

14 “(c) REGULATIONS.—The Secretary shall prescribe
15 such regulations as may be necessary to carry out the pur-
16 poses of this section.”.

17 (b) MISCELLANEOUS AMENDMENTS RELATED TO
18 CARRYOVER BASIS.—

19 (1) CAPITAL GAIN TREATMENT FOR INHERITED
20 ART WORK OR SIMILAR PROPERTY.—

21 (A) IN GENERAL.—Subparagraph (C) of
22 section 1221(a)(3) of the Internal Revenue
23 Code of 1986 (defining capital asset) is amend-
24 ed by inserting “(other than by reason of sec-
25 tion 1022)” after “is determined”.

1 (B) COORDINATION WITH SECTION 170.—
2 Paragraph (1) of section 170(e) of such Code
3 (relating to certain contributions of ordinary in-
4 come and capital gain property) is amended by
5 adding at the end the following: “For purposes
6 of this paragraph, the determination of whether
7 property is a capital asset shall be made with-
8 out regard to the exception contained in section
9 1221(a)(3)(C) for basis determined under sec-
10 tion 1022.”.

11 (2) DEFINITION OF EXECUTOR.—Section
12 7701(a) of such Code (relating to definitions) is
13 amended by adding at the end the following:

14 “(47) EXECUTOR.—The term ‘executor’ means
15 the executor or administrator of the decedent, or, if
16 there is no executor or administrator appointed,
17 qualified, and acting within the United States, then
18 any person in actual or constructive possession of
19 any property of the decedent.”.

20 (3) CLERICAL AMENDMENT.—The table of sec-
21 tions for part II of subchapter O of chapter 1 of
22 such Code is amended by adding at the end the fol-
23 lowing new item:

“Sec. 1022. Carryover basis for certain property acquired from a
decedent dying after December 31, 2010.”.

1 (c) EFFECTIVE DATE.—The amendments made by
 2 this section shall apply to estates of decedents dying after
 3 December 31, 2010.

4 **SEC. 114. ADDITIONAL REDUCTIONS OF ESTATE AND GIFT**
 5 **TAX RATES.**

6 (a) MAXIMUM RATE OF TAX REDUCED TO 50 PER-
 7 CENT.—

8 (1) IN GENERAL.—The table contained in sec-
 9 tion 2001(c)(1) of the Internal Revenue Code of
 10 1986 is amended by striking the two highest brack-
 11 ets and inserting the following:

13 “(ii) the amount of the adjusted tax-

16 endar year in which the decedent died.

17 “(3) EXEMPTION AMOUNT.—

18 “(A) IN GENERAL.—The term ‘exemption
19 amount’ means \$60,000.

20 “(B) RESIDENTS OF POSSESSIONS OF THE
21 UNITED STATES.—In the case of a decedent
22 who is considered to be a nonresident not a cit-
23 izen of the United States under section 2209,
24 the exemption amount under this paragraph
25 shall be the greater of—

1 “(i) \$60,000, or

2 “(ii) that proportion of \$175,000
3 which the value of that part of the dece-
4 dent’s gross estate which at the time of his
5 death is situated in the United States
6 bears to the value of his entire gross estate
7 wherever situated.

8 “(C) SPECIAL RULES.—

9 “(i) COORDINATION WITH TREA-
10 TIES.—To the extent required under any
11 treaty obligation of the United States, the
12 exemption amount allowed under this para-
13 graph shall be equal to the amount which
14 bears the same ratio to the exemption
15 amount under section 2001(b)(3) (for the
16 calendar year in which the decedent died)
17 as the value of the part of the decedent’s
18 gross estate which at the time of his death
19 is situated in the United States bears to
20 the value of his entire gross estate wher-

13 **SEC. 116. DEEMED ALLOCATION OF GST EXEMPTION TO**
14 **LIFETIME TRANSFERS TO TRUSTS; RETRO-**
15 **ACTIVE ALLOCATIONS.**

16 (a) IN GENERAL.—Section 2632 of the Internal Rev-
17 enue Code of 1986 (relating to special rules for allocation
18 of GST exemption) is amended by redesignating sub-
19 section (c) as subsection (e) and by inserting after sub-
20 section (b) the following new subsections:

21 “(c) DEEMED ALLOCATION TO CERTAIN LIFETIME
22 TRANSFERS TO GST TRUSTS.—

23 “(1) IN GENERAL.—If any individual makes an
24 indirect skip during such individual’s lifetime, any
25 unused portion of such individual’s GST exemption

1 shall be allocated to the property transferred to the
2 extent necessary to make the inclusion ratio for such
3 property zero. If the amount of the indirect skip ex-
4 ceeds such unused portion, the entire unused portion
5 shall be allocated to the property transferred.

6 “(2) UNUSED PORTION.—For purposes of para-
7 graph (1), the unused portion of an individual’s
8 GST exemption is that portion of such exemption
9 which has not previously been—

10 “(A) allocated by such individual,

11 “(B) treated as allocated under subsection
12 (b) with respect to a direct skip occurring dur-
13 ing or before the calendar year in which the in-
14 direct skip is made, or

15 “(C) treated as allocated under paragraph
16 (1) with respect to a prior indirect skip.

17 “(3) DEFINITIONS.—

18 “(A) INDIRECT SKIP.—For purposes of
19 this subsection, the term ‘indirect skip’ means
20 any transfer of property (other than a direct
21 skip) subject to the tax imposed by chapter 12
22 made to a GST trust.

23 “(B) GST TRUST.—The term ‘GST trust’
24 means a trust that could have a generation-

1 skipping transfer with respect to the transferor
2 unless—

3 “(i) the trust instrument provides that
4 more than 25 percent of the trust corpus
5 must be distributed to or may be with-
6 drawn by one or more individuals who are
7 non-skip persons—

8 “(I) before the date that the indi-
9 vidual attains age 46,

10 “(II) on or before one or more
11 dates specified in the trust instrument
12 that will occur before the date that
13 such individual attains age 46, or

14 “(III) upon the occurrence of an
15 event that, in accordance with regula-
16 tions prescribed by the Secretary, may
17 reasonably be expected to occur before
18 the date that such individual attains
19 age 46;

20 “(ii) the trust instrument provides
21 that more than 25 percent of the trust cor-
22 pus must be distributed to or may be with-
23 drawn by one or more individuals who are
24 non-skip persons and who are living on the
25 date of death of another person identified

1 in the instrument (by name or by class)
2 who is more than 10 years older than such
3 individuals;

4 “(iii) the trust instrument provides
5 that, if one or more individuals who are
6 non-skip persons die on or before a date or
7 event described in clause (i) or (ii), more
8 than 25 percent of the trust corpus either
9 must be distributed to the estate or estates
10 of one or more of such individuals or is
11 subject to a general power of appointment
12 exercisable by one or more of such individ-
13 uals;

14 “(iv) the trust is a trust any portion
15 of which would be included in the gross es-
16 tate of a non-skip person (other than the
17 transferor) if such person died immediately
18 after the transfer;

19 “(v) the trust is a charitable lead an-
20 nuity trust (within the meaning of section
21 2642(e)(3)(A)) or a charitable remainder
22 annuity trust or a charitable remainder
23 unitrust (within the meaning of section
24 664(d)); or

1 “(vi) the trust is a trust with respect
2 to which a deduction was allowed under
3 section 2522 for the amount of an interest
4 in the form of the right to receive annual
5 payments of a fixed percentage of the net
6 fair market value of the trust property (de-
7 termined yearly) and which is required to
8 pay principal to a non-skip person if such
9 person is alive when the yearly payments
10 for which the deduction was allowed termi-
11 nate.

12 For purposes of this subparagraph, the value of
13 transferred property shall not be considered to
14 be includible in the gross estate of a non-skip
15 person or subject to a right of withdrawal by
16 reason of such person holding a right to with-
17 draw so much of such property as does not ex-
18 ceed the amount referred to in section 2503(b)
19 with respect to any transferor, and it shall be
20 assumed that powers of appointment held by
21 non-skip persons will not be exercised.

22 “(4) AUTOMATIC ALLOCATIONS TO CERTAIN
23 GST TRUSTS.—For purposes of this subsection, an
24 indirect skip to which section 2642(f) applies shall
25 be deemed to have been made only at the close of

1 the estate tax inclusion period. The fair market
2 value of such transfer shall be the fair market value
3 of the trust property at the close of the estate tax
4 inclusion period.

5 “(5) APPLICABILITY AND EFFECT.—

6 “(A) IN GENERAL.—An individual—

7 “(i) may elect to have this subsection
8 not apply to—

9 “(I) an indirect skip, or

10 “(II) any or all transfers made
11 by such individual to a particular
12 trust, and

13 “(ii) may elect to treat any trust as a
14 GST trust for purposes of this subsection
15 with respect to any or all transfers made
16 by such individual to such trust.

17 “(B) ELECTIONS.—

18 “(i) ELECTIONS WITH RESPECT TO
19 INDIRECT SKIPS.—An election under sub-
20 paragraph (A)(i)(I) shall be deemed to be
21 timely if filed on a timely filed gift tax re-
22 turn for the calendar year in which the
23 transfer was made or deemed to have been
24 made pursuant to paragraph (4) or on

1 such later date or dates as may be pre-
2 scribed by the Secretary.

3 “(ii) OTHER ELECTIONS.—An election
4 under clause (i)(II) or (ii) of subparagraph
5 (A) may be made on a timely filed gift tax
6 return for the calendar year for which the
7 election is to become effective.

8 “(d) RETROACTIVE ALLOCATIONS.—

9 “(1) IN GENERAL.—If—

10 “(A) a non-skip person has an interest or
11 a future interest in a trust to which any trans-
12 fer has been made,

13 “(B) such person—

14 “(i) is a lineal descendant of a grand-
15 parent of the transferor or of a grand-
16 parent of the transferor’s spouse or former
17 spouse, and

18 “(ii) is assigned to a generation below
19 the generation assignment of the trans-
20 feror, and

21 “(C) such person predeceases the trans-
22 feror,

23 then the transferor may make an allocation of any
24 of such transferor’s unused GST exemption to any

1 previous transfer or transfers to the trust on a
2 chronological basis.

3 “(2) SPECIAL RULES.—If the allocation under
4 paragraph (1) by the transferor is made on a gift
5 tax return filed on or before the date prescribed by
6 section 6075(b) for gifts made within the calendar
7 year within which the non-skip person’s death
8 occurred—

9 “(A) the value of such transfer or trans-
10 fers for purposes of section 2642(a) shall be de-
11 termined as if such allocation had been made
12 on a timely filed gift tax return for each cal-
13 endar year within which each transfer was
14 made,

15 “(B) such allocation shall be effective im-
16 mediately before such death, and

17 “(C) the amount of the transferor’s unused
18 GST exemption available to be allocated shall
19 be determined immediately before such death.

20 “(3) FUTURE INTEREST.—For purposes of this
21 subsection, a person has a future interest in a trust
22 if the trust may permit income or corpus to be paid
23 to such person on a date or dates in the future.”.

24 (b) CONFORMING AMENDMENT.—Paragraph (2) of
25 section 2632(b) of the Internal Revenue Code of 1986 is

1 amended by striking “with respect to a direct skip” and
2 inserting “or subsection (c)(1)”.

3 (c) EFFECTIVE DATES.—

4 (1) DEEMED ALLOCATION.—Section 2632(c) of
5 the Internal Revenue Code of 1986 (as added by
6 subsection (a)), and the amendment made by sub-
7 section (b), shall apply to transfers subject to chap-
8 ter 11 or 12 made after December 31, 2000, and to
9 estate tax inclusion periods ending after December
10 31, 2000.

11 (2) RETROACTIVE ALLOCATIONS.—Section
12 2632(d) of the Internal Revenue Code of 1986 (as
13 added by subsection (a)) shall apply to deaths of
14 non-skip persons occurring after December 31,
15 2000.

16 **SEC. 117. SEVERING OF TRUSTS.**

17 (a) IN GENERAL.—Subsection (a) of section 2642 of
18 the Internal Revenue Code of 1986 (relating to inclusion
19 ratio) is amended by adding at the end the following new
20 paragraph:

21 “(3) SEVERING OF TRUSTS.—

22 “(A) IN GENERAL.—If a trust is severed in
23 a qualified severance, the trusts resulting from
24 such severance shall be treated as separate
25 trusts thereafter for purposes of this chapter.

1 “(B) QUALIFIED SEVERANCE.—For pur-
2 poses of subparagraph (A)—

3 “(i) IN GENERAL.—The term ‘quali-
4 fied severance’ means the division of a sin-
5 gle trust and the creation (by any means
6 available under the governing instrument
7 or under local law) of two or more trusts
8 if—

9 “(I) the single trust was divided
10 on a fractional basis, and

11 “(II) the terms of the new trusts,
12 in the aggregate, provide for the same
13 succession of interests of beneficiaries
14 as are provided in the original trust.

15 “(ii) TRUSTS WITH INCLUSION RATIO
16 GREATER THAN ZERO.—If a trust has an
17 inclusion ratio of greater than zero and
18 less than 1, a severance is a qualified sev-
19 erance only if the single trust is divided
20 into two trusts, one of which receives a
21 fractional share of the total value of all
22 trust assets equal to the applicable fraction
23 of the single trust immediately before the
24 severance. In such case, the trust receiving
25 such fractional share shall have an inclu-

1 sion ratio of zero and the other trust shall
2 have an inclusion ratio of 1.

3 “(iii) REGULATIONS.—The term
4 ‘qualified severance’ includes any other
5 severance permitted under regulations pre-
6 scribed by the Secretary.

7 “(C) TIMING AND MANNER OF
8 SEVERANCES.—A severance pursuant to this
9 paragraph may be made at any time. The Sec-
10 retary shall prescribe by forms or regulations
11 the manner in which the qualified severance
12 shall be reported to the Secretary.”.

13 (b) EFFECTIVE DATE.—The amendment made by
14 this section shall apply to severances after December 31,
15 2000.

16 **SEC. 118. MODIFICATION OF CERTAIN VALUATION RULES.**

17 (a) GIFTS FOR WHICH GIFT TAX RETURN FILED OR
18 DEEMED ALLOCATION MADE.—Paragraph (1) of section
19 2642(b) of the Internal Revenue Code of 1986 (relating
20 to valuation rules, etc.) is amended to read as follows:

21 “(1) GIFTS FOR WHICH GIFT TAX RETURN
22 FILED OR DEEMED ALLOCATION MADE.—If the allo-
23 cation of the GST exemption to any transfers of
24 property is made on a gift tax return filed on or be-
25 fore the date prescribed by section 6075(b) for such

1 transfer or is deemed to be made under section 2632
2 (b)(1) or (c)(1)—

3 “(A) the value of such property for pur-
4 poses of subsection (a) shall be its value as fi-
5 nally determined for purposes of chapter 12
6 (within the meaning of section 2001(f)(2)), or,
7 in the case of an allocation deemed to have been
8 made at the close of an estate tax inclusion pe-
9 riod, its value at the time of the close of the es-
10 tate tax inclusion period, and

11 “(B) such allocation shall be effective on
12 and after the date of such transfer, or, in the
13 case of an allocation deemed to have been made
14 at the close of an estate tax inclusion period, on
15 and after the close of such estate tax inclusion
16 period.”.

17 (b) TRANSFERS AT DEATH.—Subparagraph (A) of
18 section 2642(b)(2) of the Internal Revenue Code of 1986
19 is amended to read as follows:

20 “(A) TRANSFERS AT DEATH.—If property
21 is transferred as a result of the death of the
22 transferor, the value of such property for pur-
23 poses of subsection (a) shall be its value as fi-
24 nally determined for purposes of chapter 11; ex-
25 cept that, if the requirements prescribed by the

1 Secretary respecting allocation of post-death
2 changes in value are not met, the value of such
3 property shall be determined as of the time of
4 the distribution concerned.”.

5 (c) EFFECTIVE DATE.—The amendments made by
6 this section shall apply to transfers subject to chapter 11
7 or 12 of the Internal Revenue Code of 1986 made after
8 December 31, 2000.

9 **SEC. 119. RELIEF PROVISIONS.**

10 (a) IN GENERAL.—Section 2642 of the Internal Rev-
11 enue Code of 1986 is amended by adding at the end the
12 following new subsection:

13 “(g) RELIEF PROVISIONS.—

14 “(1) RELIEF FROM LATE ELECTIONS.—

15 “(A) IN GENERAL.—The Secretary shall by
16 regulation prescribe such circumstances and
17 procedures under which extensions of time will
18 be granted to make—

19 “(i) an allocation of GST exemption
20 described in paragraph (1) or (2) of sub-
21 section (b), and

22 “(ii) an election under subsection
23 (b)(3) or (c)(5) of section 2632.

24 Such regulations shall include procedures for
25 requesting comparable relief with respect to

1 transfers made before the date of enactment of
2 this paragraph.

3 “(B) BASIS FOR DETERMINATIONS.—In
4 determining whether to grant relief under this
5 paragraph, the Secretary shall take into ac-
6 count all relevant circumstances, including evi-
7 dence of intent contained in the trust instru-
8 ment or instrument of transfer and such other
9 factors as the Secretary deems relevant. For
10 purposes of determining whether to grant relief
11 under this paragraph, the time for making the
12 allocation (or election) shall be treated as if not
13 expressly prescribed by statute.

14 “(2) SUBSTANTIAL COMPLIANCE.—An alloca-
15 tion of GST exemption under section 2632 that
16 demonstrates an intent to have the lowest possible
17 inclusion ratio with respect to a transfer or a trust
18 shall be deemed to be an allocation of so much of
19 the transferor’s unused GST exemption as produces
20 the lowest possible inclusion ratio. In determining
21 whether there has been substantial compliance, all
22 relevant circumstances shall be taken into account,
23 including evidence of intent contained in the trust
24 instrument or instrument of transfer and such other
25 factors as the Secretary deems relevant.”.

1 (b) EFFECTIVE DATES.—

2 (1) RELIEF FROM LATE ELECTIONS.—Section
3 2642(g)(1) of the Internal Revenue Code of 1986
4 (as added by subsection (a)) shall apply to requests
5 pending on, or filed after, December 31, 2000.

6 (2) SUBSTANTIAL COMPLIANCE.—Section
7 2642(g)(2) of such Code (as so added) shall apply
8 to transfers subject to chapter 11 or 12 of the Inter-
9 nal Revenue Code of 1986 made after December 31,
10 2000. No implication is intended with respect to the
11 availability of relief from late elections or the appli-
12 cation of a rule of substantial compliance on or be-
13 fore such date.

14 **SEC. 120. EXPANSION OF ESTATE TAX RULE FOR CON-**
15 **SERVATION EASEMENTS.**

16 (a) WHERE LAND IS LOCATED.—

17 (1) IN GENERAL.—Clause (i) of section
18 2031(c)(8)(A) of the Internal Revenue Code of 1986
19 (defining land subject to a conservation easement) is
20 amended—

21 (A) by striking “25 miles” both places it
22 appears and inserting “50 miles”; and

23 (B) striking “10 miles” and inserting “25
24 miles”.

1 (2) EFFECTIVE DATE.—The amendments made
2 by this subsection shall apply to estates of decedents
3 dying after December 31, 2000.

4 (b) CLARIFICATION OF DATE FOR DETERMINING
5 VALUE OF LAND AND EASEMENT.—

6 (1) IN GENERAL.—Section 2031(c)(2) of the
7 Internal Revenue Code of 1986 (defining applicable
8 percentage) is amended by adding at the end the fol-
9 lowing new sentence: “The values taken into account
10 under the preceding sentence shall be such values as
11 of the date of the contribution referred to in para-
12 graph (8)(B).”.

13 (2) EFFECTIVE DATE.—The amendment made
14 by this subsection shall apply to estates of decedents
15 dying after December 31, 1997.

16 **TITLE II—STUDY OF COSTS OF**
17 **REGULATIONS ON FARMERS,**
18 **RANCHERS, AND FORESTERS**

19 **SEC. 201. COMPTROLLER GENERAL STUDY OF REGULA-**
20 **TIONS.**

21 (a) DATA REVIEW AND COLLECTION.—The Comp-
22 troller General of the United States shall—

23 (1) conduct a review of existing Federal and
24 non-Federal studies and data regarding the cost to
25 farmers, ranchers, and foresters of complying with

1 existing or proposed Federal regulations directly af-
2 fecting farmers, ranchers, and foresters; and

3 (2) as necessary, obtain and analyze new data
4 concerning the costs to farmers, ranchers, and for-
5 esters of complying with Federal regulations pro-
6 posed as of February 1, 2001, directly affecting
7 farmers, ranchers, and foresters.

8 (b) USE OF DATA.—Using the studies and data re-
9 viewed and collected under subsection (a), the Comptroller
10 General shall—

11 (1) assess the overall costs to farmers, ranch-
12 ers, and foresters of complying with existing and
13 proposed Federal regulations directly affecting farm-
14 ers, ranchers, and foresters; and

15 (2) identify and recommend reasonable alter-
16 natives to those regulations that will achieve the ob-
17 jectives of the regulations at less cost to farmers,
18 ranchers, and foresters.

19 (c) SUBMISSION OF RESULTS.—Not later than Feb-
20 ruary 1, 2002, the Comptroller General shall submit to
21 the Secretary of Agriculture, the Committee on Agri-
22 culture, Nutrition, and Forestry of the Senate, and the
23 Committee on Agriculture of the House of Representatives
24 the results of the assessment conducted under subsection

1 (b)(1) and the recommendations prepared under sub-
 2 section (b)(2).

3 **SEC. 202. RESPONSE OF SECRETARY OF AGRICULTURE.**

4 Not later than April 1, 2002, the Secretary of Agri-
 5 culture shall submit to the Committee on Agriculture, Nu-
 6 trition, and Forestry of the Senate, and the Committee
 7 on Agriculture of the House of Representatives a report
 8 responding to the recommendations of the Comptroller
 9 General under section 202 regarding reasonable alter-
 10 natives that could achieve the objectives of Federal regula-
 11 tions at less cost to farmers, ranchers, and foresters.

12 **TITLE III—EXTENSION OF**
 13 **TRADE AUTHORITIES PROCE-**
 14 **DURES FOR RECIPROCAL**
 15 **TRADE AGREEMENTS**

16 **SEC. 301. SHORT TITLE.**

17 This title may be cited as the “Reciprocal Trade
 18 Agreement Authorities Act of 2001”.

19 **SEC. 302. TRADE NEGOTIATING OBJECTIVES.**

20 (a) OVERALL TRADE NEGOTIATING OBJECTIVES.—
 21 The overall trade negotiating objectives of the United
 22 States for agreements subject to the provisions of section
 23 303 are—

24 (1) to obtain more open, equitable, and recip-
 25 rocal market access;

1 (2) to obtain the reduction or elimination of
2 barriers and distortions that are directly related to
3 trade and that decrease market opportunities for
4 United States exports or otherwise distort United
5 States trade;

6 (3) to further strengthen the system of inter-
7 national trading disciplines and procedures, includ-
8 ing dispute settlement; and

9 (4) to foster economic growth, raise living
10 standards, and promote full employment in the
11 United States and to enhance the global economy.

12 (b) PRINCIPAL TRADE NEGOTIATING OBJECTIVES.—

13 (1) TRADE BARRIERS AND DISTORTIONS.—The
14 principal negotiating objectives of the United States
15 regarding trade barriers and other trade distortions
16 are—

17 (A) to expand competitive market opportu-
18 nities for United States exports and to obtain
19 fairer and more open conditions of trade by re-
20 ducing or eliminating tariff and nontariff bar-
21 riers and policies and practices of foreign gov-
22 ernments directly related to trade that decrease
23 market opportunities for United States exports
24 or otherwise distort United States trade; and

1 (B) to obtain reciprocal tariff and non-
2 tariff barrier elimination agreements, with par-
3 ticular attention to those tariff categories cov-
4 ered in section 111(b) of the Uruguay Round
5 Agreements Act (19 U.S.C. 3521(b)).

6 (2) TRADE IN SERVICES.—The principal negoti-
7 ating objective of the United States regarding trade
8 in services is to reduce or eliminate barriers to inter-
9 national trade in services, including regulatory and
10 other barriers that deny national treatment or un-
11 reasonably restrict the establishment or operations
12 of service suppliers.

13 (3) FOREIGN INVESTMENT.—The principal ne-
14 gotiating objective of the United States regarding
15 foreign investment is to reduce or eliminate artificial
16 or trade-distorting barriers to trade related foreign
17 investment by—

18 (A) reducing or eliminating exceptions to
19 the principle of national treatment;

20 (B) freeing the transfer of funds relating
21 to investments;

22 (C) reducing or eliminating performance
23 requirements and other unreasonable barriers
24 to the establishment and operation of invest-
25 ments;

1 (D) seeking to establish standards for ex-
2 propriation and compensation for expropriation,
3 consistent with United States legal principles
4 and practice; and

5 (E) providing meaningful procedures for
6 resolving investment disputes.

7 (4) INTELLECTUAL PROPERTY.—The principal
8 negotiating objectives of the United States regarding
9 trade-related intellectual property are—

10 (A) to further promote adequate and effec-
11 tive protection of intellectual property rights,
12 including through—

13 (i)(I) ensuring accelerated and full
14 implementation of the Agreement on
15 Trade-Related Aspects of Intellectual
16 Property Rights referred to in section
17 101(d)(15) of the Uruguay Round Agree-
18 ments Act (19 U.S.C. 3511(d)(15)), par-
19 ticularly with respect to United States in-
20 dustries whose products are subject to the
21 lengthiest transition periods for full com-
22 pliance by developing countries with that
23 Agreement, and

24 (II) ensuring that the provisions of
25 any multilateral or bilateral trade agree-

1 ment entered into by the United States
2 provide protection at least as strong as the
3 protection afforded by chapter 17 of the
4 North American Free Trade Agreement
5 and the annexes thereto;

6 (ii) providing strong protection for
7 new and emerging technologies and new
8 methods of transmitting and distributing
9 products embodying intellectual property;

10 (iii) preventing or eliminating dis-
11 crimination with respect to matters affect-
12 ing the availability, acquisition, scope,
13 maintenance, use, and enforcement of in-
14 tellectual property rights; and

15 (iv) providing strong enforcement of
16 intellectual property rights, including
17 through accessible, expeditious, and effec-
18 tive civil, administrative, and criminal en-
19 forcement mechanisms; and

20 (B) to secure fair, equitable, and non-
21 discriminatory market access opportunities for
22 United States persons that rely upon intellec-
23 tual property protection.

24 (5) TRANSPARENCY.—The principal negotiating
25 objective of the United States with respect to trans-

1 parency is to obtain broader application of the prin-
2 ciple of transparency through—

3 (A) increased and more timely public ac-
4 cess to information regarding trade issues and
5 the activities of international trade institutions;
6 and

7 (B) increased openness of dispute settle-
8 ment proceedings, including under the World
9 Trade Organization.

10 (6) RECIPROCAL TRADE IN AGRICULTURE.—

11 The principal negotiating objective of the United
12 States with respect to agriculture is to obtain com-
13 petitive opportunities for United States exports in
14 foreign markets substantially equivalent to the com-
15 petitive opportunities afforded foreign exports in
16 United States markets and to achieve fairer and
17 more open conditions of trade in bulk and value-
18 added commodities by—

19 (A) reducing or eliminating, by a date cer-
20 tain, tariffs or other charges that decrease mar-
21 ket opportunities for United States exports—

22 (i) giving priority to those products
23 that are subject to significantly higher tar-
24 iffs or subsidy regimes of major producing
25 countries; and

1 (ii) providing reasonable adjustment
2 periods for United States import-sensitive
3 products, in close consultation with the
4 Congress on such products before initiating
5 tariff reduction negotiations;

6 (B) reducing or eliminating subsidies that
7 decrease market opportunities for United States
8 exports or unfairly distort agriculture markets
9 to the detriment of the United States;

10 (C) developing, strengthening, and clari-
11 fying rules and effective dispute settlement
12 mechanisms to eliminate practices that unfairly
13 decrease United States market access opportu-
14 nities or distort agricultural markets to the det-
15 riment of the United States, including—

16 (i) unfair or trade-distorting activities
17 of export state trading enterprises and
18 other administrative mechanisms, with em-
19 phasis on requiring price transparency in
20 the operation of export state trading enter-
21 prises and such other mechanisms;

22 (ii) unjustified trade restrictions or
23 commercial requirements affecting new
24 technologies, including biotechnology;

- 1 (iii) unjustified sanitary or
2 phytosanitary restrictions, including those
3 not based on scientific principles in con-
4 travention of the Uruguay Round Agree-
5 ments;
- 6 (iv) other unjustified technical bar-
7 riers to trade; and
- 8 (v) restrictive rules in the administra-
9 tion of tariff-rate quotas;
- 10 (D) improving import relief mechanisms to
11 recognize the unique characteristics of perish-
12 able agriculture;
- 13 (E) taking into account whether a party to
14 the negotiations has failed to adhere to the pro-
15 visions of already existing trade agreements
16 with the United States or has circumvented ob-
17 ligations under those agreements;
- 18 (F) taking into account whether a product
19 is subject to market distortions by reason of a
20 failure of a major producing country to adhere
21 to the provisions of already existing trade
22 agreements with the United States or by the
23 circumvention by that country of its obligations
24 under those agreements; and

1 (G) otherwise ensuring that countries that
2 accede to the World Trade Organization have
3 made meaningful market liberalization commit-
4 ments in agriculture.

5 (7) LABOR, ENVIRONMENT, AND OTHER MAT-
6 TERS.—The principal negotiating objective of the
7 United States regarding labor, environment, and
8 other matters is to address the following aspects of
9 foreign government policies and practices regarding
10 labor, environment, and other matters that are di-
11 rectly related to trade:

12 (A) To ensure that foreign labor, environ-
13 mental, health, or safety policies and practices
14 do not arbitrarily or unjustifiably discriminate
15 or serve as disguised barriers to trade.

16 (B) To ensure that foreign governments do
17 not derogate from or waive existing domestic
18 environmental, health, safety, or labor meas-
19 ures, including measures that deter exploitative
20 child labor, as an encouragement to gain com-
21 petitive advantage in international trade or in-
22 vestment. Nothing in this subparagraph is in-
23 tended to address changes to a country's laws
24 that are consistent with sound macroeconomic
25 development.

1 (8) WTO EXTENDED NEGOTIATIONS.—The
2 principal negotiating objectives of the United States
3 regarding trade in financial services are those set
4 forth in section 135(a) of the Uruguay Round
5 Agreements Act (19 U.S.C. 3555(a)), regarding
6 trade in civil aircraft are those set forth in section
7 135(c) of that Act, and regarding rules of origin are
8 the conclusion of an agreement described in section
9 132 of that Act (19 U.S.C. 3552).

10 (c) INTERNATIONAL ECONOMIC POLICY OBJEC-
11 TIVES.—

12 (1) IN GENERAL.—The President should take
13 into account the relationship between trade agree-
14 ments and other important priorities of the United
15 States and seek to ensure that the trade agreements
16 entered into by the United States complement and
17 reinforce other policy goals. The United States prior-
18 ities in this area include—

19 (A) seeking to ensure that trade and envi-
20 ronmental policies are mutually supportive;

21 (B) seeking to protect and preserve the en-
22 vironment and enhance the international means
23 for doing so, while optimizing the use of the
24 world's resources;

1 (C) promoting respect for worker rights
2 and the rights of children and an understanding
3 of the relationship between trade and worker
4 rights, particularly by working with the Inter-
5 national Labor Organization to encourage the
6 observance and enforcement of core labor
7 standards, including the prohibition on exploita-
8 tive child labor; and

9 (D) supplementing and strengthening
10 standards for protection of intellectual property
11 under conventions administered by international
12 organizations other than the World Trade Or-
13 ganization, expanding these conventions to
14 cover new and emerging technologies, and elimi-
15 nating discrimination and unreasonable excep-
16 tions or preconditions to such protection.

17 (2) APPLICABILITY OF TRADE AUTHORITIES
18 PROCEDURES.—Nothing in this subsection shall be
19 construed to authorize the use of the trade authori-
20 ties procedures described in section 303 to modify
21 United States law.

22 (d) GUIDANCE FOR NEGOTIATORS.—

23 (1) DOMESTIC OBJECTIVES.—In pursuing the
24 negotiating objectives described in subsection (b),
25 the negotiators on behalf of the United States shall

1 take into account United States domestic objectives,
2 including the protection of health and safety, essen-
3 tial security, environmental, consumer, and employ-
4 ment opportunity interests, and the law and regula-
5 tions related thereto.

6 (2) CONSULTATIONS WITH CONGRESSIONAL AD-
7 VISERS AND ENFORCEMENT OF THE TRADE LAWS.—
8 In the course of negotiations conducted under this
9 title, the United States Trade Representative shall—

10 (A) consult closely and on a timely basis
11 with, and keep fully apprised of the negotia-
12 tions, the congressional advisers on trade policy
13 and negotiations appointed under section 161 of
14 the Trade Act of 1974; and

15 (B) preserve the ability of the United
16 States to enforce rigorously its trade laws, in-
17 cluding the antidumping and countervailing
18 duty laws, and avoid agreements which lessen
19 the effectiveness of domestic and international
20 disciplines on unfair trade, especially dumping
21 and subsidies, in order to ensure that United
22 States workers, agricultural producers, and
23 firms can compete fully on fair terms and enjoy
24 the benefits of reciprocal trade concessions.

1 (e) ADHERENCE TO OBLIGATIONS UNDER URUGUAY
2 ROUND AGREEMENTS.—In determining whether to enter
3 into negotiations with a particular country, the President
4 shall take into account the extent to which that country
5 has implemented, or has accelerated the implementation
6 of, its obligations under the Uruguay Round Agreements.

7 **SEC. 303. TRADE AGREEMENTS AUTHORITY.**

8 (a) AGREEMENTS REGARDING TARIFF BARRIERS.—

9 (1) IN GENERAL.—Whenever the President de-
10 termines that one or more existing duties or other
11 import restrictions of any foreign country or the
12 United States are unduly burdening and restricting
13 the foreign trade of the United States and that the
14 purposes, policies, and objectives of this title will be
15 promoted thereby, the President—

16 (A) may enter into trade agreements with
17 foreign countries before—

18 (i) October 1, 2003, or

19 (ii) October 1, 2007, if trade authori-
20 ties procedures are extended under sub-
21 section (c), and

22 (B) may, subject to paragraphs (2) and
23 (3), proclaim—

24 (i) such modification or continuance
25 of any existing duty,

1 (ii) such continuance of existing duty-
2 free or excise treatment, or

3 (iii) such additional duties,
4 as the President determines to be required or
5 appropriate to carry out any such trade agree-
6 ment. The President shall notify the Congress
7 of the President's intention to enter into an
8 agreement under this subsection.

9 (2) LIMITATIONS.—No proclamation may be
10 made under paragraph (1) that—

11 (A) reduces any rate of duty (other than a
12 rate of duty that does not exceed 5 percent ad
13 valorem on the date of enactment of this Act)
14 to a rate of duty that is less than 50 percent
15 of the rate of the duty that applies on such date
16 of enactment;

17 (B) reduces the rate of duty on an article
18 to take effect on a date that is more than 10
19 years after the first reduction that is pro-
20 claimed to carry out a trade agreement with re-
21 spect to such article; or

22 (C) increases any rate of duty above the
23 rate that applied on January 1, 2001.

24 (3) AGGREGATE REDUCTION; EXEMPTION FROM
25 STAGING.—

1 (A) AGGREGATE REDUCTION.—Except as
2 provided in subparagraph (B), the aggregate re-
3 duction in the rate of duty on any article which
4 is in effect on any day pursuant to a trade
5 agreement entered into under paragraph (1)
6 shall not exceed the aggregate reduction which
7 would have been in effect on such day if—

8 (i) a reduction of 3 percent ad valo-
9 rem or a reduction of one-tenth of the total
10 reduction, whichever is greater, had taken
11 effect on the effective date of the first re-
12 duction proclaimed under paragraph (1) to
13 carry out such agreement with respect to
14 such article; and

15 (ii) a reduction equal to the amount
16 applicable under clause (i) had taken effect
17 at 1-year intervals after the effective date
18 of such first reduction.

19 (B) EXEMPTION FROM STAGING.—No
20 staging is required under subparagraph (A)
21 with respect to a duty reduction that is pro-
22 claimed under paragraph (1) for an article of a
23 kind that is not produced in the United States.
24 The United States International Trade Com-
25 mission shall advise the President of the iden-

1 tity of articles that may be exempted from stag-
2 ing under this subparagraph.

3 (4) ROUNDING.—If the President determines
4 that such action will simplify the computation of re-
5 ductions under paragraph (3), the President may
6 round an annual reduction by an amount equal to
7 the lesser of—

8 (A) the difference between the reduction
9 without regard to this paragraph and the next
10 lower whole number; or

11 (B) one-half of 1 percent ad valorem.

12 (5) OTHER LIMITATIONS.—A rate of duty re-
13 duction that may not be proclaimed by reason of
14 paragraph (2) may take effect only if a provision au-
15 thorizing such reduction is included within an imple-
16 menting bill provided for under section 305 and that
17 bill is enacted into law.

18 (6) OTHER TARIFF MODIFICATIONS.—Notwith-
19 standing paragraphs (1)(B) and (2) through (5),
20 and subject to the consultation and layover require-
21 ments of section 115 of the Uruguay Round Agree-
22 ments Act, the President may proclaim the modifica-
23 tion of any duty or staged rate reduction of any duty
24 set forth in Schedule XX, as defined in section 2(5)
25 of that Act, if the United States agrees to such

1 modification or staged rate reduction in a negotia-
2 tion for the reciprocal elimination or harmonization
3 of duties under the auspices of the World Trade Or-
4 ganization or as part of an interim agreement lead-
5 ing to the formation of a regional free-trade area.

6 (7) AUTHORITY UNDER URUGUAY ROUND
7 AGREEMENTS ACT NOT AFFECTED.—Nothing in this
8 subsection shall limit the authority provided to the
9 President under section 111(b) of the Uruguay
10 Round Agreements Act (19 U.S.C. 3521(b)).

11 (b) AGREEMENTS REGARDING TARIFF AND NON-
12 TARIFF BARRIERS.—

13 (1) IN GENERAL.—(A) Whenever the President
14 determines that—

15 (i) one or more existing duties or any other
16 import restriction of any foreign country or the
17 United States or any other barrier to, or other
18 distortion of, international trade unduly bur-
19 dens or restricts the foreign trade of the United
20 States or adversely affects the United States
21 economy, or

22 (ii) the imposition of any such barrier or
23 distortion is likely to result in such a burden,
24 restriction, or effect,

1 and that the purposes, policies, and objectives of this
2 title will be promoted thereby, the President may
3 enter into a trade agreement described in subpara-
4 graph (B) during the period described in subpara-
5 graph (C).

6 (B) The President may enter into a trade
7 agreement under subparagraph (A) with foreign
8 countries providing for—

9 (i) the reduction or elimination of a duty,
10 restriction, barrier, or other distortion described
11 in subparagraph (A), or

12 (ii) the prohibition of, or limitation on the
13 imposition of, such barrier or other distortion.

14 (C) The President may enter into a trade
15 agreement under this paragraph before—

16 (i) October 1, 2003, or

17 (ii) October 1, 2007, if trade authorities
18 procedures are extended under subsection (c).

19 (2) CONDITIONS.—A trade agreement may be
20 entered into under this subsection only if such
21 agreement makes progress in meeting the applicable
22 objectives described in section 302 and the President
23 satisfies the conditions set forth in section 304.

24 (3) BILLS QUALIFYING FOR TRADE AUTHORI-
25 TIES PROCEDURES.—The provisions of section 151

1 of the Trade Act of 1974 (in this title referred to
2 as “trade authorities procedures”) apply to a bill of
3 either House of Congress consisting only of—

4 (A) a provision approving a trade agree-
5 ment entered into under this subsection and ap-
6 proving the statement of administrative action,
7 if any, proposed to implement such trade agree-
8 ment,

9 (B) provisions directly related to the prin-
10 cipal trade negotiating objectives set forth in
11 section 302(b) achieved in such trade agree-
12 ment, if those provisions are necessary for the
13 operation or implementation of United States
14 rights or obligations under such trade agree-
15 ment,

16 (C) provisions that define and clarify, or
17 provisions that are related to, the operation or
18 effect of the provisions of the trade agreement,

19 (D) provisions to provide adjustment as-
20 sistance to workers and firms adversely affected
21 by trade, and

22 (E) provisions necessary for purposes of
23 complying with section 252 of the Balanced
24 Budget and Emergency Deficit Control Act of
25 1985 in implementing the trade agreement,

1 to the same extent as such section 151 applies to
2 implementing bills under that section. A bill to
3 which this subparagraph applies shall hereafter in
4 this title be referred to as an “implementing bill”.

5 (c) EXTENSION DISAPPROVAL PROCESS FOR CON-
6 GRESSIONAL TRADE AUTHORITIES PROCEDURES.—

7 (1) IN GENERAL.—Except as provided in sec-
8 tion 305(b)—

9 (A) the trade authorities procedures apply
10 to implementing bills submitted with respect to
11 trade agreements entered into under subsection
12 (b) before October 1, 2003; and

13 (B) the trade authorities procedures shall
14 be extended to implementing bills submitted
15 with respect to trade agreements entered into
16 under subsection (b) after September 30, 2003,
17 and before October 1, 2007, if (and only if)—

18 (i) the President requests such exten-
19 sion under paragraph (2); and

20 (ii) neither House of the Congress
21 adopts an extension disapproval resolution
22 under paragraph (5) before October 1,
23 2003.

24 (2) REPORT TO CONGRESS BY THE PRESI-
25 DENT.—If the President is of the opinion that the

1 trade authorities procedures should be extended to
2 implementing bills described in paragraph (1)(B),
3 the President shall submit to the Congress, not later
4 than July 1, 2003, a written report that contains a
5 request for such extension, together with—

6 (A) a description of all trade agreements
7 that have been negotiated under subsection (b)
8 and the anticipated schedule for submitting
9 such agreements to the Congress for approval;

10 (B) a description of the progress that has
11 been made in negotiations to achieve the pur-
12 poses, policies, and objectives of this title, and
13 a statement that such progress justifies the
14 continuation of negotiations; and

15 (C) a statement of the reasons why the ex-
16 tension is needed to complete the negotiations.

17 (3) REPORT TO CONGRESS BY THE ADVISORY
18 COMMITTEE.—The President shall promptly inform
19 the Advisory Committee for Trade Policy and Nego-
20 tiations established under section 135 of the Trade
21 Act of 1974 (19 U.S.C. 2155) of the President’s de-
22 cision to submit a report to the Congress under
23 paragraph (2). The Advisory Committee shall submit
24 to the Congress as soon as practicable, but not later

1 than August 1, 2003, a written report that
2 contains—

3 (A) its views regarding the progress that
4 has been made in negotiations to achieve the
5 purposes, policies, and objectives of this title;
6 and

7 (B) a statement of its views, and the rea-
8 sons therefor, regarding whether the extension
9 requested under paragraph (2) should be ap-
10 proved or disapproved.

11 (4) REPORTS MAY BE CLASSIFIED.—The re-
12 ports submitted to the Congress under paragraphs
13 (2) and (3), or any portion of such reports, may be
14 classified to the extent the President determines ap-
15 propriate.

16 (5) EXTENSION DISAPPROVAL RESOLUTION.—

17 (A) For purposes of paragraph (1), the term “exten-
18 sion disapproval resolution” means a resolution of
19 either House of the Congress, the sole matter after
20 the resolving clause of which is as follows: “That the
21 _____ disapproves the request of the President for
22 the extension, under section 303(c)(1)(B)(i) of the
23 Reciprocal Trade Agreement Authorities Act of
24 2001, of the provisions of section 151 of the Trade
25 Act of 1974 to any implementing bill submitted with

1 respect to any trade agreement entered into under
2 section 303(b) of the Reciprocal Trade Agreement
3 Authorities Act of 2001 after September 30, 2003.”,
4 with the blank space being filled with the name of
5 the resolving House of the Congress.

6 (B) An extension disapproval resolution—

7 (i) may be introduced in either House of
8 the Congress by any member of such House;
9 and

10 (ii) shall be referred, in the House of Rep-
11 resentatives, to the Committee on Ways and
12 Means and to the Committee on Rules.

13 (C) The provisions of sections 152(d) and (e) of
14 the Trade Act of 1974 (19 U.S.C. 2192(d) and (e))
15 (relating to the floor consideration of certain resolu-
16 tions in the House and Senate) apply to an exten-
17 sion disapproval resolution.

18 (D) It is not in order for—

19 (i) the Senate to consider any extension
20 disapproval resolution not reported by the Com-
21 mittee on Finance;

22 (ii) the House of Representatives to con-
23 sider any extension disapproval resolution not
24 reported by the Committee on Ways and Means
25 and by the Committee on Rules; or

1 (iii) either House of the Congress to con-
2 sider an extension disapproval resolution after
3 September 30, 2003.

4 **SEC. 304. CONSULTATIONS.**

5 (a) NOTICE AND CONSULTATION BEFORE NEGOTIA-
6 TION.—

7 (1) IN GENERAL.—The President, with respect
8 to any agreement that is subject to the provisions of
9 section 303(b), shall—

10 (A) provide, at least 90 calendar days be-
11 fore initiating negotiations, written notice to the
12 Congress of the President's intention to enter
13 into the negotiations and set forth therein the
14 date the President intends to initiate such nego-
15 tiations, the specific United States objectives
16 for the negotiations, and whether the President
17 intends to seek an agreement, or changes to an
18 existing agreement; and

19 (B) before and after submission of the no-
20 tice, consult regarding the negotiations with the
21 Committee on Finance of the Senate and the
22 Committee on Ways and Means of the House of
23 Representatives and such other committees of
24 the House and Senate as the President deems
25 appropriate.

1 (2) CONSULTATIONS REGARDING NEGOTIA-
2 TIONS ON CERTAIN OBJECTIVES.—

3 (A) CONSULTATION.—In addition to the
4 requirements set forth in paragraph (1), before
5 initiating negotiations with respect to a trade
6 agreement subject to section 303(b) where the
7 subject matter of such negotiations is directly
8 related to the principal trade negotiating objec-
9 tives set forth in section 302(b)(1) or section
10 302(b)(7), the President shall consult with the
11 Committee on Ways and Means of the House of
12 Representatives and the Committee on Finance
13 of the Senate and with the appropriate advisory
14 groups established under section 135 of the
15 Trade Act of 1974 with respect to such negotia-
16 tions.

17 (B) SCOPE.—The consultations described
18 in subparagraph (A) shall concern the manner
19 in which the negotiation will address the objec-
20 tive of reducing or eliminating a specific tariff
21 or nontariff barrier or foreign government pol-
22 icy or practice directly related to trade that de-
23 creases market opportunities for United States
24 exports or otherwise distorts United States
25 trade.

1 (3) NEGOTIATIONS REGARDING AGRI-
2 CULTURE.—Before initiating negotiations the sub-
3 ject matter of which is directly related to the subject
4 matter under section 302(b)(6)(A) with any country,
5 the President shall assess whether United States
6 tariffs on agriculture products that were bound
7 under the Uruguay Round Agreements are lower
8 than the tariffs bound by that country. In addition,
9 the President shall consider whether the tariff levels
10 bound and applied throughout the world with respect
11 to imports from the United States are higher than
12 United States tariffs and whether the negotiation
13 provides an opportunity to address any such dis-
14 parity. The President shall consult with the Com-
15 mittee on Ways and Means and the Committee on
16 Agriculture of the House of Representatives and the
17 Committee on Finance and the Committee on Agri-
18 culture, Nutrition, and Forestry of the Senate con-
19 cerning the results of the assessment, whether it is
20 appropriate for the United States to agree to further
21 tariff reductions based on the conclusions reached in
22 the assessment, and how all applicable negotiating
23 objectives will be met.

24 (b) CONSULTATION WITH CONGRESS BEFORE
25 AGREEMENTS ENTERED INTO.—

1 (1) CONSULTATION.—Before entering into any
2 trade agreement under section 303(b), the President
3 shall consult with—

4 (A) the Committee on Ways and Means of
5 the House of Representatives and the Com-
6 mittee on Finance of the Senate; and

7 (B) each other committee of the House
8 and the Senate, and each joint committee of the
9 Congress, which has jurisdiction over legislation
10 involving subject matters which would be af-
11 fected by the trade agreement.

12 (2) SCOPE.—The consultation described in
13 paragraph (1) shall include consultation with respect
14 to—

15 (A) the nature of the agreement;

16 (B) how and to what extent the agreement
17 will achieve the applicable purposes, policies,
18 and objectives of this title; and

19 (C) the implementation of the agreement
20 under section 305, including the general effect
21 of the agreement on existing laws.

22 (c) ADVISORY COMMITTEE REPORTS.—The report
23 required under section 135(e)(1) of the Trade Act of 1974
24 regarding any trade agreement entered into under section
25 303(a) or (b) of this Act shall be provided to the Presi-

1 dent, the Congress, and the United States Trade Rep-
2 resentative not later than 30 days after the date on which
3 the President notifies the Congress under section
4 303(a)(1) or 305(a)(1)(A) of the President's intention to
5 enter into the agreement.

6 **SEC. 305. IMPLEMENTATION OF TRADE AGREEMENTS.**

7 (a) IN GENERAL.—

8 (1) NOTIFICATION AND SUBMISSION.—Any
9 agreement entered into under section 303(b) shall
10 enter into force with respect to the United States if
11 (and only if)—

12 (A) the President, at least 90 calendar
13 days before the day on which the President en-
14 ters into the trade agreement, notifies the
15 House of Representatives and the Senate of the
16 President's intention to enter into the agree-
17 ment, and promptly thereafter publishes notice
18 of such intention in the Federal Register;

19 (B) within 60 days after entering into the
20 agreement, the President submits to the Con-
21 gress a description of those changes to existing
22 laws that the President considers would be re-
23 quired in order to bring the United States into
24 compliance with the agreement;

1 (C) after entering into the agreement, the
2 President submits a copy of the final legal text
3 of the agreement, together with—

4 (i) a draft of an implementing bill de-
5 scribed in section 303(b)(3);

6 (ii) a statement of any administrative
7 action proposed to implement the trade
8 agreement; and

9 (iii) the supporting information de-
10 scribed in paragraph (2); and

11 (D) the implementing bill is enacted into
12 law.

13 (2) SUPPORTING INFORMATION.—The sup-
14 porting information required under paragraph
15 (1)(C)(iii) consists of—

16 (A) an explanation as to how the imple-
17 menting bill and proposed administrative action
18 will change or affect existing law; and

19 (B) a statement—

20 (i) asserting that the agreement
21 makes progress in achieving the applicable
22 purposes, policies, and objectives of this
23 title;

24 (ii) setting forth the reasons of the
25 President regarding—

1 (I) how and to what extent the
2 agreement makes progress in achiev-
3 ing the applicable purposes, policies,
4 and objectives referred to in clause (i);

5 (II) whether and how the agree-
6 ment changes provisions of an agree-
7 ment previously negotiated;

8 (III) how the agreement serves
9 the interests of United States com-
10 merce; and

11 (IV) how the implementing bill
12 meets the standards set forth in sec-
13 tion 303(b)(3).

14 (3) RECIPROCAL BENEFITS.—In order to en-
15 sure that a foreign country that is not a party to a
16 trade agreement entered into under section 303(b)
17 does not receive benefits under the agreement unless
18 the country is also subject to the obligations under
19 the agreement, the implementing bill submitted with
20 respect to the agreement shall provide that the bene-
21 fits and obligations under the agreement apply only
22 to the parties to the agreement, if such application
23 is consistent with the terms of the agreement. The
24 implementing bill may also provide that the benefits
25 and obligations under the agreement do not apply

1 uniformly to all parties to the agreement, if such ap-
2 plication is consistent with the terms of the agree-
3 ment.

4 (b) LIMITATIONS ON TRADE AUTHORITIES PROCE-
5 DURES.—

6 (1) FOR LACK OF CONSULTATIONS.—

7 (A) IN GENERAL.—The trade authorities
8 procedures shall not apply to any implementing
9 bill submitted with respect to a trade agreement
10 entered into under section 303(b) if during the
11 60-day period beginning on the date that one
12 House of Congress agrees to a procedural dis-
13 approval resolution for lack of notice or con-
14 sultations with respect to that trade agreement,
15 the other House separately agrees to a proce-
16 dural disapproval resolution with respect to that
17 agreement.

18 (B) PROCEDURAL DISAPPROVAL RESOLU-
19 TION.—For purposes of this paragraph, the
20 term “procedural disapproval resolution” means
21 a resolution of either House of Congress, the
22 sole matter after the resolving clause of which
23 is as follows: “That the President has failed or
24 refused to notify or consult (as the case may
25 be) with Congress in accordance with section

1 304 or 305 of the Reciprocal Trade Agreement
2 Authorities Act of 2001 on negotiations with re-
3 spect to, or entering into, a trade agreement to
4 which section 303(b) of that Act applies and,
5 therefore, the provisions of section 151 of the
6 Trade Act of 1974 shall not apply to any imple-
7 menting bill submitted with respect to that
8 trade agreement.”.

9 (2) PROCEDURES FOR CONSIDERING RESOLU-
10 TION.—(A) A procedural disapproval resolution—

11 (i) in the House of Representatives—

12 (I) shall be introduced by the chair-
13 man or ranking minority member of the
14 Committee on Ways and Means or the
15 chairman or ranking minority member of
16 the Committee on Rules;

17 (II) shall be referred to the Com-
18 mittee on Ways and Means and to the
19 Committee on Rules; and

20 (III) may not be amended by either
21 Committee; and

22 (ii) in the Senate shall be an original reso-
23 lution of the Committee on Finance.

24 (B) The provisions of section 152(d) and (e) of
25 the Trade Act of 1974 (19 U.S.C. 2192(d) and (e))

1 (relating to the floor consideration of certain resolu-
 2 tions in the House and Senate) apply to a proce-
 3 dural disapproval resolution.

4 (C) It is not in order for the House of Rep-
 5 resentatives to consider any procedural disapproval
 6 resolution not reported by the Committee on Ways
 7 and Means and by the Committee on Rules.

8 (c) RULES OF HOUSE OF REPRESENTATIVES AND
 9 SENATE.—Subsection (b) of this section and section
 10 303(c) are enacted by the Congress—

11 (1) as an exercise of the rulemaking power of
 12 the House of Representatives and the Senate, re-
 13 spectively, and as such are deemed a part of the
 14 rules of each House, respectively, and such proce-
 15 dures supersede other rules only to the extent that
 16 they are inconsistent with such other rules; and

17 (2) with the full recognition of the constitu-
 18 tional right of either House to change the rules (so
 19 far as relating to the procedures of that House) at
 20 any time, in the same manner, and to the same ex-
 21 tent as any other rule of that House.

22 **SEC. 306. TREATMENT OF CERTAIN TRADE AGREEMENTS.**

23 (a) CERTAIN AGREEMENTS.—Notwithstanding sec-
 24 tion 303(b)(2), if an agreement to which section 303(b)
 25 applies—

1 (1) is entered into under the auspices of the
2 World Trade Organization regarding trade in infor-
3 mation technology products,

4 (2) is entered into under the auspices of the
5 World Trade Organization regarding extended nego-
6 tiations on financial services as described in section
7 135(a) of the Uruguay Round Agreements Act (19
8 U.S.C. 3555(a)),

9 (3) is entered into under the auspices of the
10 World Trade Organization regarding the rules of ori-
11 gin work program described in Article 9 of the
12 Agreement on Rules of Origin referred to in section
13 101(d)(10) of the Uruguay Round Agreements Act
14 (19 U.S.C. 3511(d)(10)), or

15 (4) is entered into with Chile,
16 and results from negotiations that were commenced before
17 the date of enactment of this Act, subsection (b) shall
18 apply.

19 (b) TREATMENT OF AGREEMENTS.—In the case of
20 any agreement to which subsection (a) applies—

21 (1) the applicability of the trade authorities
22 procedures to implementing bills shall be determined
23 without regard to the requirements of section
24 304(a), and any procedural disapproval resolution
25 under section 305(b)(1)(B) shall not be in order on

1 the basis of a failure or refusal to comply with the
2 provisions of section 304(a); and

3 (2) the President shall consult regarding the
4 negotiations described in subsection (a) with the
5 committees described in section 304(a)(1)(B) as
6 soon as feasible after the enactment of this Act.

7 **SEC. 307. CONFORMING AMENDMENTS.**

8 (a) IN GENERAL.—Title I of the Trade Act of 1974
9 (19 U.S.C. 2111 et seq.) is amended as follows:

10 (1) IMPLEMENTING BILL.—

11 (A) Section 151(b)(1) (19 U.S.C.
12 2191(b)(1)) is amended by striking “section
13 1103(a)(1) of the Omnibus Trade and Competi-
14 tiveness Act of 1988, or section 282 of the Uru-
15 guay Round Agreements Act” and inserting
16 “section 282 of the Uruguay Round Agree-
17 ments Act, or section 305(a)(1) of the Recip-
18 rocal Trade Agreement Authorities Act of
19 2001”.

20 (B) Section 151(c)(1) (19 U.S.C.
21 2191(c)(1)) is amended by striking “or section
22 282 of the Uruguay Round Agreements Act”
23 and inserting “, section 282 of the Uruguay
24 Round Agreements Act, or section 305(a)(1) of

1 the Reciprocal Trade Agreement Authorities
2 Act of 2001”.

3 (2) ADVICE FROM INTERNATIONAL TRADE COM-
4 MISSION.—Section 131 (19 U.S.C. 2151) is
5 amended—

6 (A) in subsection (a)—

7 (i) in paragraph (1), by striking “sec-
8 tion 123 of this Act or section 1102 (a) or
9 (c) of the Omnibus Trade and Competitive-
10 ness Act of 1988,” and inserting “section
11 123 of this Act or section 303(a) or (b) of
12 the Reciprocal Trade Agreement Authori-
13 ties Act of 2001,”; and

14 (ii) in paragraph (2), by striking “sec-
15 tion 1102 (b) or (c) of the Omnibus Trade
16 and Competitiveness Act of 1988” and in-
17 serting “section 303(b) of the Reciprocal
18 Trade Agreement Authorities Act of
19 2001”;

20 (B) in subsection (b), by striking “section
21 1102(a)(3)(A)” and inserting “section
22 303(a)(3)(A) of the Reciprocal Trade Agree-
23 ment Authorities Act of 2001” before the end
24 period; and

1 (C) in subsection (c), by striking “section
2 1102 of the Omnibus Trade and Competitive-
3 ness Act of 1988,” and inserting “section 303
4 of the Reciprocal Trade Agreement Authorities
5 Act of 2001,”.

6 (3) HEARINGS AND ADVICE.—Sections 132,
7 133(a), and 134(a) (19 U.S.C. 2152, 2153(a), and
8 2154(a)) are each amended by striking “section
9 1102 of the Omnibus Trade and Competitiveness
10 Act of 1988,” each place it appears and inserting
11 “section 303 of the Reciprocal Trade Agreement Au-
12 thorities Act of 2001,”.

13 (4) PREREQUISITES FOR OFFERS.—Section
14 134(b) (19 U.S.C. 2154(b)) is amended by striking
15 “section 1102 of the Omnibus Trade and Competi-
16 tiveness Act of 1988” and inserting “section 303 of
17 the Reciprocal Trade Agreement Authorities Act of
18 2001”.

19 (5) ADVICE FROM PRIVATE AND PUBLIC SEC-
20 TORS.—Section 135 (19 U.S.C. 2155) is amended—

21 (A) in subsection (a)(1)(A), by striking
22 “section 1102 of the Omnibus Trade and Com-
23 petitiveness Act of 1988” and inserting “section
24 303 of the Reciprocal Trade Agreement Au-
25 thorities Act of 2001”;

1 (B) in subsection (e)(1)—

2 (i) by striking “section 1102 of the
3 Omnibus Trade and Competitiveness Act
4 of 1988” each place it appears and insert-
5 ing “section 303 of the Reciprocal Trade
6 Agreement Authorities Act of 2001”; and

7 (ii) by striking “section 1103(a)(1)(A)
8 of such Act of 1988” and inserting “sec-
9 tion 305(a)(1)(A) of the Reciprocal Trade
10 Agreement Authorities Act of 2001”; and

11 (C) in subsection (e)(2), by striking “sec-
12 tion 1101 of the Omnibus Trade and Competi-
13 tiveness Act of 1988” and inserting “section
14 302 of the Reciprocal Trade Agreement Au-
15 thorities Act of 2001”.

16 (6) TRANSMISSION OF AGREEMENTS TO CON-
17 GRESS.—Section 162(a) (19 U.S.C. 2212(a)) is
18 amended by striking “or under section 1102 of the
19 Omnibus Trade and Competitiveness Act of 1988”
20 and inserting “or under section 303 of the Recip-
21 rocal Trade Agreement Authorities Act of 2001”.

22 (b) APPLICATION OF CERTAIN PROVISIONS.—For
23 purposes of applying sections 125, 126, and 127 of the
24 Trade Act of 1974 (19 U.S.C. 2135, 2136(a), and
25 2137)—

1 (1) any trade agreement entered into under sec-
2 tion 303 shall be treated as an agreement entered
3 into under section 101 or 102, as appropriate, of the
4 Trade Act of 1974 (19 U.S.C. 2111 or 2112); and

5 (2) any proclamation or Executive order issued
6 pursuant to a trade agreement entered into under
7 section 303 shall be treated as a proclamation or
8 Executive order issued pursuant to a trade agree-
9 ment entered into under section 102 of the Trade
10 Act of 1974.

11 **SEC. 308. DEFINITIONS.**

12 In this title:

13 (1) UNITED STATES PERSON.—The term
14 “United States person” means—

15 (A) a United States citizen;

16 (B) a partnership, corporation, or other
17 legal entity organized under the laws of the
18 United States; and

19 (C) a partnership, corporation, or other
20 legal entity that is organized under the laws of
21 a foreign country and is controlled by entities
22 described in subparagraph (B) or United States
23 citizens, or both.

24 (2) URUGUAY ROUND AGREEMENTS.—The term
25 “Uruguay Round Agreements” has the meaning

1 given that term in section 2(7) of the Uruguay
2 Round Agreements Act (19 U.S.C. 3501(7)).

3 (3) **WORLD TRADE ORGANIZATION.**—The term
4 “World Trade Organization” means the organization
5 established pursuant to the WTO Agreement.

6 (4) **WTO AGREEMENT.**—The term “WTO
7 Agreement” means the Agreement Establishing the
8 World Trade Organization entered into on April 15,
9 1994.

10 **TITLE IV—AGRICULTURAL** 11 **TRADE FREEDOM**

12 **SEC. 401. SHORT TITLE.**

13 This title may be cited as the “Agricultural Trade
14 Freedom Act”.

15 **SEC. 402. DEFINITIONS.**

16 In this title, the terms “agricultural commodity” and
17 “United States agricultural commodity” have the mean-
18 ings given the terms in section 102 of the Agricultural
19 Trade Act of 1978 (7 U.S.C. 5602).

20 **SEC. 403. AGRICULTURAL COMMODITIES, LIVESTOCK, AND** 21 **PRODUCTS EXEMPT FROM UNILATERAL AG-** 22 **RICULTURAL SANCTIONS.**

23 Subtitle B of title IV of the Agricultural Trade Act
24 of 1978 (7 U.S.C. 5661 et seq.) is amended by adding
25 at the end the following:

1 **“SEC. 418. AGRICULTURAL COMMODITIES, LIVESTOCK, AND**
2 **PRODUCTS EXEMPT FROM UNILATERAL AG-**
3 **RICULTURAL SANCTIONS.**

4 “(a) DEFINITIONS.—In this section:

5 “(1) CURRENT SANCTION.—The term ‘current
6 sanction’ means a unilateral agricultural sanction
7 that is in effect on the date of enactment of the Ag-
8 ricultural Trade Freedom Act.

9 “(2) NEW SANCTION.—The term ‘new sanction’
10 means a unilateral agricultural sanction that be-
11 comes effective after the date of enactment of that
12 Act.

13 “(3) UNILATERAL AGRICULTURAL SANCTION.—
14 The term ‘unilateral agricultural sanction’ means
15 any prohibition, restriction, or condition that is im-
16 posed on the export of an agricultural commodity to
17 a foreign country or foreign entity and that is im-
18 posed by the United States for reasons of the na-
19 tional interest, except in a case in which the United
20 States imposes the measure pursuant to a multilat-
21 eral regime and the other members of that regime
22 have agreed to impose substantially equivalent meas-
23 ures.

24 “(b) EXEMPTION.—

25 “(1) IN GENERAL.—Subject to paragraphs (2)
26 and (3) and notwithstanding any other provision of

1 law, agricultural commodities made available as a re-
2 sult of commercial sales shall be exempt from a uni-
3 lateral agricultural sanction imposed by the United
4 States on another country.

5 “(2) EXCLUSIONS.—Paragraph (1) shall not
6 apply to agricultural commodities made available as
7 a result of programs carried out under—

8 “(A) the Agricultural Trade Development
9 and Assistance Act of 1954 (7 U.S.C. 1691 et
10 seq.);

11 “(B) section 416 of the Agricultural Act of
12 1949 (7 U.S.C. 1431);

13 “(C) the Food for Progress Act of 1985 (7
14 U.S.C. 1736o);

15 “(D) the Agricultural Trade Act of 1978
16 (7 U.S.C. 5601 et seq.); or

17 “(E) section 153 of the Food Security Act
18 of 1985 (15 U.S.C. 713a–14).

19 “(3) DETERMINATION BY PRESIDENT.—The
20 President may include agricultural commodities
21 made available as a result of the activities described
22 in paragraph (1) in the unilateral agricultural sanc-
23 tion imposed on a foreign country or foreign entity
24 if—

1 “(A) a declaration of war by Congress is in
2 effect with respect to the foreign country or for-
3 eign entity; or

4 “(B)(i) the President determines that in-
5 clusion of the agricultural commodities is in the
6 national interest;

7 “(ii) the President submits the report re-
8 quired under subsection (d); and

9 “(iii) Congress has not approved a joint
10 resolution stating the disapproval of Congress
11 of the report submitted under subsection (d).

12 “(4) EFFECT ON AGRICULTURAL TRADE.—
13 Nothing in this subsection requires the imposition of
14 a unilateral agricultural sanction with respect to an
15 agricultural commodity, whether exported in connec-
16 tion with a commercial sale or a program described
17 in paragraph (2).

18 “(c) CURRENT SANCTIONS.—

19 “(1) IN GENERAL.—Subject to paragraph (2),
20 the exemption under subsection (b)(1) shall apply to
21 a current sanction.

22 “(2) PRESIDENTIAL REVIEW.—Not later than
23 90 days after the date of enactment of the Agricul-
24 tural Trade Freedom Act, the President shall review
25 each current sanction to determine whether the ex-

1 exemption under subsection (b)(1) should apply to the
2 current sanction.

3 “(3) APPLICATION.—The exemption under sub-
4 section (b)(1) shall apply to a current sanction be-
5 ginning on the date that is 180 days after the date
6 of enactment of the Agricultural Trade Freedom Act
7 unless the President determines that the exemption
8 should not apply to the current sanction for reasons
9 of the national interest.

10 “(d) REPORT.—

11 “(1) IN GENERAL.—If the President determines
12 under subsection (b)(3)(B)(i) or (c)(3) that the ex-
13 emption should not apply to a unilateral agricultural
14 sanction, the President shall submit a report to Con-
15 gress not later than 15 days after the date of the
16 determination.

17 “(2) CONTENTS OF REPORT.—The report shall
18 contain—

19 “(A) an explanation of—

20 “(i) the economic activity that is pro-
21 posed to be prohibited, restricted, or condi-
22 tioned by the unilateral agricultural sanc-
23 tion; and

1 “(ii) the national interest for which
2 the exemption should not apply to the uni-
3 lateral agricultural sanction; and

4 “(B) an assessment by the Secretary—

5 “(i) regarding export sales—

6 “(I) in the case of a current
7 sanction, whether markets in the
8 sanctioned country or countries
9 present a substantial trade oppor-
10 tunity for export sales of a United
11 States agricultural commodity; or

12 “(II) in the case of a new sanc-
13 tion, the extent to which any country
14 or countries to be sanctioned or likely
15 to be sanctioned are markets that ac-
16 counted for, during the preceding cal-
17 endar year, more than 3 percent of
18 export sales of a United States agri-
19 cultural commodity;

20 “(ii) regarding the effect on United
21 States agricultural commodities—

22 “(I) in the case of a current
23 sanction, the potential for export sales
24 of United States agricultural commod-

1 ities in the sanctioned country or
2 countries; and

3 “(II) in the case of a new sanc-
4 tion, the likelihood that exports of
5 United States agricultural commod-
6 ities will be affected by the new sanc-
7 tion or by retaliation by any country
8 to be sanctioned or likely to be sanc-
9 tioned, including a description of spe-
10 cific United States agricultural com-
11 modities that are most likely to be af-
12 fected;

13 “(iii) regarding the income of agricul-
14 tural producers—

15 “(I) in the case of a current
16 sanction, the potential for increasing
17 the income of producers of the United
18 States agricultural commodities in-
19 volved; and

20 “(II) in the case of a new sanc-
21 tion, the likely effect on incomes of
22 producers of the agricultural commod-
23 ities involved;

24 “(iv) regarding displacement of
25 United States suppliers—

1 “(I) in the case of a current
2 sanction, the potential for increased
3 competition for United States sup-
4 pliers of the agricultural commodity in
5 countries that are not subject to the
6 current sanction because of uncer-
7 tainty about the reliability of the
8 United States suppliers; and

9 “(II) in the case of a new sanc-
10 tion, the extent to which the new
11 sanction would permit foreign sup-
12 pliers to replace United States sup-
13 pliers; and

14 “(v) regarding the reputation of
15 United States agricultural producers as re-
16 liable suppliers—

17 “(I) in the case of a current
18 sanction, whether removing the sanc-
19 tion would improve the reputation of
20 United States producers as reliable
21 suppliers of agricultural commodities
22 in general, and of specific agricultural
23 commodities identified by the Sec-
24 retary; and

1 “(II) in the case of a new sanc-
2 tion, the likely effect of the proposed
3 sanction on the reputation of United
4 States producers as reliable suppliers
5 of agricultural commodities in general,
6 and of specific agricultural commod-
7 ities identified by the Secretary.

8 “(e) CONGRESSIONAL PRIORITY PROCEDURES.—

9 “(1) JOINT RESOLUTION.—In this subsection,
10 the term ‘joint resolution’ means only a joint resolu-
11 tion introduced within 10 session days of Congress
12 after the date on which the report of the President
13 under subsection (d) is received by Congress, the
14 matter after the resolving clause of which is as fol-
15 lows: ‘That Congress disapproves the report of the
16 President pursuant to section 418(d) of the Agricul-
17 tural Trade Act of 1978, transmitted on
18 _____.’, with the blank completed with
19 the appropriate date.

20 “(2) REFERRAL OF REPORT.—The report de-
21 scribed in subsection (d) shall be referred to the ap-
22 propriate committee or committees of the House of
23 Representatives and to the appropriate committee or
24 committees of the Senate.

25 “(3) REFERRAL OF JOINT RESOLUTION.—

1 “(A) IN GENERAL.—A joint resolution
2 shall be referred to the committees in each
3 House of Congress with jurisdiction.

4 “(B) REPORTING DATE.—A joint resolu-
5 tion referred to in subparagraph (A) may not
6 be reported before the eighth session day of
7 Congress after the introduction of the joint res-
8 olution.

9 “(4) DISCHARGE OF COMMITTEE.—If the com-
10 mittee to which is referred a joint resolution has not
11 reported the joint resolution (or an identical joint
12 resolution) at the end of 30 session days of Congress
13 after the date of introduction of the joint
14 resolution—

15 “(A) the committee shall be discharged
16 from further consideration of the joint resolu-
17 tion; and

18 “(B) the joint resolution shall be placed on
19 the appropriate calendar of the House con-
20 cerned.

21 “(5) FLOOR CONSIDERATION.—

22 “(A) MOTION TO PROCEED.—

23 “(i) IN GENERAL.—When the com-
24 mittee to which a joint resolution is re-
25 ferred has reported, or when a committee

1 is discharged under paragraph (4) from
2 further consideration of, a joint
3 resolution—

4 “(I) it shall be at any time there-
5 after in order (even though a previous
6 motion to the same effect has been
7 disagreed to) for any member of the
8 House concerned to move to proceed
9 to the consideration of the joint reso-
10 lution; and

11 “(II) all points of order against
12 the joint resolution (and against con-
13 sideration of the joint resolution) are
14 waived.

15 “(ii) PRIVILEGE.—The motion to pro-
16 ceed to the consideration of the joint
17 resolution—

18 “(I) shall be highly privileged in
19 the House of Representatives and
20 privileged in the Senate; and

21 “(II) shall not be debatable.

22 “(iii) AMENDMENTS AND MOTIONS
23 NOT IN ORDER.—The motion to proceed to
24 the consideration of the joint resolution
25 shall not be subject to—

1 “(I) amendment;

2 “(II) a motion to postpone; or

3 “(III) a motion to proceed to the
4 consideration of other business.

5 “(iv) MOTION TO RECONSIDER NOT IN
6 ORDER.—A motion to reconsider the vote
7 by which the motion is agreed to or dis-
8 agreed to shall not be in order.

9 “(v) BUSINESS UNTIL DISPOSITION.—
10 If a motion to proceed to the consideration
11 of the joint resolution is agreed to, the
12 joint resolution shall remain the unfinished
13 business of the House concerned until dis-
14 posed of.

15 “(B) LIMITATIONS ON DEBATE.—

16 “(i) IN GENERAL.—Debate on the
17 joint resolution, and on all debatable mo-
18 tions and appeals in connection with the
19 joint resolution, shall be limited to not
20 more than 10 hours, which shall be divided
21 equally between those favoring and those
22 opposing the joint resolution.

23 “(ii) FURTHER DEBATE LIMITA-
24 TIONS.—A motion to limit debate shall be
25 in order and shall not be debatable.

1 “(iii) AMENDMENTS AND MOTIONS
2 NOT IN ORDER.—An amendment to, a mo-
3 tion to postpone, a motion to proceed to
4 the consideration of other business, a mo-
5 tion to recommit the joint resolution, or a
6 motion to reconsider the vote by which the
7 joint resolution is agreed to or disagreed to
8 shall not be in order.

9 “(C) VOTE ON FINAL PASSAGE.—Imme-
10 diately following the conclusion of the debate on
11 a joint resolution, and a single quorum call at
12 the conclusion of the debate if requested in ac-
13 cordance with the rules of the House concerned,
14 the vote on final passage of the joint resolution
15 shall occur.

16 “(D) RULINGS OF THE CHAIR ON PROCE-
17 DURE.—An appeal from a decision of the Chair
18 relating to the application of the rules of the
19 Senate or House of Representatives, as the case
20 may be, to the procedure relating to a joint res-
21 olution shall be decided without debate.

22 “(6) COORDINATION WITH ACTION BY OTHER
23 HOUSE.—If, before the passage by one House of a
24 joint resolution of that House, that House receives

1 from the other House a joint resolution, the fol-
2 lowing procedures shall apply:

3 “(A) NO COMMITTEE REFERRAL.—The
4 joint resolution of the other House shall not be
5 referred to a committee.

6 “(B) FLOOR PROCEDURE.—With respect
7 to a joint resolution of the House receiving the
8 joint resolution—

9 “(i) the procedure in that House shall
10 be the same as if no joint resolution had
11 been received from the other House; but

12 “(ii) the vote on final passage shall be
13 on the joint resolution of the other House.

14 “(C) DISPOSITION OF JOINT RESOLUTIONS
15 OF RECEIVING HOUSE.—On disposition of the
16 joint resolution received from the other House,
17 it shall no longer be in order to consider the
18 joint resolution originated in the receiving
19 House.

20 “(7) PROCEDURES AFTER ACTION BY BOTH
21 THE HOUSE AND SENATE.—If a House receives a
22 joint resolution from the other House after the re-
23 ceiving House has disposed of a joint resolution
24 originated in that House, the action of the receiving
25 House with regard to the disposition of the joint res-

1 olution originated in that House shall be deemed to
2 be the action of the receiving House with regard to
3 the joint resolution originated in the other House.

4 “(8) RULEMAKING POWER.—This subsection is
5 enacted by Congress—

6 “(A) as an exercise of the rulemaking
7 power of the Senate and House of Representa-
8 tives, respectively, and as such this
9 subsection—

10 “(i) is deemed to be a part of the
11 rules of each House, respectively, but ap-
12 plicable only with respect to the procedure
13 to be followed in that House in the case of
14 a joint resolution; and

15 “(ii) supersedes other rules only to
16 the extent that this subsection is incon-
17 sistent with those rules; and

18 “(B) with full recognition of the constitu-
19 tional right of either House to change the rules
20 (so far as the rules relate to the procedure of
21 that House) at any time, in the same manner
22 and to the same extent as in the case of any
23 other rule of that House.”.

1 **SEC. 404. SALE OR BARTER OF FOOD ASSISTANCE.**

2 It is the sense of Congress that the amendments to
3 section 203 of the Agricultural Trade Development and
4 Assistance Act of 1954 (7 U.S.C. 1723) made by section
5 208 of the Federal Agriculture Improvement and Reform
6 Act of 1996 (Public Law 104–127; 110 Stat. 954) were
7 intended to allow the sale or barter of United States agri-
8 cultural commodities in connection with United States
9 food assistance only within the recipient country or coun-
10 tries adjacent to the recipient country, unless—

11 (1) the sale or barter within the recipient coun-
12 try or adjacent countries is not practicable; and

13 (2) the sale or barter within countries other
14 than the recipient country or adjacent countries will
15 not disrupt commercial markets for the agricultural
16 commodity involved.
