A BILL

To amend title 38, United States Code, to improve programs for homeless veterans, and for other purposes.

7 SEC. 2. FINDINGS: DEFINITIONS.

- 8 (a) FINDINGS.—Congress makes the following find-
- 9 ings:
- 10 (1) On the field of battle, the members of the
- 11 Armed Forces who defend the Nation are honor-
- bound to leave no one behind and, likewise, the Na-
- tion is honor-bound to leave no veteran behind.
- 14 (2) The Department of Veterans Affairs report
- 15 known as the Community Homeless Assessment,
- 16 Local Education, and Networking Groups for Vet-

- erans (CHALENG) assessment, issued in May 2000, reports that during 1999 there were an estimated 344,983 homeless veterans, an increase of 34 percent above the 1998 estimate of 256,872 homeless veterans.
 - (3) Male veterans are more likely to be homeless than their nonveteran peers. Although veterans constitute only 13 percent of the general male population, 23 percent of the homeless male population are veterans.
 - (4) Homelessness among veterans is persistent despite unprecedented economic growth and job ereation and general prosperity.
 - (5) While there are many effective programs that assist homeless veterans to again become productive and self-sufficient members of society, current resources provided to such programs and other activities that assist homeless veterans are inadequate to provide all needed essential services, assistance, and support to homeless veterans.
 - (6) If current programs to assist homeless veterans are fully maintained but not expanded, veterans will experience as many as a billion nights of homelessness during the next decade.

1	(7) The CHALENG assessment referred to in
2	paragraph (2) reports—
3	(A) that Department of Veterans Affairs
4	and community providers were responsible for
5	establishing almost 500 beds for homeless vet-
6	erans during 2000, including emergency, transi-
7	tional, and permanent beds; and
8	(B) that there is a need for about 45,724
9	additional beds to meet current needs of home-
10	less veterans.
11	(8) As of February 28, 2001, the Congressional
12	Budget Office forecasts a Federal budget surplus of
13	\$313,000,000,000 for fiscal year 2002 and budget
14	surpluses totaling more than \$5,610,000,000,000
15	over the next 10 years.
16	(9) At least \$750,000,000 will be required to
17	establish the 45,724 additional new beds now needed
18	by homeless veterans, according to an informal De-
19	partment of Veterans Affairs cost estimate.
20	(10) Even if the Department of Veterans Af-
21	fairs and its partners created 2,000 additional beds
22	per year for homeless veterans (roughly quadrupling
23	the number of such beds they currently plan to open
24	annually), it would still take more than two decades

1	to provide the necessary additional beds to meet the
2	current needs of homeless veterans.
3	(11) Nearly four decades ago, the Nation estab-
4	lished a goal of sending a man to the moon and re-
5	turning him safely to earth within a decade and ac-
6	complished that goal, and the Nation can do no less
7	to end homelessness among the Nation's veterans.
8	(b) DEFINITIONS.—For purposes of this Act:
9	(1) The term "homeless veteran" means a vet-
10	eran who—
11	(A) lacks a fixed, regular, and adequate
12	nighttime residence; or
13	(B) has a primary nighttime residence that
14	is
15	(i) a supervised publicly or privately
16	operated shelter designed to provide tem-
17	porary living accommodations (including
18	welfare hotels, congregate shelters, grant
19	per diem shelters and transitional housing
20	for the mentally ill);
21	(ii) an institution that provides a tem-
22	porary residence for individuals intended to
23	be institutionalized; or

1	(iii) a public or private place not de-
2	signed for, or ordinarily used as, a regular
3	sleeping accommodation for human beings.
4	(2) The term "grant and per diem provider"
5	means an entity in receipt of a grant under section
6	3 or 4 of the Homeless Veterans Comprehensive
7	Service Programs Act of 1992 (38 U.S.C. 7721
8	note).
9	SEC. 3. NATIONAL GOAL TO END HOMELESSNESS AMONG
10	VETERANS.
11	(a) National Goal.—Congress hereby declares it to
12	be a national goal to end homelessness among veterans
13	within a decade.
14	(b) Cooperative Efforts Encouraged.—Con-
15	gress hereby encourages all departments and agencies of
16	Federal, State, and local governments, quasi-governmental
17	organizations, private and public sector entities, including
18	community-based organizations, and individuals to work
19	cooperatively to end homelessness among veterans within
20	a decade.
21	SEC. 4. ADVISORY COMMITTEE ON HOMELESS VETERANS.
22	(a) In General.—Chapter 5 of title 38, United
23	States Code, is amended by adding at the end the fol-
	lowing new section:

1	*\$546. Advisory Committee on Homeless Veterans
2	"(a)(1) There is established in the Department the
3	Advisory Committee on Homeless Veterans (hereinafter in
4	this section referred to as the 'Committee').
5	"(2) The Committee shall consist of not more than
6	15 members appointed by the Secretary from among the
7	following:
8	"(A) Veterans service organizations.
9	"(B) Advocates of homeless veterans and other
10	homeless individuals.
11	"(C) Community-based providers of services to
12	homeless individuals.
13	"(D) Previously homeless veterans.
14	"(E) State veterans affairs officials.
15	"(F) Experts in the treatment of individuals
16	with mental illness.
17	"(G) Experts in the treatment of substance use
18	disorders.
19	"(H) Experts in the development of permanent
20	housing alternatives for lower income populations.
21	"(I) Experts in vocational rehabilitation.
22	"(J) Such other organizations or groups as the
23	Secretary considers appropriate.
24	"(3) The Committee shall include, as ex officie

25 members—

1	"(A) the Secretary of Labor (or a representa-
2	tive of the Secretary selected after consultation with
3	the Assistant Secretary of Labor for Veterans' Em-
4	ployment and Training);
5	"(B) the Secretary of Defense (or a representa-
6	tive of the Secretary);
7	"(C) the Secretary of Health and Human Serv-
8	ices (or a representative of the Secretary); and
9	"(D) the Secretary of Housing and Urban De-
10	velopment (or a representative of the Secretary).
11	"(4) The Secretary shall determine the terms of serv-
12	ice and pay and allowances of the members of the Com-
13	mittee, except that a term of service may not exceed three
14	years. The Secretary may reappoint any member for addi-
15	tional terms of service.
16	"(b)(1) The Secretary shall, on a regular basis, con-
17	sult with and seek the advice of the Committee with re-
18	spect to the provision by the Department of benefits and
19	services to homeless veterans.
20	"(2)(A) In providing advice to the Secretary under
21	this subsection, the Committee shall—
22	"(i) assemble and review information relating to
23	the needs of homeless veterans;
24	"(ii) provide an on-going assessment of the ef-
25	fectiveness of the policies, organizational structures,

1	and services of the Department in assisting homeless
2	veterans; and
3	"(iii) provide on-going advice on the most ap-
4	propriate means of providing assistance to homeless
5	veterans.
6	"(3) The Committee shall—
7	"(A) review the continuum of services provided
8	by the Department directly or by contract in order
9	to define cross-cutting issues and to improve coordi
10	nation of all services in the Department that address
11	the special needs of homeless veterans;
12	"(B) identify (through the annual assessments
13	under section 1774 of this title and other available
14	resources) gaps in programs of the Department in
15	serving homeless veterans, including identification of
16	geographic areas with unmet needs, and provide rec
17	ommendations to address those program gaps;
18	"(C) identify gaps in existing information sys
19	tems on homeless veterans, both within and outside
20	the Department, and provide recommendations
21	about redressing problems in data collection;
22	"(D) identify barriers under existing laws and
23	policies to effective coordination by the Department
24	with other Federal agencies and with State and loca
25	agencies addressing homeless populations;

1	"(E) identify opportunities for enhanced liaison
2	by the Department with nongovernmental organiza-
3	tions and individual groups addressing homeless
4	populations;
5	"(F) with appropriate officials of the Depart-
6	ment designated by the Secretary, participate with
7	the Interagency Council on the Homeless under title
8	H of the McKinney-Vento Homeless Assistance Act
9	(42 U.S.C. 11311 et seq.);
10	"(G) recommend appropriate funding levels for
11	specialized programs for homeless veterans provided
12	or funded by the Department;
13	"(H) recommend appropriate placement options
14	for veterans who, because of advanced age, frailty,
15	or severe mental illness, may not be appropriate can-
16	didates for vocational rehabilitation or independent
17	living; and
18	"(I) perform such other functions as the Sec-
19	retary may direct.
20	"(e)(1) Not later than March 31 of each year, the
21	Committee shall submit to the Secretary a report on the
22	programs and activities of the Department that relate to
23	homeless veterans. Each such report shall include—
24	"(A) an assessment of the needs of homeless
25	veterans:

1	"(B) a review of the programs and activities of
2	the Department designed to meet such needs;
3	"(C) a review of the activities of the Committee;
4	and
5	"(D) such recommendations (including rec-
6	ommendations for administrative and legislative ac-
7	tion) as the Committee considers appropriate.
8	"(2) Not later than 90 days after the receipt of a
9	report under paragraph (1), the Secretary shall transmit
10	to the Committees on Veterans' Affairs of the Senate and
11	House of Representatives a copy of the report, together
12	with any comments and recommendations concerning the
13	report that the Secretary considers appropriate.
14	"(3) The Committee may also submit to the Sec-

- 8 SEC. 5. MEETINGS OF INTERAGENCY COUNCIL ON THE
- 9 **HOMELESS.**
- 10 Section 202(c) of the McKinney-Vento Homeless As-
- 11 sistance Act (42 U.S.C. 11312(c)) is amended to read as
- 12 follows:
- 13 "(e) MEETINGS.—The Council shall meet at the eall
- 14 of its Chairperson or a majority of its members, but not
- 15 less often than annually.".
- 16 SEC. 6. EVALUATION OF HOMELESS PROGRAMS.
- 17 (a) EVALUATION CENTERS.—The Secretary of Vet-
- 18 erans Affairs shall support the continuation within the De-
- 19 partment of Veterans Affairs of at least one center for
- 20 evaluation to monitor the structure, process, and outcome
- 21 of programs of the Department of Veterans Affairs that
- 22 address homeless veterans.
- 23 (b) Annual Report on Health Care.—The Sec-
- 24 retary shall submit to Congress on an annual basis a re-
- 25 port on programs of the Department of Veterans Affairs

1	addressing health care needs of homeless veterans. The
2	Secretary shall include in each such report the following:
3	(1) Information about expenditures, costs, and
4	workload under the Department of Veterans Affairs
5	program known as the Health Care for Homeless
6	Veterans program (HCHV).
7	(2) Information about the veterans contacted
8	through that program.
9	(3) Information about processes under that pro-
10	gram.
11	(4) Information about program treatment out-
12	comes under that program.
13	(5) Information about supported housing pro-
14	grams.
15	(6) Information about the Department's grant
16	and per diem provider program.
17	(7) Other information the Secretary considers
18	relevant in assessing the program.
19	(c) Annual Program Assessment.—Section
20	1774(b) of title 38, United States Code, is amended—
21	(1) in paragraph (1), by inserting "annual"
22	after "to make an"; and
23	(2) by adding at the end the following new
24	paragraph:

1	"(6) The Secretary shall review each annual assess-
2	ment under this subsection, and shall consolidate the find-
3	ings and conclusions of those assessments into an annual
4	report which the Secretary shall submit to Congress.".
5	SEC. 7. CHANGES IN VETERANS EQUITABLE RESOURCE AL
6	LOCATION METHODOLOGY.
7	(a) Allocation Categories.—The Secretary of
8	Veterans Affairs shall assign veterans receiving the fol-
9	lowing services to the resource allocation eategory des-
10	ignated as "complex care" within the Veterans Equitable
11	Resource Allocation system:
12	(1) Care provided to veterans enrolled in the
13	Department of Veterans Affairs program for Menta
14	Health Intensive Community Case Management.
15	(2) Continuous care in homeless chronically
16	mentally ill veterans programs.
17	(3) Continuous care within specialized pro-
18	grams provided to veterans who have been diagnosed
19	with both serious chronic mental illness and sub-
20	stance use disorders.
21	(4) Continuous therapy combined with sheltered
22	housing provided to veterans in specialized treat-
23	mont for substance use disorders

1	(5) Specialized therapies provided to veterans
2	with post-traumatic stress disorders (PTSD), includ-
3	ing therapies provided by or under the following:
4	(A) Specialized outpatient PTSD pro-
5	grams.
6	(B) PTSD elinical teams.
7	(C) Women veterans stress disorder treat-
8	ment teams.
9	(D) Substance abuse disorder PTSD
10	teams.
11	(b) Treatment of Funds for New Programs
12	FOR HOMELESS VETERANS.—The Secretary shall ensure
13	that funds for any new program for homeless veterans car-
14	ried out through a Department health care facility are des-
15	ignated for the first three years of operation of that pro-
16	gram as a special purpose program for which funds are
17	not allocated through the Veterans Equitable Resource Al-
18	location system.
19	SEC. 8. PER DIEM PAYMENTS FOR FURNISHING SERVICES
20	TO HOMELESS VETERANS.
21	(a) Increase in Rate of Per Diem Payments.—
22	Section 4(a) of the Homeless Veterans Comprehensive
23	Service Programs Act of 1992 (38 U.S.C. 7721 note) is
24	amended by striking "at such rates" and all that follows
25	through "homeless veteran—" and inserting the following:

1	"at the same rates as the rates authorized for State homes
2	for domiciliary care provided under section 1741 of title
3	38, United States Code, for services furnished to homeless
4	veterans—".
5	(b) EFFECTIVE DATE.—The amendment made by
6	subsection (a) shall take effect on the first day of the first
7	fiscal year beginning after the date of the enactment of
8	this Act.
9	SEC. 9. GRANT PROGRAM FOR HOMELESS VETERANS WITH
10	SPECIAL NEEDS.
11	(a) Establishment.—The Secretary of Veterans
12	Affairs shall carry out a program to make grants to health
13	eare facilities of the Department of Veterans Affairs and
14	to grant and per diem providers in order to encourage de-
15	velopment by those facilities and providers of programs
16	targeted at meeting special needs within the population
17	of homeless veterans.
18	(b) Homeless Veterans With Special Needs.—
19	For purposes of this section, homeless veterans with spe-
20	eial needs include homeless veterans who—
21	(1) are women;
22	(2) are 50 years of age or older;
23	(3) are substance abusers;
24	(4) are persons with post-traumatic stress dis-

order;

1	(5) are terminally ill;
2	(6) are chronically mentally ill; or
3	(7) have eare of minor dependents or other
4	family members.
5	(c) STUDY OF OUTCOME EFFECTIVENESS.—The Sec-
6	retary shall conduct a study of the effectiveness of the
7	grant program in meeting the needs of homeless veterans.
8	As part of the study, the Secretary shall compare the re-
9	sults of programs carried out in the grant program under
10	this section in terms of veterans' satisfaction, health sta-
11	tus, reduction in addiction severity, housing, and encour-
12	agement of productive activity with results for similar vet-
13	erans in programs of the Department or of grant and per
14	diem providers that are designed to meet the general needs
15	of homeless veterans.
16	(d) Funding.—From amounts appropriated to the
17	Department of Veterans Affairs for "Medical Care" for
18	each of fiscal years 2003, 2004, and 2005, \$5,000,000
19	shall be available for purposes of the program under this
20	section. Grants under this section to a health care facility
21	of the Department or a grant and per diem provider shall
22	be treated in the manner provided in section 7(b).

1	SEC. 10. COORDINATION OF OUTREACH SERVICES FOR
2	VETERANS AT RISK OF HOMELESSNESS.
3	(a) Outreach Plan.—The Secretary of Veterans
4	Affairs, acting through the Under Secretary for Health,
5	shall provide for appropriate officials of the Mental Health
6	Service and the Readjustment Counseling Service of the
7	Veterans Health Administration to initiate a coordinated
8	plan for joint outreach to veterans at risk of homelessness,
9	including particularly veterans who are being discharged
10	from institutions (including discharges from inpatient psy-
11	chiatric care, substance abuse treatment programs, and
12	penal institutions).
13	(b) MATTERS TO BE INCLUDED.—The plan under
14	subsection (a) shall include the following:
15	(1) Strategies to identify and collaborate with
16	external entities used by veterans who have not tra-
17	ditionally used Department of Veterans Affairs serv-
18	ices to further outreach efforts.
19	(2) Strategies to ensure that mentoring pro-
20	grams, recovery support groups, and other appro-
21	priate support networks are optimally available to
22	veterans.
23	(3) Appropriate programs or referrals to family
24	support programs.
25	(4) Means to increase access to ease manage-
26	ment services.

1	(5)	Plans	for	making	additional	employment

- 3 (6) Appropriate referral sources for mental
 4 health and substance abuse services.
- 5 (e) Cooperative Relationships.—The plan under
- 6 subsection (a) shall identify strategies for the Department
- 7 to enter into formal cooperative relationships with entities
- 8 outside the Department of Veterans Affairs to facilitate
- 9 making services and resources optimally available to vet-
- 10 erans.
- 11 (d) REVIEW OF PLAN.—The Secretary shall submit
- 12 the plan under subsection (a) to the Advisory Committee
- 13 on Homeless Veterans for its review and consultation.
- 14 (e) Submission of Report.—Not later than two
- 15 years after the date of the enactment of this Act, the Sec-
- 16 retary shall submit to the Committees on Veterans' Affairs
- 17 of the Senate and House of Representatives a report on
- 18 the Secretary's plan under subsection (a), including goals
- 19 and timelines for implementation of the plan for particular
- 20 facilities and service networks.
- 21 (f) Outreach Program.—(1) The Secretary shall
- 22 earry out an outreach program to provide information to
- 23 homeless veterans and veterans at risk of homelessness.
- 24 The program shall include at a minimum—

1	(A) provision of information about benefits
2	available to eligible veterans from the Department;
3	and
4	(B) contact information for local Department
5	facilities, including medical facilities, regional offices,
6	and veterans centers.
7	(2) In developing and carrying out the program under
8	paragraph (1), the Secretary shall, to the extent prac-
9	ticable, consult with appropriate public and private organi-
10	zations, including the Bureau of Prisons, State social serv-
11	ice agencies, the Department of Defense, and mental
12	health, veterans, and homeless advocates—
13	(A) for assistance in identifying and contacting
14	veterans who are homeless or at risk of homeless-
15	ness;
16	(B) to coordinate appropriate outreach activi-
17	ties with those organizations; and
18	(C) to coordinate services provided to veterans
19	with services provided by those organizations.
20	SEC. 11. TREATMENT TRIALS IN INTEGRATED MENTAL
21	HEALTH SERVICES DELIVERY.
22	(a) Establishment.—The Secretary of Veterans
23	Affairs shall carry out two treatment trials in integrated
24	mental health services delivery. Each such trial shall be
25	carried out at a Department of Veterans Affairs medical

1	center selected by the Secretary for such purpose. The
2	trials shall each be earried out over the same one-year pe-
3	riod.
4	(b) DEFINITION.—For purposes of this section, the
5	term "integrated mental health services delivery" means
6	a coordinated and standardized approach to evaluation be-
7	tween mental health and primary health care professionals
8	for enrollment, treatment, and followup of patients who
9	have both mental health disorders (including substance
10	use disorders) and medical conditions.
11	(c) SITE SELECTION CRITERIA.—In reviewing appli-
12	eations from Department medical centers for selection as
13	a site for a treatment trial under this section, the Sec-
14	retary shall consider models that use the following:
15	(1) Standardized criteria for admission and en-
16	rollment as participant or control.

- 17 (2) Focus on prevention and symptom reduc-
- 19 (3) Development of a comprehensive, integrated
 20 treatment plan.
- 21 (4) Patient assignment to a team or teams.
- 22 (5) Management of polypharmacy.
- 23 (6) Use of evidence-based treatment protocols.
- 24 (7) Case management between visits.

tion.

1	(8) Referral and coordination of appropriate
2	Department or community-based services (including
3	housing if necessary).

- (9) Ability to maintain and provide outcomes for comparison purposes on veterans with similar diagnoses and characteristics who are not included in the trial, but who are receiving traditional consultative services in the same facility.
- 9 (d) TREATMENT MODELS TO BE TESTED.—The two
 10 treatment trials shall each use one of the following models:
- 11 (1) Mental health primary care teams.
- 12 (2) Patient assignment to a mental health pri-13 mary care team that is linked with the patient's 14 medical primary care team.
- (e) STUDY OF EFFECTIVENESS.—The Secretary shall compare treatment outcomes (including such outcomes as veterans' satisfaction, health status, treatment compliance, patient functionality, reduction in addiction severity as well as service utilization and treatment costs) of the different treatment trials for chronically mentally ill veterans who are provided treatment through integrated mental health programs with treatment outcomes for similar chronically mentally ill veterans provided treatment through traditionally consultative relationships.

- 1 (f) RESULTS.—Not later than 30 months after selec-
- 2 tion of the two centers under this section, each selected

- 7 ment of Veterans Affairs Medical Inspector General shall

 1998 estimate of 256,872 homeless veterans.
 - (3) The 1996 National Survey of Homeless Assistance Providers and Clients found that, although veterans constitute only 13 percent of the adult population, veterans comprise 23 percent of homeless clients.
 - (4) Homelessness among veterans is persistent despite unprecedented economic growth and job creation and general prosperity.
 - (5) While there are many effective programs that assist homeless veterans to again become productive and self-sufficient members of society, current resources provided to such programs and other activities that assist homeless veterans are inadequate to provide all needed essential services, assistance, and support to homeless veterans.
 - (6) The CHALENG assessment referred to in paragraph (2) reports—
 - (A) that Department of Veterans Affairs and community providers were responsible for establishing almost 500 beds for homeless veterans during 2000, including emergency, transitional, and permanent beds; and

1	(B) that there is a need for about 45,724
2	additional beds to meet current needs of homeless
3	veterans.
4	(7) Nearly four decades ago, the Nation estab-
5	lished a goal of sending a man to the moon and re-
6	turning him safely to earth within a decade and ac-
7	complished that goal, and the Nation can do no less
8	to end homelessness among the Nation's veterans.
9	(b) Homeless Veteran Defined.—In this Act, the
10	term 'homeless veteran' means a veteran who is homeless
