A BILL

To amend title 49, United States Code, to require phased increases in the fuel efficiency standards applicable to light trucks; to required fuel economy standards for automobiles up to 10,000 pounds gross vehicle weight; to raise the fuel economy of the Federal fleet of vehicles, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Automobile Fuel Econ-
5 omy Act of 2001”.

1 **SEC. 2. INCREASED AVERAGE FUEL ECONOMY STANDARD**
2 **FOR LIGHT TRUCKS.**

3 (a) DEFINITION OF LIGHT TRUCK.—Section
4 32901(a) of title 49, United States Code, is amended by
5 adding at the end the following new paragraph:

6 “(17) ‘light truck’ has the meaning given that
7 term in regulations prescribed by the Secretary of
8 Transportation in the administration of this chap-
9 ter.”.

10 (b) REQUIREMENT FOR INCREASED STANDARD.—
11 Section 32902(a) of title 49, United States Code, is
12 amended—

13 (1) by inserting “(1)” after
14 “AUTOMOBILES.—”;

15 (2) by inserting before the period at the end of
16 the third sentence the following: “, subject to para-
17 graph (2)”; and

18 (3) by adding at the end the following new
19 paragraph:

20 “(2) The average fuel economy standard for light
21 trucks manufactured by a manufacturer may not be less
22 than 27.5 miles per gallon, except that the average fuel
23 economy standard for—

24 “(A) light trucks manufactured by a manufac-
25 turer in a model year after model year 2002 and be-

1 fore model year 2005 may not be less than 22.5
 2 miles per gallon; and

3 “(B) light trucks manufactured by a manufac-
 4 turer in a model year after model year 2004 and be-
 5 fore model year 2007 may not be less than 25 miles
 6 per gallon.”.

7 (c) APPLICABILITY.—Paragraph (2) of section
 8 32902(a) of such title does not apply with respect to light
 9 trucks manufactured before model year 2003.

10 **SEC. 3. FUEL ECONOMY STANDARDS FOR AUTOMOBILES UP**
 11 **TO 10,000 POUNDS GROSS VEHICLE WEIGHT.**

12 (a) VEHICLES DEFINED AS AUTOMOBILES.—Section
 13 32901(a)(3) of title 49, United States Code, is amended
 14 by striking “is rated at—” and all that follows through
 15 the end and inserting “is rated at not more than 10,000
 16 pounds gross vehicle weight.”.

17 (b) EFFECTIVE DATE.—The amendment made by
 18 subsection (a) shall take effect on January 1, 2007.

19 **SEC. 4. FUEL ECONOMY OF THE FEDERAL FLEET OF VEHI-**
 20 **CLES.**

21 (a) BASELINE AVERAGE FUEL ECONOMY.—The head
 22 of each executive agency shall determine, for each class
 23 of vehicles that are in the agency’s fleet of vehicles in fiscal
 24 year 2001, the average fuel economy for all of the vehicles
 25 in that class that are in the agency’s fleet of vehicles for

1 that fiscal year. For the purposes of this section, the aver-
 2 age fuel economy so determined for the agency's vehicles
 3 in a class of vehicles shall be the baseline average fuel
 4 economy for the agency's fleet of vehicles in that class.

5 (b) INCREASE OF AVERAGE FUEL ECONOMY.—The
 6 head of an executive agency shall manage the procurement
 7 of vehicles in each class of vehicles for that agency in such
 8 a manner that—

9 (1) not later than September 30, 2003, the av-
 10 erage fuel economy of the new vehicles in the agen-
 11 cy's fleet of vehicles in each class of vehicles is not
 12 less than 3 miles per gallon higher than the baseline
 13 average fuel economy determined for that class; and

14 (2) not later than September 30, 2005, the av-
 15 erage fuel economy of the new vehicles in the agen-
 16 cy's fleet of vehicles in each class of vehicles is not
 17 less than 6 miles per gallon higher than the baseline
 18 average fuel economy determined for that class.

19 (c) CALCULATION OF AVERAGE FUEL ECONOMY.—
 20 Average fuel economy shall be calculated for the purposes
 21 of this section in accordance with guidance which the Sec-
 22 retary of Transportation shall prescribe for the implemen-
 23 tation of this section.

24 (d) DEFINITIONS.—In this section:

1 (1) The term “class of vehicles” means a class
2 of vehicles for which an average fuel economy stand-
3 ard is in effect under chapter 329 of title 49, United
4 States Code.

5 (2) The term “executive agency” has the mean-
6 ing given the term in section 4(1) of the Office of
7 Federal Procurement Policy Act (41 U.S.C. 403(1)).

8 (3) The term “new vehicle”, with respect to the
9 fleet of vehicles of an executive agency, means a ve-
10 hicle procured by or for the agency after September
11 30, 2002.
