6	(a) REPORTING A RECESSION.—If the budget and				
7	7 economic outlook update report provided pursuant to see				
8	tion 202(e)(2) of the Congressional Budget Act of 1974				
9	estimates that there will be 2 consecutive quarters of nega-				
10	tive economic growth in the current quarter and the next				
11	2 quarters, the chairman of the Committees on the Budget				
12	of the Senate or the House of Representatives, as applica-				
13	ble, may make the adjustments provided in subsection (b).				
14	(b) Adjustments.—The chairman of the Committee				
15	on the Budget of the Senate or House of Representatives,				
16	as applicable, may—				
17	(1) reduce the on-budget revenue aggregate by

1	SEC. 202. RESERVE FUND FOR TAX CUTS IN THE EVENT OF
2	A SURPLUS.
3	(a) Reporting a Surplus.—If the budget and eco-
4	nomic outlook update report provided pursuant to section
5	202(e)(2) of the Congressional Budget Act of 1974 esti-
6	mates that the gross Federal debt for the budget year will
7	be reduced, the chairman of the Committees on the Budg-
8	et of the Senate or the House of Representatives, as appli-
9	cable, may make the adjustments provided in subsection
10	(b).
11	(b) Adjustments.—The chairman of the Committee
12	on the Budget of the Senate or House of Representatives,
13	as applicable, may—
14	(1) reduce the on-budget revenue aggregate by
15	an amount equal to the amount of the reduction de-
16	termined as provided in subsection (a); and
17	(2) direct the chairman of the Committee on
18	Finance or the Committee on Ways and Means, as
19	applicable, to report by a date certain a reconcili-
20	ation bill reducing revenues by the amount of that
21	reduction.
22	SEC. 203. EXERCISE OF RULEMAKING POWERS.
23	Congress adopts the provisions of this title—
24	(1) as an exercise of the rulemaking power of
25	the Senate and the House of Representatives, re-
26	spectively, and as such they shall be considered as

- part of the rules of each House, or of that House to which they specifically apply, and such rules shall supersede other rules only to the extent that they are inconsistent therewith; and
- (2) with full recognition of the constitutional right of either House to change those rules (so far as they relate to that House) at any time, in the same manner, and to the same extent as in the case of any other rule of that House.
