Amending title 36, United States Code, to designate September 11 as Patriot Day.

Mr. HATCH (for himself, Mr. SCHUMER, and Mr. SPECTER) introduced the following joint resolution; which was read twice and referred to the Committee on the Judiciary

## **JOINT RESOLUTION**

Amending title 36, United States Code, to designate September 11 as Patriot Day.

Whereas on September 11, 2001, terrorists hijacked 4 civilian aircraft, crashing 2 of them into the towers of the World Trade Center in New York City, and a third into the Pentagon outside Washington, D.C.;

Whereas the fourth hijacked aircraft crashed in southwestern Pennsylvania after passengers tried to take control of the aircraft in order to prevent the hijackers from crashing the aircraft into an important symbol of democracy and freedom;

Whereas these attacks were by far the deadliest terrorist attacks ever launched against the United States, killing thousands of innocent people; and

Whereas in the aftermath of the attacks, the people of the United States stood united in providing support for those in need: Now, therefore, be it

1       *Resolved by the Senate and House of Representatives*  
2       *of the United States of America in Congress assembled,*

3       **SECTION 1. DESIGNATION OF SEPTEMBER 11 AS PATRIOT**  
4                               **DAY.**

5       Chapter 1 of title 36, United States Code, is amended  
6 by adding at the end the following:

7       **“§ 144. Patriot Day**

8               “(a) DESIGNATION.—September 11 is Patriot Day.

9               “(b) PROCLAMATION.—The President is requested to  
10 issue each year a proclamation calling on—

11                       “(1) State and local governments and the peo-  
12 ple of the United States to observe Patriot Day with  
13 appropriate programs and activities;

14                       “(2) all departments, agencies, and instrumen-  
15 talities of the United States and interested organiza-  
16 tions and individuals to display the flag of the  
17 United States at halfstaff on Patriot Day in honor  
18 of the individuals who lost their lives as a result of  
19 the terrorist attacks against the United States that  
20 occurred on September 11, 2001; and

21                       “(3) the people of the United States to observe  
22 a moment of silence on Patriot Day in honor of the  
23 individuals who lost their lives as a result of the ter-

1       rorist attacks against the United States that oc-  
2       curred on September 11, 2001.”.

3 **SEC. 2. CONFORMING AMENDMENT.**

4       The table of contents for chapter 1 of title 36, United  
5 States Code, is amended by adding at the end the fol-  
6 lowing new item:

“144. Patriot Day.”.
