 9 *Republic of Macedonia Foreign Minister*

10 **(8)**Page 2, unnumbered line 15, after “and” the first  
 11 time it appears insert: *The Former Yugoslav Republic of*

12 **(9)**Page 2, unnumbered line 29, strike out all after  
 13 “Whereas” over to an including “Macedonia” in  
 14 unnumbered line 2 on page 3 and insert: *75 special forces*  
 15 *troops of Albania were sent to Iraq as part of the coalition*  
 16 *forces during Operation Iraqi Freedom, 29 special forces*  
 17 *troops of The Former Yugoslav Republic of Macedonia were*  
 18 *sent to Iraq as part of the postwar stabilization force, and*  
 19 *Albania, Croatia, and The Former Yugoslav Republic of*  
 20 *Macedonia*

Amend the title so as to read: “Concurrent resolution commending the signing of the United States-Adriatic Charter, a charter of partnership among the United

States, Albania, Croatia, and The Former Yugoslav Republic of Macedonia.”.
