A BILL

To amend the Lacey Act Amendments of 1981 to further the conservation of certain wildlife species.

1 *Be it enacted by the Senate and House of Representa-
2 tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Captive Wildlife Safety
5 Act”.*

6 **SEC. 2. DEFINITION OF PROHIBITED WILDLIFE SPECIES.**

7 *Section 2 of the Lacey Act Amendments of 1981 (16
8 U.S.C. 3371) is amended—*

9 *(1) by redesignating subsections (g) through (j)
10 as subsections (h) through (k), respectively; and*

11 *(2) by inserting after subsection (f) the following:*

12 “*(g) PROHIBITED WILDLIFE SPECIES.—The term
13 ‘prohibited wildlife species’ means any lion, tiger, leopard,
14 cheetah, jaguar, or cougar species, or any hybrid of a lion
15 species and tiger species.”.*

16 **SEC. 3. PROHIBITED ACTS.**

17 *(a) IN GENERAL.—Section 3 of the Lacey Act Amend-
18 ments of 1981 (16 U.S.C. 3372) is amended—*

19 *(1) in subsection (a)—*

1 “(2) PERSONS DESCRIBED.—A person is de-
2 scribed in this paragraph, if—

3 “(A) the person has expertise, knowledge,
4 and experience with respect to the care of that
5 species in captivity; and

6 “(B) the person—

7 “(i) is licensed and inspected by the
8 Animal and Plant Health Inspection Serv-
9 ice with respect to that species;

10 “(ii) is a State college, university, or
11 agency, State-licensed wildlife rehabilitator,
12 or State-licensed veterinarian;

13 “(iii) is an accredited wildlife sanc-
14 tuary that cares for prohibited wildlife spe-
15 cies; or

16 “(iv) has custody of the animal solely
17 for the purpose of transporting the animal
18 to a person described in this paragraph
19 with respect to the species.

20 “(3) REGULATIONS.—Not later than 180 days
21 after the date of enactment of this subsection, the Sec-
22 retary, in consultation with the heads of other rel-
23 evant Federal agencies, shall promulgate regulations
24 describing the persons described in paragraph (2).

1 “(4) STATE AUTHORITY.—Nothing in this sub-
2 section preempts or supersedes the authority of a
3 State to regulate wildlife species within that State.”.
4 (b) APPLICATION.—Section 3(a)(2)(C) of the Lacey Act
5 Amendments of 1981 (as added by subsection (a)(1)(A)(iii))
6 shall apply beginning on the effective date of regulations
7 promulgated under section 3(e)(3) of that Act (as added by
8 subsection (a)(2)).
