the amounts authorized to be appropriated for the
Department of Health and Human Services for fiscal years 2004, 2005, and 2006, there are author-

ized to be appropriated to carry out subsection (a) 2 (relating to assistance for domestic centers and programs for the treatment of victims of torture) 3 4 \$20,000,000 for fiscal year 2004, \$25,000,000 for fiscal year 2005, and \$30,000,000 for fiscal year 5 6 2006.". 7 (b) EFFECTIVE DATE.—The amendment made by 8 subsection (a) shall take effect October 1, 2003. 9 SEC. 3. AUTHORIZATION OF APPROPRIATIONS FOR FOR-10 EIGN TREATMENT CENTERS FOR VICTIMS OF 11 TORTURE. 12 (a) AUTHORIZATION OF APPROPRIATIONS.—Section 4(b)(1) of the Torture Victims Relief Act of 1998 (22) 13 14 U.S.C. 2152 note) is amended to read as follows: 15 "(1) Authorization of Appropriations.—Of 16 the amounts authorized to be appropriated for fiscal 17 years 2004, 2005, and 2006 pursuant to chapter 1 18 of part I of the Foreign Assistance Act of 1961, 19 there are authorized to be appropriated to the Presi-20 dent to carry out section 130 of such Act (relating 21 to assistance for centers in foreign countries and 22 programs for the treatment of victims of torture) 23 \$11,000,000 for fiscal year 2004, \$12,000,000 for 24 fiscal year 2005, and \$13,000,000 for fiscal year

7 Of the amounts authorized to be appropriated for fiscal years 2004, 2005, and 2006 pursuant to chapter 3 8 9 of part I of the Foreign Assistance Act of 1961, there are authorized to be appropriated to the President for a 10 11 voluntary contribution to the United Nations Voluntary 12 Fund for Victims of Torture \$6,000,000 for fiscal year 2004, \$7,000,000 for fiscal year 2005, and \$8,000,000 13 for fiscal year 2006. 14
