## A BILL

To make permanent the authority to waive restrictions on use of funds for threat reduction in States of the former Soviet Union and for a chemical weapons destruction facility in Russia.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Threat Reduction Im-  
5 plementation Act of 2003”.

1 **SEC. 2. PERMANENT WAIVER OF RESTRICTIONS ON USE OF**  
2 **FUNDS FOR THREAT REDUCTION IN STATES**  
3 **OF THE FORMER SOVIET UNION.**

4 Section 1306 of the Bob Stump National Defense  
5 Authorization Act for Fiscal Year 2003 (Public Law 107–  
6 314) is amended—

7 (1) in subsection (c), by striking “only with re-  
8 spect to fiscal years 2003, 2004, and 2005” and in-  
9 serting “with respect to fiscal year 2003 and each  
10 fiscal year thereafter”;

11 (2) by striking subsection (d); and

12 (3) by redesignating subsection (e) as sub-  
13 section (d).

14 **SEC. 3. PERMANENT WAIVER OF RESTRICTIONS ON USE OF**  
15 **FUNDS FOR CHEMICAL WEAPONS DESTRUC-**  
16 **TION.**

17 Section 8144 of the Department of Defense Appro-  
18 priations Act, 2003 (Public Law 107–248; 116 Stat.  
19 1571) is amended—

20 (1) by inserting “and any fiscal year there-  
21 after” after “2003”;

22 (2) by striking subsection (b); and

23 (3) by striking “(a)”.
