- 8 mittee, as well as the administrative and procedural guide-
- 9 lines for the operation of the Committee.
- 10 "(2) The two Departments shall supply appropriate
- 11 staff and resources to provide administrative support and
- 12 services. Support for such purposes shall be provided at
- 13 a level sufficient for the efficient operation of the Com-
- 14 mittee, including a subordinate Health Executive Com-
- 15 mittee, a subordinate Benefits Executive Committee, and
- 16 such other committees or working groups as considered
- 17 necessary by the Deputy Secretary and Under Secretary.
- 18 "(c) Recommendations.—(1) The Committee shall
- 19 recommend to the Secretaries strategic direction for the
- 20 joint coordination and sharing efforts between and within
- 21 the two Departments under section 8111 of this title and
- 22 shall oversee implementation of those efforts.
- "(2) The Committee shall submit to the two Secre-
- 24 taries and to Congress an annual report containing such
- 25 recommendations as the Committee considers appropriate.

- 1 "(d) Functions.—In order to enable the Committee 2 to make recommendations in its annual report under sub-3 section (c)(2), the Committee shall do the following:
- 4 "(1) Review existing policies, procedures, and 5 practices relating to the coordination and sharing of 6 resources between the two Departments.
 - "(2) Identify changes in policies, procedures, and practices that, in the judgment of the Committee, would promote mutually beneficial coordination, use, or exchange of use of services and resources of the two Departments, with the goal of improving the quality, efficiency and effectiveness of the delivery of benefits and services to veterans, service members, military retirees and their families through an enhanced Department of Veterans Affairs and Department of Defense partnership.
 - "(3) Identify and assess further opportunities for the coordination and collaboration between the Departments that, in the judgment of the Committee, would not adversely affect the range of services, the quality of care, or the established priorities for benefits provided by either Department.
 - "(4) Review the plans of both Departments for the acquisition of additional resources, especially new facilities and major equipment and technology,
