Mr. Collins introduced the following bill; which was referred to the Committee on International Relations

A BILL

To provide for the transfer of a Vietnam-era Cessna L—19D Bird Dog aircraft that is excess to the needs of the Department of State to Army Aviation Heritage Foundation.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. TRANSFER OF VIETNAM-ERA CESSNA L-19D
- 4 BIRD DOG AIRCRAFT TO ARMY AVIATION
- 5 HERITAGE FOUNDATION.
- 6 (a) AUTHORITY TO CONVEY.—The Secretary of
- 7 State may convey, without consideration, to the Army
- 8 Aviation Heritage Foundation, a nonprofit organization

- 1 incorporated in the State of Georgia, all right, title, and
- 2 interest of the United States in and to a Vietnam-era
- 3 Cessna L-19D Bird Dog aircraft (serial No. 24020, Na-
- 4 tional registration number N32FL) (in this section re-
- 5 ferred to as the "aircraft") that is excess to the needs
- 6 of the Department of State. The conveyance shall be made
- 7 by means of a conditional deed of gift
- 8 (b) CONDITION OF AIRCRAFT.—The aircraft shall be
- 9 conveyed in its current "as is" condition. The Secretary
- 10 is not required to repair or alter the condition of the air-
- 11 craft before conveying ownership of the aircraft.
- 12 (c) CONDITION ON CONVEYANCE.—The Secretary
- 13 shall include in the instrument of conveyance of the air-
- 14 craft the following conditions:
- 15 (1) The Army Aviation Heritage Foundation
- may not convey any ownership interest in, or trans-
- 17 fer possession of, the aircraft to any other party
- 18 without the prior approval of the Secretary.
- 19 (2) The Army Aviation Heritage Foundation
- shall operate and maintain the aircraft in compli-
- ance with all applicable limitations and maintenance
- requirements imposed by the Administrator of the
- Federal Aviation Administration.
- 24 (d) Reverter Upon Breach of Conditions.—If
- 25 the Secretary determines at any time that the Army Avia-

- 1 tion Heritage Foundation has conveyed an ownership in-
- 2 terest in, or transferred possession of, the aircraft to any
- 3 other party without the prior approval of the Secretary,
- 4 all right, title, and interest in and to the aircraft, including
- 5 any repair or alteration of the aircraft, shall revert to the
- 6 United States, and the United States shall have the right
- 7 of immediate possession of the aircraft.
- 8 (e) Conveyance at No Cost to the United
- 9 States.—The conveyance of the aircraft shall be made
- 10 at no cost to the United States. Any costs associated with
- 11 the conveyance and costs of operation and maintenance
- 12 of the aircraft conveyed shall be borne by the Army Avia-
- 13 tion Heritage Foundation.
- 14 (f) Additional Terms and Conditions.—The Sec-
- 15 retary may require such additional terms and conditions
- 16 in connection with a conveyance under this section as the
- 17 Secretary considers appropriate to protect the interests of
- 18 the United States.
- 19 (g) Clarification of Liability.—Notwithstanding
- 20 any other provision of law, upon the conveyance of owner-
- 21 ship of the aircraft to the Army Aviation Heritage Foun-
- 22 dation, the United States shall not be liable for any death,
- 23 injury, loss, or damage that results from any use of that
- 24 aircraft by any person other than the United States.
