- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

### 1 TITLE I—CASTILLO DE SAN

### 2 MARCOS NATIONAL MONU-

### 3 MENT PRESERVATION ACT

- 4 SEC. 101. SHORT TITLE.
- 5 This title may be cited as the "Castillo de San Marcos
- 6 National Monument Preservation and Education Act".

### 7 SEC. 102. VISITOR CENTER.

- 8 (a) AUTHORIZATION.—Subject to the availability of
- 9 appropriations and the project being prioritized in the Na-
- 10 tional Park Services 5-year, line-item construction pro-
- 11 gram, the Secretary of the Interior (referred to in this sec-
- 12 tion as the "Secretary") may design and construct a Vis-
- 13 itor Center for the Castillo de San Marcos National Monu-
- 14 ment (referred to in this section as the "Monument").
- 15 (b) Preferred Alternative.—The Visitor Center
- 16 authorized in subsection (a) shall be located and con-
- 17 structed in accordance with the Preferred Alternative
- 18 identified in the Record of Decision for the General Man-
- 19 agement Plan for the Monument, expected to be signed
- 20 in 2005.

### 21 SEC. 103. COOPERATIVE AGREEMENT.

- The Secretary may enter into cooperative agreements
- 23 with the City of St. Augustine, Florida, the Colonial St.
- 24 Augustine Preservation Foundation, other Federal, State,
- 25 and local departments or agencies, academic institutions,

- 1 and non-profit entities for the planning and design, con-
- 2 struction, management, and operation of the Visitor Cen-
- 3 ter.

### 4 SEC. 104. BOUNDARY EXPANSION.

- 5 (a) Property Acquisition.—If the Preferred Alter-
- 6 native for the Visitor Center authorized by section 102
- 7 is located outside the boundary of the Monument, the Sec-
- 8 retary is authorized to acquire the site for the Visitor Cen-
- 9 ter, from willing sellers, by donation, purchase with do-
- 10 nated or appropriated funds, or by exchange.
- 11 (b) Administration of Newly Acquired Land.—
- 12 Land added to the Monument pursuant to subsection (a)
- 13 shall be administered by the Secretary in accordance with
- 14 applicable laws and regulations.
- (c) BOUNDARY MODIFICATION.—The boundary of
- 16 the Monument shall be modified to reflect the acquisition
- 17 of land authorized in subsection (a) after completion of
- 18 the acquisition.

### 19 SEC. 105. PROJECT APPROVAL.

- 20 Prior to initiating any planning, design, or construc-
- 21 tion on the Visitor Center authorized by section 102, the
- 22 project must be reviewed and approved by the National
- 23 Park Service consistent with partnership construction
- 24 guidelines established by that agency.

### II—CASTILLO TITLE DE SAN **NATIONAL MONU-MARCOS** 2 MENT BOUNDARY MODIFICA-3 **TION**

5 SEC. 201. SHORT TITLE.

- 6 This title may be cited as the "Castillo de San Marcos
- National Monument Boundary Adjustment Act of 2004". 7
- 8 SEC. 202. FINDINGS.
- 9 Congress finds the following:
- 10 (1) The early defense lines for Fort Marion,
- 11 Florida, today known as the Castillo de San Marcos
- 12 National Monument, included defenses extending in
- 13 a line due west to the Sebastian River, a distance of
- 14 about one half mile.
- 15 (2) In the 1830's, during the Seminole Wars in
- 16 Florida, these defensive lines were maintained, but
- 17 as Florida became more settled they fell into dis-
- 18 repair and/or became obsolete.
- 19 (3) In 1908 the War Department deeded much
- 20 of the property running west to the Sebastian River
- 21 to the St. Johns County Board of Public Instruc-
- 22 tion. The portion of this property remaining in fed-
- 23 eral ownership today is occupied by Orange Street,
- 24 a City of St. Augustine, Florida street.

- 1 (4) For nearly a century, the City of St. Augus-2 tine has maintained and managed Orange Street, a 3 modern city street, and associated utilities in the Or-4 ange Street corridor.
- 5 (5) Any archeological remains that are still 6 present on the property overlaid by Orange Street 7 are adequately protected by the City's archeological 8 ordinances, and by the City having an archeologist 9 on staff.
- 10 (6) Although the city currently operates Orange 11 Street under a right-of-way from the National Park 12 Service, from a management perspective it is appro-13 priate for the City of St. Augustine to own Orange 14 Street.

### 15 SEC. 203. BOUNDARY ADJUSTMENT.

17 Interior shall convey, without consideration, to the City 18 of St. Augustine, Florida, all right, title, and interest of 19 the United States in and to the lands known as Orange 20 Street, a portion of the Castillo de San Marcos National 21 Monument (Monument), consisting of approximately 3.1 22 acres, as shown on the map entitled Castillo de San

(a) Conveyance of Land.—The Secretary of the

- 23 Marcos National Monument Boundary Adjustment and
- 24 Correction, numbered 343/80060, and dated April 2003.
- 25 Upon completion of the conveyance, the Secretary shall

- 1 revise the boundary of the Monument to exclude the land
- 2 conveyed.
- 3 (b) BOUNDARY REVISION.—Effective on the date of
- 4 the enactment of this Act, the boundary of the Monument
- 5 is revised to include an area of approximately 0.45 acres,
- 6 as shown on the map identified in subsection (a). The Sec-
- 7 retary shall administer the lands included in the boundary
- 8 as part of the national monument in accordance with ap-
- 9 plicable laws and regulations.
