To authorize funds for an educational center for the Castillo de San Marcos National Monument, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Castillo de San Marcos
- 5 National Monument Preservation and Education Act".
- 6 SEC. 2. EDUCATIONAL CENTER FOR THE CASTILLO DE SAN
- 7 MARCOS NATIONAL MONUMENT.
- 8 (a) Grants Authorized.—The Secretary is author-
- 9 ized to make grants to the City and the Foundation jointly
- 10 as follows:

| 19 | (A) Matching contributions for a dollar- |

| 21 | (B) The remainder of funds necessary to |

| 23 | (3) Conditions.—Except for the funds re- |
| 24 | quired under paragraph (2)(B), amounts required |
| 25 | under this subsection may be in the form of cash or |

| 21 | (2) CITY.—The term "City" means the City of |
