## A BILL

To provide for an adjustment of the boundaries of Mount Rainier National Park, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 *This Act may be cited as the “Mount Rainier National*  
3 *Park Boundary Adjustment Act of 2003”.*

4 **SEC. 2. FINDINGS.**

5 *The Congress finds the following:*

6 *(1) The Carbon River watershed within Pierce*  
7 *County in the State of Washington has unique quali-*  
8 *ties of ecological, economic, and educational impor-*  
9 *tance, including clean water, productive salmon*  
10 *streams, important wildlife habitat, active geologic*  
11 *processes, outdoor recreational opportunities, scenic*  
12 *beauty, educational opportunities, and diverse eco-*  
13 *nomic opportunities.*

14 *(2) Mount Rainier National Park is one of the*  
15 *premier attractions in the State of Washington, pro-*  
16 *viding recreational, educational, and economic oppor-*  
17 *tunities that will be enhanced by the construction of*  
18 *new campgrounds and visitor contact facilities in the*  
19 *Carbon River valley outside old-growth forest habitats*  
20 *and above the flood plain.*

21 *(3) Coordination of management across national*  
22 *forest and national park lands in this corridor will*  
23 *enhance the conservation of the forest ecosystem and*  
24 *public enjoyment of these public lands.*

25 *(4) Protection and development of historic and*  
26 *recreational facilities in the Carbon River valley, such*

1        *as trails and visitor centers, can be facilitated by the*  
2        *National Park Service.*

3        **SEC. 3. MOUNT RAINIER NATIONAL PARK BOUNDARY AD-**  
4        **JUSTMENT.**

5        (a) *BOUNDARY ADJUSTMENT.*—*The boundary of*  
6        *Mount Rainier National Park is modified to include the*  
7        *area within the boundary generally depicted on the map*  
8        *entitled “Mount Rainier National Park, Carbon River*  
9        *Boundary Adjustment”, numbered 105/92,002B, and dated*  
10       *June 2003. The Secretary of the Interior shall keep the map*  
11       *on file in the appropriate offices of the National Park Serv-*  
12       *ice.*

13       (b) *LAND ACQUISITION.*—*The Secretary of the Interior*  
14       *may acquire, only with the consent of the owner, by dona-*  
15       *tion, purchase with donated or appropriated funds, or ex-*  
16       *change—*

17                (1) *land or interests in land, totaling not more*  
18        *than 800 acres, and improvements thereon within the*  
19        *boundary generally depicted on the map referred to in*  
20        *subsection (a) for development of camping and other*  
21        *recreational facilities; and*

22                (2) *land or interests in land, totaling not more*  
23        *than one acre, and improvements thereon in the vi-*  
24        *cinity of Wilkeson, Washington, for a facility to serve*

1 *visitors to public lands along the Carbon and Mowich*  
2 *Corridors.*

3 *(c) ADMINISTRATION OF ACQUIRED LANDS.—Lands*  
4 *acquired under this section shall be administered by the*  
5 *Secretary of the Interior as part of Mount Rainier National*  
6 *Park in accordance with applicable laws and regulations.*

7 **SEC. 4. ASSOCIATED LANDS.**

8 *The Secretary of Agriculture shall manage that por-*  
9 *tion of the Mt. Baker-Snoqualmie National Forest lying ad-*  
10 *acent to Mt. Rainier National Park, as identified on the*  
11 *map referred to in section 3(a), to maintain the area's nat-*  
12 *ural setting in a manner consistent with its management*  
13 *as of June 1, 2003.*
