AN ACT

Making appropriations for the Legislative Branch for the fiscal year ending September 30, 2004, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 That the following sums are appropriated, out of any
4 money in the Treasury not otherwise appropriated, for the
5 fiscal year ending September 30, 2004, and for other pur-
6 poses, namely:

19 ADMINISTRATIVE PROVISIONS

20 *SECTION. 1. GROSS RATE OF COMPENSATION IN OF-*
 21 *FICES OF SENATORS. Effective on and after October 1, 2003,*
 22 *each of the dollar amounts contained in the table under sec-*
 23 *tion 105(d)(1)(A) of the Legislative Branch Appropriations*
 24 *Act, 1968 (2 U.S.C. 61-1(d)(1)(A)) shall be deemed to be*
 25 *the dollar amounts in that table, as adjusted by law and*

1 *in effect on September 30, 2003, increased by an additional*
2 *\$50,000 each.*

3 *SEC. 2. PAYMENT OF EXPENSES OF CONFERENCES OF*
4 *MAJORITY AND MINORITY. (a) IN GENERAL.—Section 120*
5 *of Public Law 97–51 (2 U.S.C. 61g–6) is amended in the*
6 *first sentence by striking “an amount, not in excess of*
7 *\$100,000,” and inserting “such amount as necessary”.*

8 *(b) EFFECTIVE DATE.—This section shall apply with*
9 *respect to fiscal year 2004, and each fiscal year thereafter.*

10 *SEC. 3. PROVISIONS RELATING TO SENATE COMMIS-*
11 *SION ON ART. (a) AUTHORITY TO ACQUIRE AND DIS-*
12 *POSE.—*

13 *(1) IN GENERAL.—The Senate Commission on*
14 *Art (referred to in this section as the “Commission”)*
15 *may—*

16 *(A) accept gifts of money; and*

17 *(B) acquire (by gift, purchase, or otherwise)*
18 *any work of art, historical object, document, or*
19 *material relating to historical matters, or ex-*
20 *hibit, for placement or exhibition in the Senate*
21 *Wing of the Capitol, the Senate Office Buildings,*
22 *or in rooms, spaces, or corridors thereof.*

23 *(2) ACCESSION OR DISPOSAL.—All works of art,*
24 *historical objects, documents, or material related to*
25 *historical matters, or exhibits, acquired by the Com-*

1 mission may, as determined by the Commission and
2 after consultation with the Curatorial Advisory
3 Board, be—

4 (A) retained for accession to the United
5 States Senate Collection or other use; or

6 (B) disposed of by sale or other transaction.

7 (3) REPEAL.—Senate Resolution 95, 92d Con-
8 gress, agreed to April 1, 1971, and enacted into law
9 by section 901(a) of Public Law 100–696 (2 U.S.C.
10 2106) is repealed.

11 (b) ADVISORY BOARDS.—

12 (1) CURATORIAL ADVISORY BOARD.—There is es-
13 tablished a Board which shall be chaired by the Sen-
14 ate Curator. The Curatorial Advisory Board shall
15 provide advice and assistance to the Commission on
16 the acquisition, care, and disposition of items for or
17 within the United States Senate Collection, and on
18 such other matters as the Commission determines ap-
19 propriate.

20 (2) ADDITIONAL ADVISORY BOARDS.—

21 (A) IN GENERAL.—The Commission, or the
22 chairman and vice chairman acting jointly on
23 behalf of the Commission and after giving notice
24 to the Commission, may establish 1 or more ad-
25 ditional advisory boards.

1 (B) *TERM.*—*The term of existence for an*
2 *additional advisory board—*

3 (i) *shall be specified by the Commis-*
4 *sion but no longer than 4 years; and*

5 (ii) *shall be renewable.*

6 (C) *PURPOSE.*—*The purpose of an addi-*
7 *tional advisory board shall be to provide advice*
8 *and assistance to the Commission and to further*
9 *the purposes of the Commission.*

10 (3) *APPOINTMENTS.*—

11 (A) *IN GENERAL.*—*Subject to subparagraph*
12 *(B), the Curatorial Advisory Board and other*
13 *advisory boards established by the Commission*
14 *under paragraph (2) shall be composed of mem-*
15 *bers appointed by the Commission, or the chair-*
16 *man and vice chairman acting jointly on behalf*
17 *of the Commission and after giving notice to the*
18 *Commission.*

19 (B) *APPLICABLE RULES.*—*Members ap-*
20 *pointed under subparagraph (A)—*

21 (i) *shall be appointed from public and*
22 *private life and shall serve at the pleasure*
23 *of the Commission; and*

24 (ii) *in the case of individuals ap-*
25 *pointed to the Curatorial Advisory Board,*

1 *shall be experts or have significant experi-*
2 *ence in the field of arts, historic preserva-*
3 *tion, or other appropriate fields.*

4 *Each member of the Commission may have ap-*
5 *pointed to an advisory board created by the*
6 *Commission at least 1 individual requested by*
7 *that member.*

8 (4) *MEMBERS.—A member of a board under this*
9 *subsection—*

10 (A) *may, at the discretion of the Commis-*
11 *sion, be reimbursed for actual and necessary ex-*
12 *penses incurred in the performance of the official*
13 *duties of the board from any funds available to*
14 *the Commission in accordance with applicable*
15 *Senate regulations for such expenses; and*

16 (B) *shall not, by virtue of such member's*
17 *service on the board, be deemed to be an officer,*
18 *employee, or agent of the Senate and may not*
19 *bind the Senate in any contract or obligation.*

20 (5) *TERMS FOR ADDITIONAL ADVISORY BOARD*
21 *MEMBERS.—Members appointed to the other advisory*
22 *boards created under paragraph (2) shall serve for*
23 *terms as stated in their appointment, but no longer*
24 *than a term of 4 years, except that any member may*
25 *be reappointed upon the expiration of their term.*

1 (6) *REGULATIONS.*—*The Commission, or the*
2 *chairman and vice chairman acting jointly on behalf*
3 *of the Commission and after giving notice to the Com-*
4 *mission, in consultation with the Committee on Rules*
5 *and Administration, may promulgate such regula-*
6 *tions governing advisory boards established under this*
7 *subsection as are necessary to carry out the purposes*
8 *of this subsection.*

9 (7) *ASSISTANCE.*—*The Executive Secretary of the*
10 *Commission shall provide assistance to an advisory*
11 *board as authorized by the Commission.*

12 (c) *ESTABLISHMENT OF SENATE PRESERVATION*
13 *FUND.*—

14 (1) *ESTABLISHMENT.*—*There is established in*
15 *the Treasury a fund, to be known as the “Senate*
16 *Preservation Fund” (in this section referred to as the*
17 *“fund”), which shall consist of amounts deposited and*
18 *credited under paragraph (3).*

19 (2) *PAYMENT OF COSTS.*—*The fund shall be*
20 *available to the Commission for the payment of acqui-*
21 *sition and transaction costs incurred for acquisitions*
22 *under subsection (a), for official activities of any ad-*
23 *visory board established under subsection (b), and for*
24 *any purposes for which funds from the contingent*

1 *fund of the Senate may be used under section 316(a)*
2 *of Public Law 101–302 (2 U.S.C. 2107).*

3 (3) *DEPOSITS, CREDITS, AND DISBURSEMENTS.—*

4 (A) *DEPOSITS.—The Commission shall de-*
5 *posit in the fund amounts appropriated for use*
6 *of the fund, gifts of money, and proceeds of*
7 *transactions under subsection (a).*

8 (B) *CREDITS.—The Secretary of the Treas-*
9 *ury shall credit to the fund the interest on, and*
10 *the proceeds from sale or redemption of, obliga-*
11 *tions held in the fund.*

12 (C) *DISBURSEMENTS.—Disbursements from*
13 *the fund shall be made on vouchers approved by*
14 *the Commission and signed by the Executive*
15 *Secretary of the Commission.*

16 (4) *INVESTMENTS.—*

17 (A) *IN GENERAL.—The Secretary of the*
18 *Treasury shall invest any portion of the fund*
19 *that, as determined by the Commission, is not*
20 *required to meet current withdrawals.*

21 (B) *TYPE OF OBLIGATION.—Each invest-*
22 *ment required by this paragraph shall be made*
23 *in an interest bearing obligation of the United*
24 *States or an obligation guaranteed as to the*
25 *principal and interest by the United States that,*

1 *as determined by the Commission, has a maturity*
2 *suitable for the fund.*

3 (C) *COMMISSION APPROVAL.*—*In carrying*
4 *out this subsection, the Secretary of the Treasury*
5 *may make such purchases, sales, and redemption*
6 *of obligations as may be approved by the Com-*
7 *mission.*

8 (5) *SERVICES AND SUPPORT.*—*The Library of*
9 *Congress shall provide financial management and*
10 *disbursing services and support to the Commission as*
11 *may be required and mutually agreed to by the Li-*
12 *brarian of Congress and the Executive Secretary of*
13 *the Commission.*

14 (6) *AUDITS.*—*The Comptroller General of the*
15 *United States shall conduct annual audits of the Sen-*
16 *ate Preservation Fund and shall report the results of*
17 *each audit to the Commission.*

18 (d) *ADMINISTRATIVE CHANGES.*—

19 (1) *SENATE COMMISSION ON ART.*—*Section 1 of*
20 *Senate Resolution 382, 90th Congress, agreed to Octo-*
21 *ber 1, 1968, and enacted into law by section 901(a)*
22 *of Public Law 100–696 (2 U.S.C. 2101) is amend-*
23 *ed—*

24 (A) *in subsection (b), by striking the first*
25 *sentence and inserting “The Majority Leader*

1 *and Minority Leader of the Senate shall be the*
2 *chairman and vice chairman, respectively, of the*
3 *Commission.”; and*

4 *(B) by striking subsection (c) and inserting*
5 *the following:*

6 *“(c) The Secretary of the Senate shall appoint a Sen-*
7 *ate Curator approved by the Senate Commission on Art.*
8 *The Senate Curator shall be an employee of the Secretary*
9 *of the Senate assigned to assist the Commission. The Sec-*
10 *retary of the Senate shall assign additional employees to*
11 *assist the Commission, and provide such other assistance,*
12 *as the Commission determines necessary.”.*

13 *(2) PURCHASE OF ART.—The first sentence of*
14 *section 316(a) of Public Law 101–302 (2 U.S.C.*
15 *2107(a)) is amended by inserting after “in which in-*
16 *curring,” the following: “for the purchase of art and*
17 *historical objects for the United States Senate Collec-*
18 *tion, for exhibits and public education relating to the*
19 *United States Senate Collection, for administrative*
20 *and transitional expenses of the Senate Commission*
21 *on Art, and”.*

22 *SEC. 4. ORIENTATION SEMINARS. The first sentence of*
23 *section 107(a) of the Supplemental Appropriations Act,*
24 *1979 (Public Law 96–38; 2 U.S.C. 69a) is amended by*
25 *striking “\$10,000” and inserting “\$25,000”.*

1 *SEC. 5. EXPENSE ALLOWANCES FOR CERTAIN OFFI-*
2 *CERS OF THE SENATE. (a) IN GENERAL.—Section 119(a)*
3 *of the joint resolution entitled “Joint resolution making*
4 *continuing appropriations for the fiscal year 1982, and for*
5 *other purposes”, approved October 1, 1981 (2 U.S.C. 65c)*
6 *is amended by striking “\$3,000” and inserting “\$6,000”.*

7 *(b) EFFECTIVE DATE.—The amendment made by this*
8 *section shall apply with respect to fiscal year 2004, and*
9 *each fiscal year thereafter.*

10 *SEC. 6. CONSULTANTS. With respect to fiscal year*
11 *2004, the first sentence of section 101(a) of the Supple-*
12 *mental Appropriations Act, 1977 (2 U.S.C. 61h–6(a)) shall*
13 *be applied by substituting “nine individual consultants”*
14 *for “eight individual consultants”.*

20 For salaries and expenses, as authorized by law,
21 \$17,094,000, including: Office of the Speaker,
22 \$2,048,000, including \$25,000 for official expenses of the
23 Speaker; Office of the Majority Floor Leader, \$1,965,000,
24 including \$10,000 for official expenses of the Majority
25 Leader; Office of the Minority Floor Leader, \$2,390,000,
26 including \$10,000 for official expenses of the Minority

1 Leader; Office of the Majority Whip, including the Chief
2 Deputy Majority Whip, \$1,684,000, including \$5,000 for
3 official expenses of the Majority Whip; Office of the Mi-
4 nority Whip, including the Chief Deputy Minority Whip,
5 \$1,259,000, including \$5,000 for official expenses of the
6 Minority Whip; Speaker's Office for Legislative Floor Ac-
7 tivities, \$460,000; Republican Steering Committee,
8 \$862,000; Republican Conference, \$1,448,000; Demo-
9 cratic Steering and Policy Committee, \$1,542,000; Demo-
10 cratic Caucus, \$768,000; nine minority employees,
11 \$1,380,000; training and program development—major-
12 ity, \$290,000; training and program development—minor-
13 ity, \$290,000; Cloakroom Personnel—majority, \$354,000;
14 and Cloakroom Personnel—minority, \$354,000.

15 MEMBERS' REPRESENTATIONAL ALLOWANCES
16 INCLUDING MEMBERS' CLERK HIRE, OFFICIAL
17 EXPENSES OF MEMBERS, AND OFFICIAL MAIL

18 For Members' representational allowances, including
19 Members' clerk hire, official expenses, and official mail,
20 \$514,454,000.

21 COMMITTEE EMPLOYEES

22 STANDING COMMITTEES, SPECIAL AND SELECT

23 For salaries and expenses of standing committees,
24 special and select, authorized by House resolutions,
25 \$106,058,000: *Provided*, That such amount shall remain

1 available for such salaries and expenses until December
2 31, 2004.

3 COMMITTEE ON APPROPRIATIONS

4 For salaries and expenses of the Committee on Ap-
5 propriations, \$24,926,000, including studies and examina-
6 tions of executive agencies and temporary personal serv-
7 ices for such committee, to be expended in accordance with
8 section 202(b) of the Legislative Reorganization Act of
9 1946 and to be available for reimbursement to agencies
10 for services performed: *Provided*, That such amount shall
11 remain available for such salaries and expenses until De-
12 cember 31, 2004.

13 SALARIES, OFFICERS AND EMPLOYEES

14 For compensation and expenses of officers and em-
15 ployees, as authorized by law, \$158,324,000, including:
16 for salaries and expenses of the Office of the Clerk, includ-
17 ing not more than \$13,000, of which not more than
18 \$10,000 is for the Family Room, for official representa-
19 tion and reception expenses, \$18,632,000; for salaries and
20 expenses of the Office of the Sergeant at Arms, including
21 the position of Superintendent of Garages, and including
22 not more than \$3,000 for official representation and re-
23 ception expenses, \$5,471,000; for salaries and expenses of
24 the Office of the Chief Administrative Officer,
25 \$113,141,000, of which \$9,400,000 shall remain available

1 until expended; for salaries and expenses of the Office of
2 the Inspector General, \$3,847,000; for salaries and ex-
3 penses of the Office of Emergency Planning, Preparedness
4 and Operations, \$5,000,000, to remain available until ex-
5 pended; for salaries and expenses of the Office of General
6 Counsel, \$926,000; for the Office of the Chaplain,
7 \$153,000; for salaries and expenses of the Office of the
8 Parliamentarian, including the Parliamentarian and
9 \$2,000 for preparing the Digest of Rules, \$1,560,000; for
10 salaries and expenses of the Office of the Law Revision
11 Counsel of the House, \$2,263,000; for salaries and ex-
12 penses of the Office of the Legislative Counsel of the
13 House, \$6,233,000; for salaries and expenses of the Cor-
14 rections Calendar Office, \$948,000; and for other author-
15 ized employees, \$150,000.

16 **ALLOWANCES AND EXPENSES**

17 For allowances and expenses as authorized by House
18 resolution or law, \$193,608,000, including: supplies, mate-
19 rials, administrative costs and Federal tort claims,
20 \$3,975,000; official mail for committees, leadership of-
21 fices, and administrative offices of the House, \$410,000;
22 Government contributions for health, retirement, Social
23 Security, and other applicable employee benefits,
24 \$188,533,000; and miscellaneous items including pur-
25 chase, exchange, maintenance, repair and operation of

1 House motor vehicles, interparliamentary receptions, and
2 gratuities to heirs of deceased employees of the House,
3 \$690,000.

4 CHILD CARE CENTER

5 For salaries and expenses of the House of Represent-
6 atives Child Care Center, such amounts as are deposited
7 in the account established by section 312(d)(1) of the Leg-
8 islative Branch Appropriations Act, 1992 (2 U.S.C. 2112),
9 subject to the level specified in the budget of the Center,
10 as submitted to the Committee on Appropriations of the
11 House of Representatives.

12 ADMINISTRATIVE PROVISION

13 SEC. 101. (a) REQUIRING AMOUNTS REMAINING IN
14 MEMBERS' REPRESENTATIONAL ALLOWANCES TO BE
15 USED FOR DEFICIT REDUCTION OR TO REDUCE THE
16 FEDERAL DEBT.—Notwithstanding any other provision of
17 law, any amounts appropriated under this Act for
18 “HOUSE OF REPRESENTATIVES—SALARIES AND

24 For all necessary expenses for the mechanical and
25 structural maintenance; care and operation of the Library

4 CAPITOL POLICE BUILDINGS AND GROUNDS

5 For all necessary expenses for the maintenance, care,

8 shall remain available until September 30, 2008.

9 BOTANIC GARDEN

10 For all necessary expenses for the maintenance, care
11 and operation of the Botanic Garden and the nurseries,
12 buildings, grounds, and collections; and purchase and ex-
13 change, maintenance, repair, and operation of a passenger
14 motor vehicle; all under the direction of the Joint Com-
15 mittee on the Library, \$6,062,000, of which \$25,000 shall
16 remain available until September 30, 2008: *Provided*,
17 That this appropriation shall not be available for any ac-
18 tivities of the National Garden.

19 ADMINISTRATIVE PROVISION

20 SEC. 1101. (a) Except as provided in subsection (b),

3 For necessary expenses of the Copyright Office,

7 under section 708(d) of title 17, United States Code: *Pro-*
8 *vided*, That the Copyright Office may not obligate or ex-
9 pend any funds derived from collections under such sec-
10 tion, in excess of the amount authorized for obligation or

18 *tion or designation of any office or position appropriated*
19 *for is different from that specifically established by such*

11 *SEC. 205. AWARDS AND SETTLEMENTS. Such sums as*

15 *tlements as authorized under such subsection.*

16 *SEC. 206. COSTS OF LBFMC. Amounts available for*

19 *Managers Council (LBFMC) established by charter on*

9 these amounts for these specific purposes are designated by

13 paragraph shall be effective immediately upon the enact-
14 ment of this Act.

16 propriations Act, 2004”.
