# A BILL

To establish the National Invasive Species Council, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 **SECTION 1. SHORT TITLE.**
- 4 This Act may be cited as the "National Invasive Spe-
- 5 cies Council Act".
- 6 SEC. 2. STATEMENT OF POLICY REGARDING FEDERAL DU-
- 7 **TIES.**
- 8 (a) In General.—No Federal agency may author-
- 9 ize, fund, or carry out any action that would likely cause
- 10 or promote the introduction or spread of an invasive spe-
- 11 cies in the United States or any other location, unless the

- 1 head of the Federal agency, at his or her sole discretion
- 2 and pursuant to guidelines developed under subsection (b),
- 3 determines that—
- 4 (1) the benefits of the action under consider-
- 5 ation clearly outweigh the potential harm to the en-
- 6 vironment, economy, or human health caused by the
- 7 introduction or spread of the invasive species; and
- 8 (2) all feasible and prudent measures to mini-
- 9 mize risk of harm to the environment, economy, or
- 10 human health will be taken in carrying out the ac-
- 11 tions.
- 12 (b) Guidelines.—The Council for Environmental
- 13 Quality, in conjunction with the Invasive Species Council,
- 14 shall develop guidelines for Federal agencies to analyze ac-
- 15 tions pursuant to this section.

#### 16 SEC. 3. NATIONAL INVASIVE SPECIES COUNCIL.

- 17 (a) Establishment.—There is established as an
- 18 independent entity within the executive branch the Na-
- 19 tional Invasive Species Council. The Council shall provide
- 20 leadership and coordination among Federal agencies, and
- 21 between the Federal Government and State and local gov-
- 22 ernments, with respect to effort to minimize the economic,
- 23 ecological, and human health impacts that invasive species
- 24 cause and reduce the threat of further invasions.
- (b) Membership.—

| 18 | (2) Additional members.—With the concur-              |
| 19 | rence of a majority of the members of the Council,    |
| 20 | the Chair of the Council may appoint additional       |
| 21 | members to the Council from among individuals who     |
| 22 | are officers or employees of the Federal Government   |
| 23 | with significant responsibilities concerning invasive |
| 24 | species.  |

| 1  | (c) Chair.—The Secretary of the Interior shall serve        |

| 2  | as chair of the Council for the three-year period beginning |
| 3  | on the date of the enactment of this Act. Thereafter, the   |
| 4  | chair shall rotate every three years among the following    |
| 5  | members, in the order stated:                               |
| 6  | (1) The Secretary of Agriculture.                           |
| 7  | (2) The Secretary of Commerce.                              |
| 8  | (3) The Secretary of the Interior.                          |
| 9  | (d) Meetings.—The Council shall meet at least               |
| 10 | semiannually, at the call of chair.                         |
| 11 | (e) Executive Director.—                                    |
| 12 | (1) Appointment.—The President shall ap-                    |
| 13 | point the Executive Director of the Council, by and         |
| 14 | with the advice and consent of the Senate.                  |
| 15 | (2) Consultation.—Before appointing an in-                  |
| 16 | dividual under paragraph (1), the President shall           |
| 17 | consult with the Secretary of the Interior, the Sec-        |
| 18 | retary of Agriculture, and the Secretary of Com-            |
| 19 | merce.  |
| 20 | (3) QUALIFICATIONS.—An individual appointed                 |
| 21 | under this subsection must have legal or scientific         |
| 22 | experience and training in the area of natural re-          |
| 23 | sources, ecology, or agriculture, and experience in         |
| 24 | dealing with public policy matters regarding aquatic        |

and terrestrial invasive species.

- 1 (4) TERM.—The Executive Director of the 2 Council shall serve a term of six years, unless re-3 moved earlier by the President.
- 4 (5) COMPENSATION.—The Executive Director 5 shall be paid at the maximum rate of basic pay for 6 GS-15 of the General Schedule.

## 7 SEC. 4. DUTIES.

- 8 (a) IN GENERAL.—The Council shall ensure that 9 Federal agency efforts concerning invasive species are co-
- 10 ordinated, effective, complementary, and cost-efficient.
- (b) Specific Functions.—To carry out subsection(a) the Council shall perform the following functions:
- 13 (1) Coordinate with existing organizations addressing invasive species, such as the Aquatic Nui-14 15 sance Species Task Force, the Federal Interagency 16 Committee for the Management of Noxious and Ex-17 otic Weeds, regional panels established under the 18 Nonindigenous Aquatic Nuisance Prevention and 19 Control Act of 1990 (16 U.S.C. 4701 et seq.), and 20 the White House Office of Science and Technology
  - (2) Develop recommendations for international cooperation between Federal and State Governments and other nations on tools, policies, and methods to

- prevent the introduction and export of invasive species into and from, respectively, the United States.
  - (3) Develop guidelines for Federal agency efforts to ensure that Federal programs concerning invasive species, including outreach programs, are coordinated with State, local, and tribal governments.
  - (4) Develop, in consultation with the Council on Environmental Quality, guidance to Federal agencies pursuant to the National Environmental Policy Act of 1969 (42 U.S.C. 4321 et seq.) on prevention, control, and eradication of invasive species.
  - (5) Establish and maintain a publicly accessible, coordinated, up-to-date information sharing system that—
    - (A) allows the access to and exchange of information among Federal agencies and the public; and
    - (B) utilizes, to the greatest extent practicable, the Internet.
  - (6) Ensure that Federal agencies implement the plans, programs, and policies adopted by the Council in the National Management Plan through appropriate actions, including working in cooperation with Federal agencies on development of budgets pursu-

- 1 (d) AGENCY REPORTS.—Within 18 months after the
- 2 date of the issuance of any edition of the National Man-
- 3 agement Plan that recommends action by a Federal agen-
- 4 cy, the head of such agency shall report to the Congress
- 5 any of such actions that the agency has not taken, with
- 6 an explanation of why the action is not feasible.

## 7 SEC. 6. INVASIVE SPECIES ADVISORY COMMITTEE.

- 8 (a) In General.—The Council shall have an advi-
- 9 sory committee to provide information and advice for con-
- 10 sideration by the Council, which shall be known as the
- 11 Invasive Species Advisory Committee. Except as otherwise
- 12 provided in this section, the advisory committee shall be
- 13 organized, perform the functions, and have the authorities
- 14 specified in the charter for such advisory committee signed
- 15 by the Secretary of the Interior on October 30, 2001.
- 16 (b) APPOINTMENT.—Members of the advisory com-
- 17 mittee shall be appointed by the chair of the Council, after
- 18 consultation with the other members of the Council, from
- 19 among individuals representing stakeholders with respect
- 20 to Federal programs for minimizing the economic, ecologi-
- 21 cal, and human health impacts that invasive species cause.
- (c) Functions.—In addition to the functions speci-
- 23 fied in the charter referred to in subsection (a), the advi-
- 24 sory committee shall recommend to the Council plans and
- 25 actions at local, tribal, State, regional, and ecosystem-

- There is authorized to be appropriated to carry out this Act \$2,000,000 for each of fiscal years 2004 through
- 15 2006.
