A BILL

To amend the Occupational Safety and Health Act of 1970 to provide for the award of attorney’s fees and costs to very small employers when they prevail in litigation prompted by the issuance of citations by the Occupational Safety and Health Administration.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Occupational Safety
 5 and Health Small Employer Access to Justice Act of
 6 2003”.

7 **SEC. 2. AWARD OF ATTORNEYS’ FEES AND COSTS.**

8 The Occupational Safety and Health Act of 1970 (29
 9 U.S.C. 651 and following) is amended by redesignating
 10 section 32 through 34 as 33 through 35 and inserting the
 11 following new section after section 31:

12 **“SEC. 32. AWARD OF ATTORNEYS’ FEES AND COSTS.**

13 “(a) ADMINISTRATIVE PROCEEDINGS.—An employer
 14 who—

15 “(1) is the prevailing party in any adversary
 16 adjudication instituted under this Act, and

17 “(2) had not more than 100 employees and a
 18 net worth of not more than \$1,500,000 at the time
 19 of the adversary adjudication was initiated,

1 shall be awarded fees and other expenses as a prevailing
2 party under section 504 of title 5, United States Code,
3 in accordance with the provisions of that section, but with-
4 out regard to whether the position of the Secretary was
5 substantially justified or special circumstances make an
6 award unjust. For purposes of this section the term ‘ad-
7 versary adjudication’ has the meaning given that term in
8 section 504(b)(1)(C) of title 5, United States Code.

9 “(b) PROCEEDINGS.—An employer who—

10 “(1) is the prevailing party in any proceeding
11 for judicial review of any action instituted under this
12 Act, and

13 “(2) had not more than 100 employees and a
14 net worth of not more than \$1,500,000 at the time
15 the action addressed under subsection (1) was filed,
16 shall be awarded fees and other expenses as a prevailing
17 party under section 2412(d) of title 28, United States
18 Code, in accordance with the provisions of that section,
19 but without regard to whether the position of the United
20 States was substantially justified or special circumstances
21 make an award unjust. Any appeal of a determination of
22 fees pursuant to subsection (a) of this subsection shall be
23 determined without regard to whether the position of the
24 United States was substantially justified or special cir-
25 cumstances make an award unjust.

25 *an award unjust.*
