## A BILL

To protect children from foods that pose a significant choking hazard.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Food Choking Preven-
- 5 tion Act of 2003".
- 6 SEC. 2. OFFICE OF CHOKING HAZARD EVALUATION.
- 7 (a) IN GENERAL.—An Office of Choking Hazard
- 8 Evaluation (referred to in this Act as the "Office") shall
- 9 be established by the Food and Drug Administration. The
- 10 Food and Drug Administration is encouraged to enter into

- 1 interagency agreements with the Consumer Product Safe-
- 2 ty Commission and any other pertinent agencies in estab-
- 3 lishing and operating the Office.
- 4 (b) Informational Labels.—The Office shall have
- 5 the authority to require informational labels on food con-
- 6 sumed by children that pose a demonstrably high choking
- 7 risk to children.
- 8 (c) Recall Authority.—The Office shall have
- 9 mandatory recall authority of food that the Office deter-
- 10 mines pose a significant and unacceptable choking hazard
- 11 to the general public.
- 12 (d) Education.—The Office shall produce edu-
- 13 cational materials on food choking hazards, precautions,
- 14 and life-saving procedures that shall be provided to pedia-
- 15 tricians and hospitals to distribute to patients aged 14 and
- 16 younger. The Office shall designate one week a year as
- 17 "National Child Food Choking Prevention Week" and
- 18 shall widely publicize choking hazards and life-saving pro-
- 19 cedures during that time period. Child safety, as well as
- 20 infant and child CPR classes, shall be made widely avail-
- 21 able throughout the designated week.
- 22 SEC. 3. INTERAGENCY TASK FORCE.
- 23 (a) Choking Hazard Evaluation Task Force.—
- 24 The Food and Drug Administration, in consultation with
- 25 the Consumer Product Safety Commission, shall establish

- 1 the Choking Hazard Evaluation Task Force (referred to
- 2 in this Act as the "Task Force"). The staff of the Task
- 3 Force shall be designated by such agencies.
- 4 (b) Duties.—
- 5 (1) IN GENERAL.—The Task Force shall be re-
- 6 sponsible for establishing criteria for determining
- 7 whether a food poses a significant and unacceptable
- 8 choking hazard.
- 9 (2) Age-specific criteria.—In carrying out
- paragraph (1), the Task Force shall establish age-
- differentiated criteria for choking hazards.
- 12 (3) Public comment.—There shall be a 90-
- day public comment period after the criteria under
- paragraph (1) are announced by the Task Force.
- 15 SEC. 4. DATABASE OF COMPLAINTS.
- 16 The Food and Drug Administration, in consultation
- 17 with other pertinent agencies, shall ensure that there is
- 18 in operation a national database of food choking incidents.
- 19 The Food and Drug Administration shall provide for an
- 20 adequate reporting system throughout its field offices,
- 21 which members of the health care profession and the gen-
- 22 eral public can readily access to report new incidents.
- 23 SEC. 5. REPORTS TO CONGRESS.
- 24 The Food and Drug Administration shall regularly
- 25 submit reports to the Committee on Health, Education,

- 1 Labor, and Pensions of the Senate and the Committee on
- 2 Energy and Commerce of the House of Representatives

3 regarding the implementation of this Act.
