3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Federal Wildland Fire-

5 fighter Emergency Response Compensation Act of 2003".

6 SEC. 2. PORTAL-TO-PORTAL COMPENSATION.

7 (a) WILDLAND FIREFIGHTER DEFINED.—For pur-8 poses of this section, the term "wildland firefighter"

means an employee of the Department of the Interior or 1 2 the United States Forest Service in the Department of 3 Agriculture, the duties of whose position are primarily to 4 perform work directly connected with the control, extin-5 guishment, prevention, and management of wildland fires (including an employee engaged in this activity who is 6 7 transferred to a supervisory or administrative position), 8 but does not include an employee or group of employees 9 excluded by the Office of Personnel Management under 10 the second sentence of subsection (c).

11 (b) PORTAL-TO-PORTAL COMPENSATION.—

(1) IN GENERAL.—For purposes of any determination of pay, a wildland firefighter is entitled to
be paid for the entire period of time during which
such firefighter is engaged in officially ordered or
approved duties in connection with responding to a
wildland fire or other emergency, subject to paragraph (2).

19 (2) LIMITATION.—Notwithstanding any other
20 provision of law, for any 24-hour period, the total
21 amount in basic pay and premium pay payable to a
22 wildland firefighter as a result of the application of
23 this subsection may not exceed the amount equal to
24 the sum of—

1	(A) 16 times the firefighter's hourly rate

5	(c) Regulations.—The Office of Personnel Man-
6	agement shall prescribe any regulations necessary to carry

9	or group of employees appointed on a casual emergency
