A BILL

To preserve the use and access of pack and saddle stock animals on public lands, including wilderness areas, national monuments, and other specifically designated areas, administered by the National Park Service, the Bureau of Land Management, the United States Fish and Wildlife Service, or the Forest Service where there is a historical tradition of such use, and for other purposes.

1 SECTION 1. SHORT TITLE.

- This Act may be cited as the "Right-to-Ride Live-
- 3 stock on Federal Lands Act of 2003".
- 4 SEC. 2. USE AND ACCESS OF PACK AND SADDLE ANIMALS
- 5 ON PUBLIC LANDS.
- 6 (a) National Park System Lands.—Section 12 of
- 7 Public Law 91–383 (16 U.S.C. 1a–7) is amended by add-
- 8 ing at the end the following new subsection:
- 9 "(c) Use and Access of Pack and Saddle Ani-
- 10 Mals.—The Secretary of the Interior shall provide for the
- 11 management of National Park System lands to preserve
- 12 and facilitate the continued use and access of pack and
- 13 saddle stock animals on such lands, including wilderness
- 14 areas, national monuments, and other specifically des-
- 15 ignated areas, where there is a historical tradition of such
- 16 use. As a general rule, all trails, routes, and areas used
- 17 by pack and saddle stock shall remain open and accessible
- 18 for such use. The Secretary may implement a proposed

- 2 Mals.—The Secretary shall provide for the management

- 4 and access of pack and saddle stock animals on such
- 5 lands, including wilderness areas, national monuments,
- 6 and other specifically designated areas, where there is a
- 7 historical tradition of such use. As a general rule, all

- 19 "(5) The Secretary shall provide for the management
- 20 of System lands to preserve and facilitate the continued
- 21 use and access of pack and saddle stock animals on such
- 22 lands, including wilderness areas, national monuments,
- 23 and other specifically designated areas, where there is a
- 24 historical tradition of such use. As a general rule, all
- 25 trails, routes, and areas used by pack and saddle stock

- 1 shall remain open and accessible for such use. The Sec-
- 2 retary may implement a proposed reduction in the use and
- 3 access of pack and saddle stock animals on such lands only
- 4 after complying with the full review process required under

- 7 (d) National Forest System Lands.—Section 15
- 8 of the Forest and Rangeland Renewable Resources Plan-

- 10 (1) by inserting "(a)" before "The Secretary";
- 11 and
- 12 (2) by adding at the end the following new sub-
- 13 section:
- 14 "(b) The Secretary shall provide for the management
- 15 of National Forest System lands to preserve and facilitate
- 16 the continued use and access of pack and saddle stock ani-
- 17 mals on such lands, including wilderness areas, national
- 18 monuments, and other specifically designated areas, where
- 19 there is a historical tradition of such use. As a general
- 20 rule, all trails, routes, and areas used by pack and saddle
- 21 stock shall remain open and accessible for such use. The
- 22 Secretary may implement a proposed reduction in the use
- 23 and access of pack and saddle stock animals on such lands
- 24 only after complying with the full review process required

- 1 under the National Environmental Policy Act of 1969 (42
- 2 U.S.C. 4321 et seq.).".
- 3 (e) Issuance of Rules.—Not later than 120 days
- 4 after the date of the enactment of this Act, the Secretary
- 5 of the Interior and the Secretary of Agriculture shall issue
- 6 final rules to define the meaning of a historical tradition
- 7 of use of pack and saddle stock animals on Federal lands
- 8 for purposes of the amendments made by this section.
