A BILL

To amend the Foreign Intelligence Surveillance Act of 1978 and title 18, United States Code, to strengthen protections of civil liberties in the exercise of the foreign intelligence surveillance authorities under Federal law, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Security and Freedom
3 Ensured (Act of 2003 (SAFE) Act”.

4 **SEC. 2. LIMITATION ON ROVING WIRETAPS UNDER FOR-**
5 **EIGN INTELLIGENCE SURVEILLANCE ACT OF**
6 **1978.**

7 Section 105(c) of the Foreign Intelligence Surveil-
8 lance Act of 1978 (50 U.S.C. 1805(c)) is amended—

9 (1) in paragraph (1)—

10 (A) in subparagraph (A), by inserting be-
11 fore the semicolon the following: “, however, if
12 the identity is unknown, the facilities and
13 places shall be specified”; and

14 (B) in subparagraph (B), by inserting be-
15 fore the semicolon the following: “, however, if
16 any of the facilities or places are unknown, the
17 identity of the target shall be specified”; and

18 (2) in paragraph (2)(A), by inserting before the
19 semicolon the following: “, and, in cases where the
20 facility or place at which the surveillance is to be di-
21 rected is not known at the time the order is issued,
22 that the surveillance be conducted only when the
23 presence of the target at a particular facility or
24 place has been ascertained by the person conducting
25 the surveillance”.

1 **SEC. 3. LIMITATION ON AUTHORITY TO DELAY NOTICE OF**
2 **SEARCH WARRANTS.**

3 Section 3103a of title 18, United States Code, is
4 amended—

5 (1) in subsection (b)—

6 (A) in paragraph (1), by striking “may
7 have an adverse result (as defined in section
8 2705)” and inserting “will endanger the life or
9 physical safety of an individual, result in flight
10 from prosecution, or result in the destruction of
11 or tampering with the evidence sought under
12 the warrant”; and

13 (B) in paragraph (3), by striking “a rea-
14 sonable period” and all that follows and insert-
15 ing “seven calendar days, which period, upon
16 application of the Attorney General, the Deputy
17 Attorney General, or an Associate Attorney
18 General, may thereafter be extended by the
19 court for additional periods of up to seven cal-
20 endar days each if the court finds, for each ap-
21 plication, reasonable cause to believe that notice
22 of the execution of the warrant will endanger
23 the life or physical safety of an individual, re-
24 sult in flight from prosecution, or result in the
25 destruction of or tampering with the evidence
26 sought under the warrant.”; and

1 (2) by adding at the end the following new sub-
2 section:

3 “(c) REPORTS.—(1) On a semiannual basis, the At-
4 torney General shall transmit to Congress and make pub-
5 lic a report concerning all requests for delays of notice,
6 and for extensions of delays of notice, with respect to war-
7 rants under subsection (b).

8 “(2) Each report under paragraph (1) shall include,
9 with respect to the preceding six-month period—

10 “(A) the total number of requests for delays of
11 notice with respect to warrants under subsection (b);

12 “(B) the total number of such requests granted
13 or denied; and

14 “(C) for each request for delayed notice that
15 was granted, the total number of applications for ex-
16 tensions of the delay of notice and the total number
17 of such extensions granted or denied.”.

18 **SEC. 4. PRIVACY PROTECTIONS FOR LIBRARY, BOOK-**
19 **SELLER, AND OTHER PERSONAL RECORDS**
20 **UNDER FOREIGN INTELLIGENCE SURVEIL-**
21 **LANCE ACT OF 1978.**

22 (a) APPLICATIONS FOR ORDERS.—Subsection (b) of
23 section 501 of the Foreign Intelligence Surveillance Act
24 of 1978 (50 U.S.C. 1861) is amended—

1 (1) in paragraph (1), by striking “and” at the
2 end;

3 (2) in paragraph (2), by striking the period at
4 the end and inserting “; and”; and

5 (3) by adding at the end the following new
6 paragraph:

7 “(3) shall specify that there are specific and
8 articulable facts giving reason to believe that the
9 person to whom the records pertain is a foreign
10 power or an agent of a foreign power.”.

11 (b) ORDERS.—Subsection (c)(1) of that section is
12 amended by striking “finds” and all that follows and in-
13 serting “finds that—

14 “(A) there are specific and articulable facts giv-
15 ing reason to believe that the person to whom the
16 records pertain is a foreign power or an agent of a
17 foreign power; and

18 “(B) the application meets the other require-
19 ments of this section.”.

20 (c) OVERSIGHT OF REQUESTS FOR PRODUCTION OF
21 RECORDS.—Section 502 of that Act (50 U.S.C. 1862) is
22 amended—

23 (1) in subsection (a), by striking “the Perma-
24 nent” and all that follows through “the Senate” and
25 inserting “the Permanent Select Committee on Intel-

1 ligence and the Committee on the Judiciary of the
2 House of Representatives and the Select Committee
3 on Intelligence and the Committee on the Judiciary
4 of the Senate”; and

5 (2) in subsection (b), by striking “On a semi-
6 annual basis,” and all that follows through “a report
7 setting forth” and inserting “The report of the At-
8 torney General to the Committees on the Judiciary
9 of the House of Representatives and the Senate
10 under subsection (a) shall set forth”.

11 **SEC. 5. PRIVACY PROTECTIONS FOR COMPUTER USERS AT**
12 **LIBRARIES UNDER NATIONAL SECURITY AU-**
13 **THORITY.**

14 Section 2709 of title 18, United States Code, is
15 amended—

16 (1) in subsection (a)—

17 (A) by inserting “(1)” before “A wire or
18 electronic communication service provider”; and

19 (B) by adding at the end the following new
20 paragraph:

21 “(2) A library shall not be treated as a wire or
22 electronic communication service provider for pur-
23 poses of this section.”; and

24 (2) by adding at the end the following new sub-
25 section:

2 Section 224(a) of the USA PATRIOT ACT of 2001
3 (Public Law 107–56; 115 Stat. 295) is amended by strik-
4 ing “213, 216, 219,” and inserting “and section 505”
5 after “by those sections”).
