## A BILL

To extend nondiscriminatory treatment (normal trade relations treatment) to the products of Laos.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. EXTENSION OF NORMAL TRADE RELATIONS TO**

4 **LAOS.**

5 (a) FINDINGS.—Congress finds that—

6 (1) the Lao People's Democratic Republic is  
7 pursuing a broad policy of adopting market-based  
8 reforms to enhance its economic competitiveness and  
9 achieve an attractive climate for investment;

1           (2) extension of normal trade relations treat-  
2           ment would assist the Lao People’s Democratic Re-  
3           public in developing its economy based on free mar-  
4           ket principles and becoming competitive in the global  
5           marketplace;

6           (3) establishing normal commercial relations on  
7           a reciprocal basis with the Lao People’s Democratic  
8           Republic will promote United States exports to the  
9           rapidly growing southeast Asian region and expand  
10          opportunities for United States business and invest-  
11          ment in the Lao People’s Democratic Republic econ-  
12          omy;

13          (4) United States and Laotian commercial in-  
14          terests would benefit from the bilateral trade agree-  
15          ment between the United States and the Lao Peo-  
16          ple’s Democratic Republic, signed in 2003, providing  
17          for market access and the protection of intellectual  
18          property rights;

19          (5) the Lao People’s Democratic Republic has  
20          taken cooperative steps with the United States in  
21          the global war on terrorism, combating the traf-  
22          ficking of narcotics, and the accounting for Amer-  
23          ican servicemen and civilians still missing from the  
24          Vietnam war; and

1           (6) expanding bilateral trade relations that in-  
2           clude a commercial agreement may promote further  
3           progress by the Lao People’s Democratic Republic  
4           on human rights, religious tolerance, democratic  
5           rule, and transparency, and assist that country in  
6           adopting regional and world trading rules and prin-  
7           ciples.

8           (b) EXTENSION OF NONDISCRIMINATORY TREAT-  
9           MENT TO THE PRODUCTS OF THE LAO PEOPLE’S DEMO-  
10          CRATIC REPUBLIC.—

11           (1) HARMONIZED TARIFF SCHEDULE AMEND-  
12          MENT.—General note 3(b) of the Harmonized Tariff  
13          Schedule of the United States is amended by strik-  
14          ing “Laos”.

15           (2) EFFECTIVE DATE.—The amendment made  
16          by paragraph (1) applies with respect to goods en-  
17          tered, or withdrawn from warehouse for consump-  
18          tion, on or after the effective date of a notice pub-  
19          lished in the Federal Register by the United States  
20          Trade Representative that a trade agreement obli-  
21          gating reciprocal most-favored-nation treatment be-  
22          tween the Lao People’s Democratic Republic and the  
23          United States has entered into force.
