## A BILL

To provide for the development of a national plan for the control and management of Sudden Oak Death, a tree disease caused by the fungus-like pathogen Phytophthora ramorum, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. NATIONAL PLAN FOR CONTROL AND MANAGE-
- 4 MENT OF SUDDEN OAK DEATH.
- 5 (a) DEVELOPMENT OF NATIONAL PLAN.—Subject to
- 6 the availability of appropriated funds for this purpose, the

- 1 Secretary of Agriculture, acting through the Animal Plant
- 2 and Health Inspection Service, shall develop a national
- 3 plan for the control and management of Sudden Oak
- 4 Death, a forest disease caused by the fungus-like pathogen
- 5 Phytophthora ramorum.
- 6 (b) PLAN ELEMENTS.—In developing the plan, the
- 7 Secretary shall specifically address the following:
- 8 (1) Information derived by the Department of
- 9 Agriculture from ongoing efforts to identify hosts of
- 10 Phytophthora ramorum and survey the extent to
- 11 which Sudden Oak Death exists in the United
- 12 States.
- 13 (2) Past and current efforts to understand the
- risk posed by Phytophthora ramorum and the re-
- sults of control and management efforts regarding
- 16 Sudden Oak Death, including efforts related to re-
- search, control, quarantine, and hazardous fuel re-
- duction.
- 19 (3) Such future efforts as the Secretary con-
- siders necessary to control and manage Sudden Oak
- Death, including cost estimates for the implementa-
- tion of such efforts.
- (c) Consultation.—The Secretary shall develop the
- 24 plan in consultation with other Federal agencies that have

- 1 appropriate expertise regarding the control and manage-
- 2 ment of Sudden Oak Death.
- 3 (d) Implementation of Plan.—The Secretary
- 4 shall complete the plan and commence implementation as
- 5 soon as practicable after the date on which funds are first
- 6 appropriated pursuant to the authorization of appropria-
- 7 tions in subsection (e) to carry out this section.
- 8 (e) AUTHORIZATION OF APPROPRIATIONS.—There is
- 9 authorized to be appropriated to the Secretary such sums
- 10 as may be necessary to carry out this section.
