## AN ACT

For the relief of Tanya Andrea Goudeau.

1       *Be it enacted by the Senate and House of Representa-*  
2   *tives of the United States of America in Congress assembled,*

1 **SECTION 1. IMMEDIATE RELATIVE STATUS FOR TANYA AN-**  
2 **DREA GOUDEAU.**

3 (a) IN GENERAL.—Tanya Andrea Goudeau shall be  
4 classified as a child under section 101(b)(1)(E) of the Im-  
5 migration and Nationality Act for purposes of approval  
6 of a relative visa petition filed under section 204 of such  
7 Act by her adoptive parent and the filing of an application  
8 for an immigrant visa or adjustment of status.

9 (b) ADJUSTMENT OF STATUS.—If Tanya Andrea  
10 Goudeau enters the United States before the filing dead-  
11 line specified in subsection (c), she shall be considered to  
12 have entered and remained lawfully and shall, if otherwise  
13 eligible, be eligible for adjustment of status under section  
14 245 of the Immigration and Nationality Act as of the date  
15 of the enactment of this Act.

16 (c) DEADLINE FOR APPLICATION AND PAYMENT OF  
17 FEES.—Subsections (a) and (b) shall apply only if the pe-  
18 tition and the application for issuance of an immigrant  
19 visa or the application for adjustment of status are filed  
20 with appropriate fees within 2 years after the date of the  
21 enactment of this Act.

22 (d) REDUCTION OF IMMIGRANT VISA NUMBER.—  
23 Upon the granting of an immigrant visa or permanent res-  
24 idence to Tanya Andrea Goudeau, the Secretary of State  
25 shall instruct the proper officer to reduce by 1, for the  
26 current or next following fiscal year, the worldwide level

1 of family-sponsored immigrants under section  
2 201(c)(1)(A) of the Immigration and Nationality Act.

3 (e) DENIAL OF PREFERENTIAL IMMIGRATION  
4 TREATMENT FOR CERTAIN RELATIVES.—The natural  
5 parents, brothers, and sisters of Tanya Andrea Goudeau  
6 shall not, by virtue of such relationship, be accorded any  
7 right, privilege, or status under the Immigration and Na-  
8 tionality Act.

9 **SEC. 2. ELIGIBILITY FOR CITIZENSHIP.**

10 For purposes of section 320 of the Immigration and  
11 Nationality Act, Tanya Andrea Goudeau shall be consid-  
12 ered to have satisfied the requirements applicable to  
13 adopted children under section 101(b)(1) of such Act.
