AN ACT

To authorize the Secretary of the Interior to acquire the McLoughlin House National Historic Site in Oregon City, Oregon, and to administer the site as a unit of the National Park System, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-
2 tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE; DEFINITIONS.**

4 (a) **SHORT TITLE.**—This Act may be cited as the
5 “McLoughlin House National Historic Site Act”.

1 (b) DEFINITIONS.—For the purposes of this Act, the
2 following definitions apply:

3 (1) ASSOCIATION.—The term “Association”
4 means the McLoughlin Memorial Association, an or-
5 ganization described in section 501(c)(3) of the In-
6 ternal Revenue Code of 1986 and exempt from tax-
7 ation under section 501(a) of such Code.

8 (2) CITY.—The term “City” means Oregon
9 City, Oregon.

10 (3) HISTORIC SITE.—The term “Historic Site”
11 means the McLoughlin House National Historic Site
12 which is described in the Acting Assistant Secretary
13 of the Interior’s Order of June 27, 1941, and gen-
14 erally depicted on the map entitled “McLoughlin
15 House National Historic Site”, numbered 007/
16 80,000, and dated 12/01/01, and includes the
17 McLoughlin House, the Barelay House, and other
18 associated real property, improvements, and personal
19 property.

20 (4) SECRETARY.—The term “Secretary” means
21 the Secretary of the Interior.

22 **SEC. 2. FINDINGS.**

23 Congress finds the following:

24 (1) On June 27, 1941, Acting Assistant See-
25 retary of the Interior W.C. Mendenhall, by means of

1 the authority granted the Secretary under section 2
2 of the Historic Sites Act of August 21, 1935, estab-
3 lished the McLoughlin Home National Historic Site,
4 located in the City.

5 (2) Since January 16, 1945, the site has been
6 known as McLoughlin House National Historic Site.

7 (3) The Historic Site includes the McLoughlin
8 House and Barelay House, which are owned and
9 managed by the Association.

10 (4) The Historic Site is located in a Charter
11 Park on Oregon City Block 40, which is owned by
12 the City.

13 (5) A cooperative agreement was made in 1941
14 among the Association, the City, and the United
15 States, providing for the preservation and use of the
16 McLoughlin House as a national historic site.

17 (6) The Association has had an exemplary and
18 longstanding role in the stewardship of the Historic
19 Site but is unable to continue that role.

20 (7) The Historic Site has been an affiliated
21 area of the National Park System and is worthy of
22 recognition as part of the National Park System.

23 **SEC. 3. MCLOUGHLIN HOUSE NATIONAL HISTORIC SITE.**

24 (a) ACQUISITION.—The Secretary is authorized to ac-
25 quire the Historic Site, from willing sellers only, by dona-

1 tion, purchase with donated or appropriated funds, or ex-
2 change, except that lands or interests in lands owned by
3 the City may be acquired by donation only.

4 (b) **BOUNDARIES; ADMINISTRATION.**—Upon acquisi-
5 tion of the Historic Site, the acquired property shall be
6 included within the boundaries of, and be administered as
7 part of, the Fort Vancouver National Historic Site in ac-
8 cordance with all applicable laws and regulations of the
9 National Park System.

10 **SECTION 1. SHORT TITLE; DEFINITIONS.**

11 (a) **SHORT TITLE.**—*This Act may be cited as the*
12 *“McLoughlin House Addition to Fort Vancouver National*
13 *Historic Site Act”.*

14 (b) **DEFINITIONS.**—*For the purposes of this Act, the*
15 *following definitions apply:*

16 (1) **CITY.**—*The term “City” means Oregon City,*
17 *Oregon.*

18 (2) **MCLOUGHLIN HOUSE.**—*The term “McLough-*
19 *lin House” means the McLoughlin House National*
20 *Historic Site which is described in the Acting Assist-*
21 *ant Secretary of the Interior’s Order of June 27,*
22 *1941, and generally depicted on the map entitled*
23 *“McLoughlin House, Fort Vancouver National His-*
24 *toric Site”, numbered 389/92,002, and dated 5/01/03,*
25 *and includes the McLoughlin House, the Barclay*

1 *House, and other associated real property, improvements, and personal property.*

3 (3) *SECRETARY.*—The term “Secretary” means
4 *the Secretary of the Interior.*

5 **SEC. 2. MCLOUGHLIN HOUSE ADDITION TO FORT VAN-**
6 **COUVER.**

7 (a) *ACQUISITION.*—The Secretary is authorized to ac-
8 *quire the McLoughlin House, from willing sellers only, by*
9 *donation, purchase with donated or appropriated funds, or*
10 *exchange, except that lands or interests in lands owned by*
11 *the City may be acquired by donation only.*

12 (b) *MAP AVAILABILITY.*—The map identifying the
13 *McLoughlin House referred to in section 1(b)(2) shall be*
14 *on file and available for inspection in the appropriate of-*
15 *fices of the National Park Service, Department of the Inter-*
16 *prior.*

17 (c) *BOUNDARIES; ADMINISTRATION.*—Upon acquisi-
18 *tion of the McLoughlin House, the acquired property shall*
19 *be included within the boundaries of, and be administered*
20 *as part of, the Fort Vancouver National Historic Site in*
21 *accordance with all applicable laws and regulations.*

22 (d) *NAME CHANGE.*—Upon acquisition of the
23 *McLoughlin House, the Secretary shall change the name of*
24 *the site from the “McLoughlin House National Historic*
25 *Site” to the “McLoughlin House”.*

1 (e) *FEDERAL LAWS.*—*After the McLoughlin House is*
2 *acquired and added to Fort Vancouver National Historic*
3 *Site, any reference in a law, map, regulation, document,*
4 *paper, or other record of the United States to the “McLough-*
5 *lin House National Historic Site” (other than this Act)*
6 *shall be deemed a reference to the “McLoughlin House”, a*
7 *unit of Fort Vancouver National Historic Site.*

Amend the title so as to read, “A bill to authorize the Secretary of the Interior to acquire the McLoughlin House in Oregon City, Oregon, for inclusion in Fort Vancouver National Historic Site, and for other purposes.”.
