A BILL

To provide for the withholding of United States contributions to any United Nations commission, organization, or affiliated agency that is chaired or presided over by a country that has repeatedly provided support for acts of international terrorism, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. WITHHOLDING OF UNITED STATES CONTRIBU-**
2 **TIONS FOR CERTAIN UNITED NATIONS COM-**
3 **MISSIONS, ORGANIZATIONS, OR ANY AFFILI-**
4 **ATED AGENCIES.**

5 Notwithstanding any other provision of law, funds
6 available to the Department of State or any other Federal
7 department or agency may not be used for the following:

8 (1) United States contributions to any United
9 Nations commission, organization, or affiliated agen-
10 cy that is chaired or presided over by a country, the
11 government of which the Secretary of State has de-
12 termined, for purposes of section 6(j)(1) of the Ex-
13 port Administration Act of 1979 (50 U.S.C. App.
14 2405(j)(1)) has repeatedly provided support for acts
15 of international terrorism, until such time as the
16 President determines that such commission, organi-
17 zation, or agency is no longer chaired or presided
18 over by such country and the commission, organiza-
19 tion, or agency has established appropriate electoral
20 reforms, including minimum standards for leader-
21 ship positions and the elimination of automatic rota-
22 tion of such leadership positions.

23 (2) Expenses for any United States delegation
24 to any United Nations commission, organization, or
25 affiliated agency described in paragraph (1) until

- 1 such time as the President makes the determination
- 2 described in such paragraph.
