A BILL

 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,
 - 3 **SECTION 1. SHORT TITLE.**
 - 4 This Act may be cited as the "State Budget Relief
 - 5 Act of 2003".
 - 6 SEC. 2. TEMPORARY INCREASES OF MEDICAID FMAP.
 - 7 (a) Permitting Maintenance of Fiscal Year
 - 8 2002 FMAP.—Notwithstanding any other provision of
 - 9 law, but subject to subsection (d), if the FMAP deter-
- 10 mined without regard to this section for a State for a cov-
- 11 ered calendar quarter (as defined in subsection (g)(1)) is
- 12 less than the FMAP as so determined for fiscal year 2002,
- 13 the FMAP for the State for fiscal year 2002 shall be sub-
- 14 stituted for the State's FMAP for each of such covered
- 15 calendar quarters, before the application of this section.
- 16 (b) General 2 Percentage Point Increase.—
- 17 Notwithstanding any other provision of law, but subject
- 18 to subsections (d) and (e), for each State for each covered
- 19 calendar quarter, the FMAP (taking into account the ap-

- 1 plication of subsection (a)) shall be increased by 2 percent-

- 3 (c) Further Increase for States With High
- 4 Unemployment Rates.—
- 5 (1) In General.—Notwithstanding any other 6 provision of law, but subject to subsections (d) and 7 (e), if a State is a high unemployment State for any 8 covered calendar quarter, then the FMAP for that 9 State for that calendar quarter and for any subse-10 quent calendar quarter in such fiscal year regardless 11 of whether the State continues to be high unemploy-12 ment State for that subsequent calendar quarter 13 shall be increased (after the application of sub-14 sections (a) and (b)) by 2.5 percentage points.
 - (2) High unemployment state.—For purposes of this subsection, a State is a high unemployment State for a calendar quarter if, for any 3 consecutive month period beginning on or after June 2002 and ending with the second month before the beginning of the calendar quarter, the State has an average seasonally adjusted unemployment rate that exceeds the average weighted unemployment rate during such period. Such unemployment rates for such months shall be determined based on publica-

1	tions of the Bureau of Labor Statistics of the De-
2	partment of Labor.
3	(3) Average weighted unemployment rate
4	DEFINED.—For purposes of paragraph (2), the "av-
5	erage weighted unemployment rate" for a period
6	is—
7	(A) the sum of the seasonally adjusted
8	number of unemployed civilians in each State
9	and the District of Columbia for the period, di-
10	vided by
11	(B) the sum of the civilian labor force in
12	each State and the District of Columbia for the
13	period.
14	(d) Scope of Application.—The increases in the
15	FMAP for a State under this section shall apply only for
16	purposes of title XIX of the Social Security Act and shall
17	not apply with respect to—
18	(1) disproportionate share hospital payments
19	described in section 1923 of such Act; and
20	(2) payments under titles IV and XXI of such
21	Act.
22	(e) State Eligibility.—A State is eligible for an
23	increase in its FMAP under subsection (b) or (c) or an $$
24	increase in a cap amount under subsection (f) only if the
25	eligibility under its State plan under title XIX of the So-

- 1 cial Security Act (including any waiver under such title
- 2 or under section 1115 of such Act) is no more restrictive
- 3 than the eligibility under such plan (or waiver) as in effect
- 4 on September 30, 2003.
- 5 (f) One-Year Increase in Cap on Medicaid Pay-
- 6 MENTS TO TERRITORIES.—Notwithstanding any other
- 7 provision of law, but subject to section (e), with respect
- 8 to a covered calendar quarter, the amounts otherwise de-
- 9 termined for Puerto Rico, the Virgin Islands, Guam, the
- 10 Northern Mariana Islands, and American Samoa under
- 11 subsections (f) and (g)(2) of section 1108 of the Social
- 12 Security Act (42 U.S.C 1308) shall each be increased by
- 13 9 percent of such amounts.
- 14 (g) Definitions.—For purposes of this section:
- 15 (1) COVERED CALENDAR QUARTER.—The term
- 16 "covered calendar quarter" means the last two cal-
- endar quarters of fiscal year 2003 and the first two
- calendar quarters of fiscal year 2004.
- 19 (2) FMAP.—The term "FMAP" means the
- Federal medical assistance percentage, as defined in
- section 1905(b) of the Social Security Act (42)
- 22 U.S.C. 1396d(b)).

1 (3) STATE.—The term "State" has the mean-2 ing given such term for purposes of title XIX of the 3 Social Security Act.
