A BILL

12	"Sec. 316. (a) Surplus or Deficit Totals.—Any

17	deficit totals of the congressional budget, and any descrip-
18	tion of, or reference to, such totals in any official publica-

21	survivors, and disability insurance program under title 2
22	of the Social Security Act and of the Federal Hospital In-
23	surance Trust Fund under part A of title 18 of such Act.

"Sec. 316. Removing Social Security and Medicare from budget surplus/deficit pronouncements.".
