# A BILL

To amend the General Education Provisions Act to prohibit Federal education funding for elementary or secondary schools that provide access to emergency postcoital contraception.

- 1 Be it enacted by the Senate and House of Representa-

#### 1 SECTION 1. SHORT TITLE.

- 2 This Act may be cited as the "Schoolchildren's
- 3 Health Protection Act".
- 4 SEC. 2. SCHOOLCHILDREN'S HEALTH PROTECTION.
- 5 The General Education Provisions Act (20 U.S.C.
- 6 1221 et seq.) is amended by adding at the end the fol-
- 7 lowing new part:

### 9 **PROTECTION**

- 10 "SEC. 461. LIMITATION ON FUNDING.
- "Notwithstanding any other provision of Federal law,
- 12 no funds shall be made available from any applicable pro-
- 13 gram to a State educational agency or local educational
- 14 agency that distributes or provides to an unemancipated
- 15 minor, on the premises or in the facilities of an elementary
- 16 school or secondary school, postcoital emergency contra-
- 17 ception (such as the so-called 'morning-after pill') or a
- 18 prescription for such contraception.
- 19 **"SEC. 462. DEFINITIONS.**
- 20 "In this part:
- 21 "(1) The term 'postcoital emergency contracep-
- 22 tion' means any of the regimens described in the no-
- 23 tice entitled 'Prescription Drug Products; Certain
- 24 Combined Oral Contraceptives for Use as Postcoital
- 25 Emergency Contraception', published in the Federal

2	any subsequent corresponding notice.
3	"(2) The term 'unemancipated minor' means an
4	unmarried individual under 18 years old who is—
5	"(A) a dependent (as defined in section
6	152(a) of the Internal Revenue Code of 1986);
7	and
8	"(B) not emancipated under an applicable
9	State law.".
