5	HEALTH-CARE PROFESSIONALS.
6	(a) Effective Date.—The effective date of the
7	amendment made by section 132 of the Department of
8	Veterans Affairs Health Care Programs Enhancement Act
9	of 2001 (Public Law 107–135; 115 Stat. 2454) shall be
10	January 23, 2002, in the case of health care professionals
11	referred to in subsection (c) of section 7426 of title 38,
12	United States Code (as so amended), who retire on or
13	after that date and in the case of health care professionals
14	referred to in such subsection (c) who retired before such
15	date, but after April 7, 1986.
16	(b) RECOMPUTATION OF ANNUITY.—The Office of
17	Personnel Management shall recompute the annuity of
18	each health-care professional described in the first sen-
19	tence of subsection (c) of section 7426 of title 38, United
20	States Code (as so amended), who retired before January
21	23, 2002, but after April 7, 1986, in order to take into
22	account the amendment made by section 132 of the De-
23	partment of Veterans Affairs Health Care Programs En-
24	hancement Act of 2001. Such recomputation shall be ef-

- 1 fective with respect to annuities paid for months after
- 2 January 23, 2002.
