Ms. PRYCE, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 4444) to amend the Workforce Investment Act of 1998 to establish a Personal Reemployment Accounts grant program to assist Americans in returning to work.

1 *Resolved*, That upon the adoption of this resolution
2 it shall be in order to consider in the House the bill (H.R.
3 4444) to amend the Workforce Investment Act of 1998
4 to establish a Personal Reemployment Accounts grant pro-
5 gram to assist Americans in returning to work. The bill
6 shall be considered as read for amendment. In lieu of the

1 amendment in the nature of a substitute recommended by
2 the Committee on Education and Workforce now printed
3 in the bill, an amendment in the nature of a substitute
4 consisting of the text of H.R. 4444 shall be considered
5 as adopted. The previous question shall be considered as
6 ordered on the bill, as amended, to final passage without
7 intervening motion except: (1) one hour of debate on the
8 bill, as amended, equally divided and controlled by the
9 chairman and ranking minority member of the Committee
10 on Education and the Workforce; and (2) one motion to
11 recommit with or without instructions.

12 SEC. 2. (a) In the engrossment of H.R. 4444, the
13 Clerk shall—

14 (1) await the disposition of H.R. 4409 and
15 H.R. 4410;

16 (2) add the respective texts of such bills speci-
17 fied in subparagraph (1) as have passed the House,
18 as new matter at the end of H.R. 4444;

19 (3) conform the title of H.R. 4444 to reflect the
20 addition to the engrossment of the text of such bills
21 specified in subparagraph (1) as have passed the
22 House;

23 (4) assign appropriate designations to provi-
24 sions within the engrossment; and

1 (5) conform provisions for short titles within
2 the engrossment.

3 (b) Upon the addition to the engrossment of H.R.
4 4444 of the text of each bill specified in subsection (a)(1)
5 that has passed the House, each such bill shall be laid
6 on the table.

7 (c) If H.R. 4444 is disposed of without reaching the
8 stage of engrossment as contemplated in subsection (a),
9 the bill specified in subsection (a)(1) that first passes the
10 House shall be treated in the manner specified for H.R.
11 4444 in subsections (a) and (b), and only the other bill
12 specified in subsection (a)(1) that has passed the House
13 shall be laid on the table.
