Mr. LINDER, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 4850) making appropriations for the government of the District of Columbia and other activities chargeable in whole or in part against the revenues of said District for the fiscal year ending September 30, 2005, and for other purposes.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 2(b) of
3 rule XVIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 4850) making appropriations for

1 the government of the District of Columbia and other ac-
2 tivities chargeable in whole or in part against the revenues
3 of said District for the fiscal year ending September 30,
4 2005, and for other purposes. The first reading of the bill
5 shall be dispensed with. All points of order against consid-
6 eration of the bill are waived. General debate shall be con-
7 fined to the bill and shall not exceed one hour equally di-
8 vided and controlled by the chairman and ranking minor-
9 ity member of the Committee on Appropriations. After
10 general debate the bill shall be considered for amendment
11 under the five-minute rule. Points of order against provi-
12 sions in the bill for failure to comply with clause 2 of rule
13 XXI are waived except: sections 116, 126, 130, and 131.
14 During consideration of the bill for amendment, the Chair-
15 man of the Committee of the Whole may accord priority
16 in recognition on the basis of whether the Member offering
17 an amendment has caused it to be printed in the portion
18 of the Congressional Record designated for that purpose
19 in clause 8 of rule XVIII. Amendments so printed shall
20 be considered as read. At the conclusion of consideration
21 of the bill for amendment the Committee shall rise and
22 report the bill to the House with such amendments as may
23 have been adopted. The previous question shall be consid-
24 ered as ordered on the bill and amendments thereto to

- 1 final passage without intervening motion except one mo-
- 2 tion to recommit with or without instructions.
