## RESOLUTION

Providing for consideration of the bill (H.R. 4423) making appropriations for the Department of Veterans Affairs for the fiscal year ending September 30, 2004, and for other purposes.

1 *Resolved*, That immediately upon the adoption of this 2 resolution the Speaker shall, pursuant to clause 2(b) of 3 rule XVIII, declare the House resolved into the Committee 4 of the Whole House on the state of the Union for consider-5 ation of the bill (H.R. 4423) making appropriations for 6 the Department of Veterans Affairs for the fiscal year 7 ending September 30, 2005, and for other purposes. The first reading of the bill shall be dispensed with. All points 8

1 of order against the bill and against its consideration are 2 waived. General debate shall be confined to the bill and 3 shall not exceed 90 minutes with one hour equally divided 4 and controlled by the chairman and ranking minority 5 member of the Committee on Appropriations and 30 minutes equally divided and controlled by the chairman and 6 7 ranking minority member of the Committee on Ways and 8 Means. After general debate the bill shall be considered 9 for amendment under the five-minute rule. During consid-10 eration of the bill for amendment, the Chairman of the Committee of the Whole may accord priority in recognition 11 12 on the basis of whether the Member offering an amend-13 ment has caused it to be printed in the portion of the Con-14 gressional Record designated for that purpose in clause 15 8 of rule XVIII. Amendments so printed shall be considered as read. At the conclusion of consideration of the bill 16 17 for amendment, the Committee shall rise and report the 18 bill to the House with such amendments as may have been 19 adopted. The previous question shall be considered as or-20dered on the bill and amendments thereto to final passage 21 without intervening motion except one motion to recommit 22 with or without instructions.

SEC. 2. If the Committee of the Whole rises and reports that it has come to no resolution on the bill, then
on the next legislative day the House shall, immediately
